San Francisco communication of March 16, 1967 set forth leads for the New Orleans Office to locate and interview [REDACTED] and [REDACTED] who were reportedly acquainted with FRANK LEE MORRIS, and who might have some information as to his whereabouts, based on information received from [REDACTED]

San Francisco airtel to New Orleans dated April 10, 1967, requested that this investigation be expedited and that every facit be completely explored to insure that MORRIS had not been successful in reaching the mainland from Alcatraz Island. The New Orleans Office was reminded that leads in this case were to receive preferred attention.

New Orleans communication to San Francisco dated April 28, 1967, advised that extensive efforts had been made attempting to locate [REDACTED] a well known hoodlum in the New Orleans area.

[REDACTED] was interviewed on February 23, 1967 by SAs [REDACTED] and [REDACTED]. He advised that he left New Orleans in July 1966 to come to Miami, Florida. He stated that a few days prior to his leaving New Orleans he ran into a friend, [REDACTED]. [REDACTED] told [REDACTED] that he had seen FRANK MORRIS in New Orleans and knew that he had escaped Alcatraz. [REDACTED] further advised that he knew MORRIS very well and that he even visited MORRIS while MORRIS was an inmate at the Atlanta Penitentiary prior to his being transferred to Alcatraz.

[REDACTED] further advised that MORRIS had told [REDACTED] that the two brothers who had attempted to escape Alcatraz with MORRIS drowned in their attempt. [REDACTED] said that he has no idea where [REDACTED] could be located but said that [REDACTED] had served time in the Angola State Prison in Louisiana and was in this penitentiary at the same time that FRANK MORRIS served there. He further added that [REDACTED] b7C b7D

[REDACTED] He described [REDACTED] as [REDACTED] and stated that [REDACTED] if he knows the whereabouts of FRANK MORRIS, would not divulge this information to anyone.

[REDACTED] said that there are two other individuals who if located might be able to furnish information concerning [REDACTED] or FRANK MORRIS. They are [REDACTED] b7C b7D

On March 31, 1967, [redacted] was contacted and he stated that he has given considerable thought to the previous interview with the Miami Agents. He advised that he cannot furnish any other additional information that would be of assistance in locating the Subjects. He concluded by saying he would call the Miami Division if any information came to his attention regarding the whereabouts of Subjects.

Washington Field Office communication to San Francisco received on April 15, 1967, reflected the following inquiries:

The following investigation was conducted by SA [redacted] at Washington, D.C.:

The intersection of Georgia Avenue and Kennedy Street, N.W., is a major transfer point for D.C. Transit Company busses, both north and south bound; east and west bound. It is totally commercial at the intersection. Spot checks were maintained on February 18, 20, 24, and 28; March 3, 15, and 28, 1967, but no one resembling the Subject was observed. The only establishment open at 7:15 am is the Kennedy Corner Delicatessen, Georgia Avenue and Kennedy Street, N.W. The slick photograph of MORRIS was shown to [redacted]

He said he could not identify it as anyone he has seen, but that it looked vaguely familiar.

[redacted] and would be alert for the appearance of anyone looking like MORRIS at either place. He said his delicatessen caters to early morning bus travellers who stop for coffee.

[redacted] and [redacted] Kane's Tavern, Georgia and Kennedy, N.W., looked at MORRIS' photo but could not identify it. [redacted] said it looked familiar. He further said he does not open his place until 10:30 am.

April 28, 1967. [REDACTED] advised that approximately one year ago he visited [REDACTED] in Ruskin, Alabama. He said they discussed whether the ANGLIN brothers had been successful in reaching the mainland following their escape, and if they might possibly be alive. He said this was a continual topic of conversation among the family inasmuch as they have been repeatedly contacted by the FBI at regular intervals. [REDACTED] stated, however, that the family has resolved that the ANGLINs must be dead because they feel sure that otherwise they would have made contact with some member of the family by this time.

[REDACTED] stated that he would notify the FBI should any information come to his attention indicating that the Subjects were alive.

[redacted] was advised he was being interviewed relative to a Federal Fugitive Investigation, the type of which, should he furnish false information, would involve him in a possible harboring violation. [redacted] stated as he is currently still on parole from Angola, Louisiana State Penitentiary, he would not do anything which would possibly violate this parole. At that time, [redacted] was furnished twenty photographs of white males and asked to go through them, pointing out anyone who he is acquainted with. [redacted] chose the photograph of FRANK LEE MORRIS, IO number 3584, stating while in Angola, he felt around the early 1950's, he knew the individual whose picture he had chosen as FRANK LYONS. He said he has not seen this individual since MORRIS' transfer from Angola to a prison, possibly in Mississippi. He said the last time he heard anything about MORRIS was in 1954, or 1955, when he [redacted]

[redacted] advised the subject of this particular program was the life of the individual he knew as FRANKIE LYONS. [redacted]

[redacted] emphatically stated he has not seen, nor has he heard, from MORRIS since his transfer from Angola.

[redacted] was asked if he was acquainted with a fellow named [redacted] or one named [redacted] and he said he served time in Angola with both of these individuals. He said he does see [redacted] periodically in the New Orleans area, but he has not seen [redacted] for a number of years.

[redacted] He said he has no idea how you could go about getting in touch with [redacted] but suggested inquiries could possibly be made in the [redacted]

[redacted] was asked if he could recall any conversations he might have had in July of 1966, concerning FRANK LEE MORRIS, and he advised he could not. He said his wife [redacted] is aware of him having once been acquainted with MORRIS and it is even possible, some time in years past, he talked to her about MORRIS. A communication of the El Paso Office received at San Francisco on November 27, 1967, reflected that on November 21, 1967, [redacted] (Protect Identity), [redacted] advised that the bar where [redacted] could be located on Decatur Street, New Orleans.

This bar is located in the same two block area as the French Market Bar, Decatur Street Bar, and Bracattos Bar. [redacted] is possibly hanging out at any one of these bars.

New Orleans communication received at San Francisco on November 27, 1967, pointed out that information furnished by the El Paso and Phoenix Offices as emanating from [redacted] was the grounds for extensive investigation conducted in New Orleans. Information was furnished the Phoenix Office by [redacted] and then similar information was furnished the El Paso Office with the names of the alleged prostitute associate of FRANKIE LEE MORRIS being the only change. It was believed that this was an effort on the part of [redacted] to experience monetary gain. None of the information furnished by [redacted] was verified or refuted. As [redacted] was a previous prison inmate of MORRIS, it would seem possible he would attempt to use his knowledge of MORRIS to furnish information which would appear to be authentic.

Information furnished the Miami Division previously by [redacted] apparently has a ring of the same nature as that being furnished El Paso and Phoenix; however, investigation is still pending New Orleans to interview other persons who were cellmates and inmates of MORRIS in Angola in the early 1950's. Contact has been maintained with [redacted] and information he has furnished seems to be accurate. [redacted] has been transferred to the Parish Prison, New Orleans, Louisiana, and will be interviewed concerning information he might have concerning any activities of FRANKIE LEE MORRIS since his leaving Angola in the early 1950's.



(This information contained in San Francisco report of SA [redacted] dated 6/17/68.) Obviously, this information furnished by [redacted] was completely in error since [redacted] has been confined to a Louisiana prison for nearly three years, and is still there. It should be observed that prior to [redacted] recent location in a Louisiana prison, numerous inquiries had been made regarding her location in the New Orleans area based upon information furnished by [redacted] that he had seen her with Subject within the past year.

It is further noted that [redacted] on another occasion furnished information regarding an [redacted] who was allegedly a girlfriend of Subject MORRIS and who supposedly was working as a barmaid in New Orleans and frequenting bars on Decatur Street. Again New Orleans conducted extensive investigation regarding such a person, including direct inquiry in the Decatur Street area and contact with both [redacted] but again with negative results regarding such a person.

Consequently, careful consideration should be accorded to any other information [redacted] may furnish in the future. It is noted that information furnished by this person regarding any New Orleans investigation has never been substantiated and, in fact, has been directly refuted regarding his allegedly observing [redacted] with Subject approximately a year ago.

This matter was reactivated from a pending inactive status in December, 1966, for the purpose of recontacting relatives, associates, and sources as to whether escapees were alive and as to their whereabouts. These inquiries have been completed and no information has been received that escapees are alive. This matter is being placed in a pending inactive status for one year.
