SITHER, DIRECTOR OF CORPORATE SECURITY, OCCIDENTAL PETROLEUM CORPORATION (OPC), 10889 WILSHIRE BOULEVARD, LOS ANGELES, CALIFORNIA, ADVISED S [REDACTED] ^{b7c} THAT THE ICCC IS A WHOLLY OWNED SUBSIDIARY OF OPC AND APPOINTEE IS THE CHAIRMAN OF THE BOARD OF ICCC. HE SAID FURTHER THAT THE PERSONNEL RECORDS FOR APPOINTEE ARE MAINTAINED AT THE ICCC OFFICE IN LEXINGTON, KENTUCKY. SITHER ADVISED THAT HE HAS HAD CLOSE ASSOCIATION WITH APPOINTEE SINCE GORE BECAME AFFILIATED WITH ICCC IN ABOUT 1972. HE SAID THAT THE

HE ADDED THAT GORE'S MAIN EXPERTISE WITH THE COAL COMPANY IS THE RENEGOTIATION AND NEGOTIATION OF PUBLIC UTILITY COAL CONTRACTS, WHICH BEFORE HIS EFFORTS TO NEGOTIATE THEM, WERE WRITTEN TO THE DISADVANTAGE OF THE COMPANY LOSING THEM MUCH PROFIT.
