DEMONSTRATION BY ANANDA MARGA JUSTICE COMMITTEE AT UNITED STATES CAPITOL, JULY 17, 1975 - AUGUST 15, 1975; IS - INDIA

ON JULY 17, 1975, A REPRESENTATIVE OF THE CAPITOL POLICE ADVISED THAT THE ANANDA MARGA JUSTICE COMMITTEE INTENDED TO CONDUCT A VIGIL ON THE EAST FRONT STEPS OF THE UNITED STATES CAPITOL FROM JULY 17, 1975 UNTIL AUGUST 15, 1975, FOR THE PURPOSE OF PROTESTING THE OUTLAWING AND PERSECUTION OF THE ANANDA MARGA ORGANIZATION IN INDIA AND IMPRISONMENT OF ITS LEADER SHRII SHRII ANANDAMURTI AND MANY WORKERS AND FOLLOWERS. THE GROUP INTENDED TO HAVE SIX TO TEN PARTICIPANTS PRESENT ON THE EAST STEPS FROM 9:00 IN THE MORNING UNTIL 10:00 AT NIGHT DURING WHICH TIME THEY WILL PASS OUT LEAFLETS AND POSSIBLY GIVE SPEECHES. IT WAS NOTED THAT THE GROUP HAD PREVIOUSLY INTENDED TO CONDUCT A DEMONSTRATION ON JULY 14 AND 15 AT THE CAPITOL, HOWEVER, THESE PLANS WERE DROPPED.

[REDACTED] The Ananda Marga is self-described as a religious social organization with a goal of peaceful social reform. The Ananda Marga, also known as Anand Marg, was founded in India by Prabhat Rainjan Sarkar. (U)

Sarkar, who is known to his devotees as Anadmurti (Bliss Incarnate) and Baba (father), was imprisoned in India after being found guilty of conspiring in the murders of six former followers who had defected from "Anand Marg." The "Anand Marg" and its splinter groups, i.e., Universal Proutist Revolutionary Federation, etc., have committed numerous acts of terrorism throughout the world demanding the release of their leader, Sarkar, and social revolution in India. (U)

The "Anand Marge" was founded in 1955 by Prabhat Rainjan Sarkar, alias "Baba" or Ananda Murthiji, and advocates the overthrow of the Indian government and a takeover by a group called "Sadvippas," an elite section of "Anand Marg." The group reportedly had indicated that such overthrow would be accomplished by bloody revolution. Sarkar has been imprisoned since 1971 on charges he ordered the murder of several defectors from the "Anand Marg." He has since been released in 1978 on bond pending an appeal before the Indian court. (U)

Sarkar claims to be the incarnation of God and his purpose is to establish a government of moralists. He has succeeded in persuading his followers that he has supernatural powers and can liberate their souls. Once the organization gained some popularity it became involved in politics.

The organization then reportedly started a para-military cadre to give training in military drill, guerrilla warfare, etc., to its members. Since 1968, "Anand Marg" started opening branches in different countries under the guise of yoga societies, pre-school programs, and relief centers. Some of the foreign disciples have traveled to India for instruction. (U)

"Ananda Marge" established itself in the United States in 1971, when Achrya Yatishwarananda Avadhoot, alias R. Venkatanarayan, was sent to propagate the group's philosophy. The headquarters was established in Wichita, Kansas, under the name of the "Ananda Marga" Yoga Society of United States of America. In 1973, the Society bought its own three-story building at 854 Pearl Street, Denver, Colorado, and moved its headquarters there. (U)
