

[REDACTED] advised that she is a member of Ananda Marga. Her purpose in visiting the FBI was to deny certain allegations made by the news media that Ananda Marga was responsible for certain activities directed against Air-India. [REDACTED] stated that she was directed by the Sectorial Headquarters of Ananda Marga, which is located in Denver, Colorado, to advise that Ananda Marga does not believe in or espouse acts of terrorism. She stated that terrorism has no place in the philosophy of Ananda Marga.

[REDACTED] produced copies of three letters which were furnished to her through the Ananda Marga Headquarters in Denver, Colorado. The first letter was directed to the United States National Director, Air-India, 345 Park Avenue, New York, New York, which in effect denied and disavowed any association or connection with any organization known as the Universal Proutist Revolutionary Federation (UPRF). This letter was signed by ACARYA YATIISHVARANANDA AVT.. The second letter was addressed to the FBI, Denver, Colorado, dated October 23, 1977, and disclosed that Ananda Marga is a non-profit social service/spiritual organization and disavows any connection with the UPRF. This letter is signed by IVO NELSON. The third letter was mailed to An. Marg, 854 Pearl Street, Denver, Colorado, and is addressed to MORAJI DESAI. This letter assumes the responsibility for actions taken against the airlines of India in the name of the Universal Proutist Revolutionary Federation, and is signed UPRF, U.S. Division, North American Command.

[REDACTED] stated that the term Universal Proutist Revolutionary Federation may have been taken from the organization called Prout. She advised that Ananda Marga and Prout both espouse the philosophy and teachings

of Mr. P. R. SARKAR. She also advised that the regional leader of Prout has been in contact with an FBI Agent named [REDACTED] in San Francisco, California.

[REDACTED] stated that Ananda Marga would fully cooperate with the FBI in order to clear Ananda Marga of any wrongdoing. She advised that it was her personal opinion that a conspiracy to frame Ananda Marga was initiated by the India Central Bureau of Investigation and the KGB of the Soviet Union. She advised that her belief originated from information that Ananda Marga in India had been gaining followers among the young people and college students; therefore, supplanting the Communist philosophy among the Indian young.

[REDACTED] stated that the Los Angeles Office of Ananda Marga is located at 1245 South Norton Avenue, and the telephone number is 731-1372.

[REDACTED] advised that the copies of the three letters furnished to her through Ananda Marga Headquarters in Denver were to be given to the FBI Office at Los Angeles, California.

Dear Sirs,

In the last month we have received copies of three threatening letters addressed to Mr. Moraji Desai from the Universal Proutist Revolutionary Federation. Two of the letters contained threats that were directed at Air India. Upon immediate receipt of each letter, a representative from our national office submitted it to the Federal Bureau of Investigation of the United States.

I would like to say at this time that Ananda Marga is in no way associated with the Universal Proutist Revolutionary Federation. Acts as have been alleged by the UPRF are not by any means representative of Ananda Marga's activities in North America. In the United States alone we have established such projects as group homes, schools, prison programs, disaster relief teams, and many other service-oriented programs.

We do support the request that the founder and spiritual leader of Ananda Marga, Mr. P. R. Sarkar, be released from prison in India. It is our feeling that due to the adverse political setting in India during the State of Emergency, it was impossible for fair trial proceedings to take place. Documentation of our position is available through reports by W. T. Wells (Queen's Counsel) and Claude Sheppard, a lawyer sent as a neutral observer of the trial by the International Commission of Jurists and The League for Human Rights.

Regardless of our stance on the fairness of Mr. Sarkar's trial, we do not support violent acts as a means to justify his release, or for any other reason. Mr. Sarkar himself stated in a recent interview, "I completely disown these acts of violence... I will not obtain my release in this way."

At this time, we feel that the attacks on your offices, as well as similar actions that have been performed in other countries under the auspices of the UPRF, are an effort by a foreign intelligence agency to defame Ananda Marga. Recent research shows good reason for such an attack. A booklet is now being prepared that will

clarify this line of thought. Upon completion, a copy will be sent to you.

We have been keeping in constant touch with the FBI in San Francisco, Washington D. C., and Denver as well as the State Department, Indian Embassy, and Secret Service in Washington, D. C.

I deeply regret the injury that resulted from the incident in Los Angeles and sincerely hope it will not be repeated.







The Anand Marg, founded in India by Prabhat Rainjan Sarkar, is self-described as a religious, social organization whose goal is peaceful, social reform. Sarkar, who is known to his devotees as Anadmurti (Bliss Incarnate) and Baba (father), was imprisoned in India after being found guilty of conspiring in the murders of six former followers who had defected from Anand Marg. The Anand Marg and its splinter groups, i.e., Universal Proutist Revolutionary Federation, etc. have committed numerous acts of terrorism throughout the world demanding the release of their leader Sarkar, and social revolution in India.

The Anand Marg was founded in 1955 by Prabhat Rainjan Sarkar, alias "Baba" or Ananda Murthiji, and advocates the overthrow of the Indian government and a takeover by a group called "Sadvippas," an elite section of Anand Marg. The group reportedly had indicated that such overthrow would be accomplished by bloody revolution. Sarkar has been imprisoned since 1971 on charges he ordered the murder of several defectors from the Anand Marg. He has since been released in 1978 on bond pending an appeal before the Indian Court.

Sarkar claims to be the incarnation of God and his purpose is to establish a government of moralists. He has succeeded in persuading his followers that he has supernatural powers and can liberate their souls. Once

the organization gained some popularity it became involved in politics. [REDACTED]

[REDACTED] Since 1968, Anand Marg started opening branches in different countries under the guise of yoga societies, pre-school programs, and relief centers. Some of the foreign disciples have traveled to India for instruction.

Ananda Marg established itself in the United States in 1971 when Acharya Yatishwarananda Avadhoot, alias R. Venkatanarayan, was sent to propagate the group's philosophy. The headquarters were established in Wichita, Kansas, under the name of the Ananda Marga Yoga Society of USA. In 1973 the Society bought its own three-story building at 854 Pearl Street, Denver, Colorado, and moved its headquarters there.

The Ananda Marga Yoga Society is self-described as a group whose members attempt, through self-discipline, and meditation, to find ecstasy and inner peace. In 1975 the Society claimed to have 80 branches in the U.S. In 1972 and 1973, it engaged in demonstrations in Washington, D.C., and San Francisco, California, protesting the jailing of its spiritual leader, Shrii Shrii Anandamurti (Sarkar). These demonstrations were peaceful; however, a demonstration at the Indian Embassy on April 23, 1973, resulted in the arrest of two Society members. They were charged with "Depositing of Trash in a Public Place" after they attempted to deliver to the Indian Ambassador the ashes of a monk who had immolated himself. In the process, the container of ashes was dropped and broke on the Embassy steps.

In late 1976, Sarkar claimed to have eight million followers in India, Great Britain, the United States, Canada, The Philippines, and Australia.

Activity in the United States

On October 20, 1977, a brick and fire bomb were thrown through the window of the Air India office at 400 Park Avenue, New York, New York.

While PROUT professes to be neither capitlistic nor communistic, its primary tenet is that no individual should be allowed to accumulate any wealth without the "approval of the collective body." According to PROUT, only the elite who possess "education, morality, and socioeconomic-politico consciousness" should be invested with political power.
