



The November 28, 1977 late city edition of "The New York Times", a daily newspaper published in New York City (NYC), sets forth on page six an Associated Press (AP) dispatch dated November 27, 1977 from New Delhi, India. Under the caption, "India Tightens Security After Suspected Sabotage", the following report is set forth. (U)

"Prime Minister Morarji R. Desai's Government ordered tighter security tonight on the Indian railways and at power, communications and other vital installations". (U)

"The move followed a series of accidents and fires that some authorities have attributed to sabotage. Anti-Government political elements and the Anand Marg, a Hindu religious sect that is demanding the release of its leader from prison, have been accused of the sabotage". (U)



"The security measures were ordered after seven suspected attempts of sabotage in the last fifteen days against the Government-run railroad system, a fire that burned tapes and files at a Government radio studio and an explosion at a thermal-electric plant". (U)

"In the most serious incident, twenty persons died in a train derailment south of New Delhi last Wednesday. The railroads minister said the track joint had been opened in what he called a clear case of sabotage". (U)

NOTE: The AM is basically a religious organization concerned with social services and peaceful social reform. It was founded in India by P. R. Sarkar, who is imprisoned in India for conspiring in the murders of several former followers who defected from AM. Recently, there have been attacks directed at Indian establishments and citizens within the United States and UPRF has claimed responsibility for these attacks. UPRF alleges to be a front organization of AM. However, AM leaders vehemently deny any affiliation with UPRF or any of the attacks claimed by UPRF. AM is headquartered in the United States in Denver, Colorado, and AM leaders in Denver and other U. S. locations have initiated contact with our offices offering to be of assistance in identifying those individuals responsible for the attacks directed against Indian personnel and establishments. We are investigating these attacks as criminal investigations under the PFO statute, and no separate domestic security or foreign counterintelligence investigation is warranted at this time. Should such investigation appear necessary at a later date, same will be instituted and appropriate offices notified.





At approximately 6:45 p.m., November 28, 1977, Silla Koteswar, Attache assigned to the Indian Embassy, was stabbed by an unknown assailant outside the Indian Embassy Annex, 2536 Massachusetts Avenue, N.W., Washington, D.C. (WDC). An Embassy security guard removed two knives from Koteswar's back and Koteswar was transported to the George Washington University Hospital, where he underwent successful surgery. Investigation by the Metropolitan Police Department (MPD), WDC, and the Federal Bureau of Investigation (FBI), at the Indian Embassy Annex after the stabbing reflected no information relating to the individual responsible for the assault on Koteswar.

On November 28, 1977, the Indian Embassy, WDC, received a threatening letter signed by the Universal Proutist Revolutionary Federation (UPRF), North American Command, United States Division, which demanded the unconditional release of P.R. Sarkar and stated that if this was not done "blood is on your hands."

On December 1, 1977, [redacted] received a letter addressed to Moraji Desai, Prime Minister of India, advising that the UPRF was taking credit for the stabbing of Koteswar and signed UPRF, United States Division, North American Command. The letter stated, "The Universal Proutist
