

PURPOSE: To document a phone call from [REDACTED] Georgia State Bureau of Investigation Crime Laboratory.

DETAILS: On May 15, 1981, SA [REDACTED] of the Laboratory Division received a call from [REDACTED] Georgia State Bureau of Investigation Crime Laboratory. [REDACTED] stated he was calling for the purpose of extending an invitation for a representative of the FBI Laboratory to attend a seminar type conference on June 13, 1981, at the GSBI Crime Laboratory in Atlanta. He stated that a written communication would follow his telephone call confirming this invitation; however, he indicated that numerous invitees would be at this conference whom he characterized as leading fiber experts in the country.

SA [REDACTED] expressed appreciation for being included in this list and he advised [REDACTED] that SA [REDACTED] is now handling these matters for the FBI Laboratory and that this information would be passed to SA [REDACTED]. No actual acceptance of this invitation was made during this telephone conversation.

RECOMMENDATION: Recommend that SA [REDACTED] of the Microscopic Analyses Unit be assigned to attend this conference on June 13, 1981.

OUTSIDE SOURCE

I wish to propose my "theory" on the Atlanta slayings. I have studied the sociopathic / psychopathic personality since 1967. At that time very little info could be found in any printed materials.

The lady psychic from Nutley, New Jersey seems to me to be correct in that the individual is also of the same race (Negro) as the victims.

At the moment I cannot state definitely whether the culprit is male or female. Considering the physical size of the victims, a female cannot be ruled out.

The possible motive for a female could possibly be:

① Mother of adult or teenage sons who were killed or maimed in the "streets", ergo she wishes that other young black boys be mercifully put to an end before causing their parents' grief in leading useless lives. 10

② Someone who has obtained an abortion against her will of a male child

The possible motive for a male could possibly be:

① A prominent member of the black community who remembering his great struggle up from poverty to his present position - realizes the vast odds which were against him. 1981

② An individual who considers himself worthless and desires that instead of ending his life - to save and shorten the sufferings of those of similar early childhood situations. A uniform of any sort - that a child ^{easily} recognizes.

I am not sure whether any notes were left. Therefore, I can only conjecture that the perpetrator(s?) are of super-intelligence or at the other extreme - super imbecility.

I had come up with the idea of the changed license plates before the Yorkshire Ripper was apprehended. But the connection with that particular criminal did not "click" until I had read the newspapers.

You are probably dealing with a criminal who believes that he/she is on some God-given crusade to help the "suffering children." This personality does not see his/her actions as being against the law per se. Probably, very religious individual.

I pray that the number of victims never reach 30 and that my theories will help your investigation and place you on the correct path to conclusion of this case.

PURPOSE:

To summarize discussions between SA [redacted] and [redacted] the Division of Forensic Sciences, Georgia Bureau of Investigation (GBI), Atlanta, Georgia, concerning this case. To set forth S.A. [redacted] impressions concerning the capabilities of the GBI Crime Laboratory in this matter.

SYNOPSIS:

SA [redacted] also repeats the Bureau offer of Laboratory assistance to GBI and discusses some areas where the MAU can become involved in this case.

A letter from [REDACTED] to the Atlanta Office is attached to this memorandum. It explains [REDACTED] reasoning for his conclusion. It should be noted that the Shepherd mentioned above is not the common German Shepherd but a rare breed that is not normally encountered. [REDACTED] has also advised the Atlanta Office that there are other dogs having hairs similar to those recovered from the victims but these other dogs do not shed hair to any great extent. The large number of hairs recovered in this case indicates to [REDACTED] that the animal involved sheds readily.

SA [REDACTED] can find no errors in the above reasoning and feels that a veterinarian such as [REDACTED] is more experienced in matters of this type than forensic microscopists. It should be noted, however, that actual microscopical comparisons of the question dog hairs and known samples of the many long-haired dogs that exist have not been conducted.

In discussions with [REDACTED] SA [REDACTED] on both April 28, 1981, and April 29, 1981, repeated the previous offer of FBI Laboratory assistance that SA [REDACTED] made to [REDACTED] the GBI Laboratory [REDACTED]. As before, this offer was made with the understanding that the GBI Laboratory would coordinate the work of the FBI examiners.

SA [REDACTED] specifically mentioned that the FBI Laboratory could become involved with the examination of items of clothing and other objects from the houses of victims, looking for fibers like those previously recovered from the victims' bodies. SA [REDACTED] also suggested that the FBI Laboratory make a major effort to determine the manufacturers and sources of the various fibers of significance in this case. In these areas the FBI would not be dealing with the major items of evidence such as the victim's clothing. The chances of obtaining significant findings would be low and these types of examinations would be time consuming, but these areas should be completely covered in a case of this significance.

He has examined some items of clothing obtained from the homes of various victims and has found some fibers indicating that there may have been some prior contact or relationship between some of the victims and the offender. [REDACTED] has also initiated contact with various fiber manufacturers to attempt to determine specific sources of the fibers common to some of the victims. [REDACTED] was not specific about the amount of clothing that has not been examined or how close he is to the determination of a source of the questioned fibers. [REDACTED] graciously acknowledged the Bureau's offer but made no indication that the Bureau's assistance would be requested at any time in the near future. It is pointed out that SA [REDACTED] memorandum dated April 14, 1981, concerning his contact with the GBI Laboratory, goes into greater detail regarding his offer of FBI assistance to [REDACTED]

On 5/20/81, based on Bureau approval and thereafter, written permission from the Department of Justice (DOJ), [redacted] were separately interviewed under hypnosis for information pertaining to an attempted abduction of [redacted] by unknown individuals near the [redacted] residence in Atlanta, Georgia.

An attempt was made by Dr. [redacted] to hypnotize [redacted] utilizing the eye and muscle relaxation technique. However, she did not enter a hypnotic state, but instead responded by entering a self-induced trance. During this trance, [redacted] hallucinated as to the alleged attempt to kidnap [redacted] by these unknown individuals. During this period of time, she gave vague information as to the individuals. In the latter part of this self-induced trance, she asked for paper and pencil, writing on the piece of paper that she saw that [redacted] is the killer. After the self-induced trance, she, on her own volition, entered a voluntary state and stated that she felt fine.

On the same date, [redacted] was interviewed under hypnosis, which was induced by Dr. [redacted] utilizing the eye and muscle technique. [redacted] entered a moderate trance at the initial stages of the interview and later moved to a light trance. [redacted] furnished descriptive data of the two individuals, one white and one black, who had attempted to abduct him. He stated that the black individual's first name was known to him as [redacted] (phonetic). He further stated that he knew the black male from previous occasions when the black male had taken Timothy Hill and "Jo Jo" Bell (previous victims of captioned matter) to several areas [redacted]

By attached teletype the Atlanta Division advises that attempts continue to establish positive link between suspect Williams and victims in captioned matter.

On 6/10/81, [REDACTED] and [REDACTED] advised they were close associates of Joseph Bell, and, in fact, resided in the same neighborhood. [REDACTED] advised that on the day previously to or the day of Bell's disappearance he was playing basketball with Bell when Bell decided to go home. [REDACTED] observed Bell entering a light blue older model station wagon. [REDACTED] selected, from the photographic spread, the photograph of suspect Williams as being the operator and sole occupant of the station wagon. [REDACTED] knows suspect Williams, having answered Williams' talent scout ad and auditioning for him. [REDACTED] recalls discussing the audition with Bell, with Bell indicating to him that he, Bell, knew the suspect Williams.

Task Force officers were interviewing an associate of Williams, [redacted] on 6/10/81, approximately 7:30 p.m., when [redacted] telephonically contacted Williams and advised him of the interview. Williams and his father proceeded to [redacted] residence in a rented Toyota automobile. Williams spoke privately with [redacted] and returned to his residence. Approximately 30 minutes later Williams' father was observed driving out of his residence in the Toyota by himself. One surveillance vehicle followed to a nearby Amoco gas station. At this time, suspect Williams was observed exiting the trunk of the car and entering the driver's side driving off with both he and his father. Evasive driving caused the loss of the Toyota by the surveillance vehicle. Suspect's father located subsequently at his place of business "Atlanta Daily World" without vehicle or suspect Williams. At approximately 9:45 p.m., suspect Williams observed picking up his father at employment (supra) and Williams began evasive driving including speeds over 80 miles per hour (MPH), wrong direction on one-way streets, and through traffic lights. By attached teletype, the Atlanta Division advises that the name of John Harold Porter, Jr., found 4/12/81 in a vacant lot in Atlanta, Georgia, with multiple stab wounds, has not been added to the list of murdered and missing children.

Georgia Crime Lab, Atlanta, Georgia, has indicated that although a final crime lab report has not been prepared relative to Porter, trace evidence obtained from the victim includes green carpet fibers and light violet bedspread fibers. These fibers appear similar to those found in the home of ATKID suspect Wayne Bertram Williams. Additionally, Porter's blood type and enzymes contained therein were the same as blood-stained evidence which was found in Williams' automobile.

Surveillance of Williams is continuing and Bureau will be kept advised of all additional pertinent information.

Additionally, Atlanta is in the process of contacting over 400 associates and acquaintances of Williams' for the purposes of interviewing and display of photographs where appropriate.

The former residence of Michael McIntosh, a prior victim in this matter, was processed on 6/8/81 and a limited number of fingerprints were obtained and forwarded to the FBI Laboratory for analysis.

The case of John Harold Porter has not yet been placed on the Task Force's list of missing and murdered children; however, the Atlanta Division is obtaining the facts of the full investigation conducted to date.

The Atlanta news media has been erroneously reporting that a witness has voluntarily come forth stating that he had seen Williams with prior victim Yusef Bell.

A meeting between AUSA Chuck Sapphos and the Attorney General for the State of Georgia was held on 6/8/81 to discuss an alternative to the opposition of Lewis Slaton to proceeding in a legal manner regarding Wayne Bertram Williams. No decision has yet been reached as a result of this meeting.

DETAILS: On 5/22/81 at approximately 3:00 a.m., pursuant to a bridge surveillance being conducted by representatives of the FBI and the Atlanta Task Force, an individual was identified as a possible suspect in this matter. This was based on the observation of [REDACTED] Atlanta Police Department (APD) recruit assigned to the bridge surveillance, who was stationed on the north bank of the Chattahoochee River on the west side of the James - Jackson Bridge. At approximately 3:00 a.m. [REDACTED] heard a loud splash and observed large ripples in the water, which splashed against the bank, with the point of entry being 21 feet from the bank of the river.

Immediately after the splash, [REDACTED] APD recruit assigned to the bridge surveillance, who was stationed on the south bank of the river, was informed by [REDACTED] via radio of the splash and inquiries made by [REDACTED] of a car on the bridge. [REDACTED] observed a 1970 Chevrolet station wagon moving slowly toward his location with vehicle lights on and with no other cars being

on the bridge. [REDACTED] observed this automobile drive slowly off the bridge into a liquor store parking lot and thereafter, proceeded back across the James - Jackson Bridge in the direction of Interstate 285.

This vehicle was followed by Officer [REDACTED] APD, and by Special Agents [REDACTED] and [REDACTED]. This vehicle was stopped as it headed south of Interstate 285 at which time the sole occupant of the vehicle was Wayne Bertram Williams. 7

At the time the vehicle was stopped, observed in the vehicle were: (1) a large plastic bag of what appeared to be women's clothing in the back of the station wagon; (2) hairs which appeared to be dog hairs on the floor of the back; (3) a brown paper bag on the floor of the front seat containing men's clothing consisting of dark colored trousers, black shoes, a pair of white jockey shorts, and a tank top; and (4) a two-foot white, nylon cord in the back of the station wagon. The configuration of the station wagon was that the back seat was down creating additional space.

During interview pursuant to the stop, Williams stated he was attempting to locate an address of a woman who wanted to speak to him about a job and that he was to meet this woman in the morning of 5/22/81. Williams further stated that after crossing the James - Jackson Bridge he traveled past the liquor store to a "Starvin Marvin" store where he tried unsuccessfully to contact this woman. APD recruit [REDACTED] advised Williams did not proceed to store mentioned supra but turned around at the liquor store 100 feet south of the bridge, recrossed the bridge and headed north toward Interstate 285. Williams denied throwing anything out of the car while on the bridge and stated that he had been hunting for empty box cartons at the liquor store. Williams further stated that there were two other vehicles on the bridge at the time he was crossing over the bridge. Williams provided the name of the woman he was to meet as Cheryl Johnson, telephone number 934-7766. Subsequent investigation determined a recorded message at the number indicating a change to telephone number 768-2710, which is listed for "Merle Norman Cosmetics," with no one answering the telephone knowing of a Cheryl Johnson. b7c

On 5/24/81 at approximately 12:00 noon, the body of Nathaniel Cater was found on the bank of the Chattahoochee River approximately two miles downstream from the James - Jackson Bridge. The medical examiner determined cause of death was asphyxiation with the body having been in the water several days.

The attached chart provides a listing of victims on which hairs and fibers were found which are consistent in microscopic appearance to those comprising the green nylon fibers of the carpet in Williams' bedroom, the light violet fibers comprising the bedspread of Williams', and the dog hairs of a German Sheppard-type mixed-breed dog chained in the rear of the Williams' residence. A source for the light yellow carpet fibers of microscopic appearance was not found in the search of Williams' automobile or residence. The analyses were conducted by [REDACTED] Microanalyst for the Georgia State Crime Laboratory. *b7c*

A synopsis of information on attached chart concerning fibers and hair found on the clothing and/or the bodies of the victims listed thereon, which are consistent in microscopic appearance to those fibers and hairs found in Williams' residence and vehicle, is as follows: Green Carpet Fibers - 10; Small Lt. Violet Fibers (Blanket) - 13; Lt. Yellow Carpet Fibers - 5; and Dog Hairs - 6.



A letter contains threat to individual reading letter, and mentions captioned matter, while reversed side of envelope contains threat to President Ronald Reagan.

Examination of return address area on face of envelope appears to have previously listed return address which had been written in pencil and which was subsequently erased, and the name "Bobby Doe" added over the erased impressions.

By attached teletype, the Atlanta Division advised that [redacted] Black male, aged 15, who was reported missing on 4/21/81 was subsequently found on 4/22/81. Fibers on his clothing matched some of the fibers previously reported in the ATKID matter.

[redacted] allegedly was with two other individuals who stole a van, and he reportedly slept in the vehicle of one of these two other individuals.

On 6/15/81, [redacted] was afforded a polygraph examination regarding his association with Wayne Bertram Williams. The preliminary analysis of this polygraph reflected nondeceptive results on the part of [redacted]

An AUSA for the Northern District of Georgia advised that a restraining order was to be filed by Mary Welcome, attorney for Williams, requesting that the media and law enforcement be prohibited from making public certain facts regarding Williams. A motion was filed 6/15/81 to have the hearing on the restraining motion, which is set for 6/16/81, be closed to everyone but Williams and the attorneys for the government.

Associates and friends of Williams' are currently being contacted and interviewed and a surveillance of Williams is being maintained.



By attached teletype, the Atlanta Division advises that it has reviewed a 6/14/81 "New York Times" article entitled, "Officials in Atlanta Suggest FBI Mishandled Key Lead in Slayings". Numerous factual errors are contained in the article as well as incorrect inferences and conclusions. These factual errors, incorrect inferences, and conclusions are thereafter refuted.

The article apparently makes two arguments, first that the Williams' investigation was mishandled and because the FBI refused to allow Task Force participation, the FBI is solely responsible.

It is the opinion of the SAC, Atlanta, that each critical decision made by Special Agent personnel was proper in view of the facts known at the time of the decision. Also, every facet of the bridge surveillances and Williams' investigation has been made known to and implemented in coordination with the Atlanta Task Force.

It is additionally noted that the "New York Times" article appears to be a purposeful "leak" to discredit evidence recovered by the FBI relative to Williams and to justify non-prosecution based on FBI "bungling" and not prosecutive discretion.

IN FACT, THE TWO OFFICERS SELECTED BY REDDING WERE CHOSEN NOT BECAUSE OF THEIR SURVEILLANCE EXPERTISE, BUT BECAUSE THEY COULD BE TRUSTED NOT TO "LEAK" TO THE MEDIA.

9) PARAGRAPH 41 ALLEGES THAT THE JUNE 3, 1981, INTERVIEW OF WILLIAMS WAS A RESULT OF A NEED TO PLACE SURVEILLANCE DEVICES IN HIS HOUSE AND CAR HAVING "FAILED IN AN ATTEMPT TO ATTACH AN ELECTRONIC HOMING DEVICE TO HIS CAR." WHEN IN FACT THE INTERVIEW OCCURRED ONLY AS AN ADJUNCT OF THE EXECUTION OF SEARCH WARRANTS ON WILLIAMS' HOME, CAR, AND PERSON NECESSITATED BY THE FACT WILLIAMS APPARENTLY "MADE" THE SURVEILLANCE THE EVENING OF JUNE 2, 1981. THE "BEEPER" HAD PREVIOUSLY BEEN ATTACHED PER COURT ORDER MAY 30, 1981, AND THERE WAS NEVER ANY INTENTION OF "BUGGING" WILLIAMS' HOME.

10) PARAGRAPH 43 ALLEGES WILLIAMS WAS IN "CUSTODY" ON JUNE 3, 1981, WHEN IN FACT HE VOLUNTARILY SUBMITTED TO INTERVIEW AND THAT HIS FATHER WAS ALLOWED "ON THE SAME FLOOR WITH HIM" WHEN IN FACT HIS FATHER WAS ALLOWED TO SPEAK HIM TO HIM ONLY DURING THE LAST FEW MINUTES WILLIAMS WAS AT THE FBI OFFICE AND ONLY AT THE REQUEST OF PUBLIC SAFETY COMMISSIONER LEE BROWN AND CHIEF REDDING IN HOPES THAT WILLIAMS FATHER COULD CONVINCE HIM TO ACCEPT PROTECTIVE CUSTODY STATUS.

11) PARAGRAPH 49 ALLEGES THAT THE FIBERS FOUND IN THE SEARCH OF WILLIAMS' RESIDENCE ARE "SIMILAR" TO THOSE FOUND
