Dear Sir:

With reference to my teletype to the Bureau dated May 28, 1936, having to do with the Black Legion, and a statement appearing in the Indianapolis Times, Indianapolis, Indiana, issue of May 28, 1936, stating that the Black Legion was being investigated in Indianapolis by U. S. Department of Justice agents at the request of Detroit authorities, permit me to attach hereto for your information the news item and a kindred item over a Detroit date line of May 28 (UP).

It is my understanding that this Bureau Office is not to interest itself in the Black Legion, or its activities, unless its activities are in violation of a Federal Statute over which this Bureau has basic investigative jurisdiction, and that this office is not to interest itself in making investigations even when the facts indicate Federal Statutes over which this Bureau has investigative jurisdiction, until the information has been submitted to the Bureau, and the Bureau thereafter issued instructions to make an investigation.

In other words, no activity is to be engaged in by this office in the absence of Bureau instructions.

## U. S. Reply to Detroit Plea for Aid Is Delivered to McCrea.

### 12 MEN ARE SOUGHT 15 to 18 States Involved in Movement, Belief of Authorities.

DETROIT, May 28.—The Federal government replied today to an invitation to enter the investigation of the night-riding, terroristic society, the Black Legion.

Prosecuting Attorney Duncan C. McCrea pressed his search for 12 fugitive Legionnaires, whose arrests may bolster his charge that the cult accused of responsibility for killings and floggings is operating actively in 15 to 18 states and particularly in New York City and Chicago.

The Federal government's reply was delivered by Harold H. Reinecke, head of the local office of the Federal Bureau of Investigation, whose chief is Atty. Gen. Homer S. Cummings, whom McCrea petitioned yesterday for Federal intervention. Reinecke refused to hint as to the nature of the reply, saying that McCrea was the person to make it public.

As he delivered the reply there came evidence from Lima, O., that the Federal Bureau of Investigation had looked into the Black Legion as far back as 18 months ago.

#### Interviewed by G-Man

William H. Smith, an Ohio farmer who was kidnaped and beaten by Legionnaires on Sept. 29, 1934, said he was interviewed by a Department of Justice agent who told him: "You'll be called upon to tell your story in court at the proper time."

With a mass of evidence already compiled McCrea intimated that the 12 men being sought were of great importance to his investigation.

At Jackson, a grand jury resumed its investigation of Legion activities there. The jury already had issued warrants for the arrest of 25 men accused of kidnaping and flogging Harley Smith who was forced to join the Legion and beaten when he failed to attend one of its meetings.

#### Grand Jury Probes Planned

Atty. Gen. David H. Crowley having initiated a one-man grand jury inquiry in Wayne County (Detroit and environs) returned to Lansing to plan similar proceedings throughout Michigan.

In petitioning Atty. Gen. Cummings for Federal aid yesterday, McCrea said.

"I know definitely that the Black Legion is operating in 15 to 18 states. I know that it is very active in the cities of New York and Chicago. I have reason to believe that the activities of the Legion have included the hauling of bodies across state boundary lines, which is a Federal offense."

He told Cummings that his evidence showed that "many serious crimes have been committed in states other than Michigan."

"Of course, I am unable to investigate these," he said, "and for that reason I have sought the aid of the Department of Justice."

#### 12 Other Hunted

McCrea's investigators and six members of the Detroit Homicide Squad were searching for the 12 fugitive Legionnaires.

At Jackson, Smith, the Black Legion victim, threw a new light on the organization's techniques. He said:

"Two neighbors invited me to a party about a year ago. I went and pretty soon we got to a place where there were three men in robes. They called themselves Black Knights. One man held a gun against me and they gave me the oath. I was scared. I can't remember the oath, but they did give me a bullet and one of them said, 'The next one we give you will be out of a gun.'"

#### Lashed by Group, Report

"I went to one meeting after that. When they told me there was going to be another meeting, I said I couldn't go to it. Well, about last November some of them came around to my house and said, 'Your superior officer wants to talk to you.' I went out to their car. They pushed me into the back seat. They drove about a mile. They told me to get out of the car. They took me into a house and tied my hands. Somebody said, 'What's the verdict—guilty or not guilty?' They voted 'guilty' and somebody said, 'six lashes.'"

"They pulled my shirt off. They gave me six lashes. It felt like a blacksnake whip. It hurt. Then they put me back in the car and we drove a while. We were near my house."

"They took off the blindfold and told me to walk home. I went to one meeting after that—in December. I've been a nervous wreck ever since."

# G-MEN PROBE 'BLACK LEGION'

## HERE

ALLEGED TERROR  
NOTES ARE LEFT  
AT LOCAL HOMES

**Messages Promise Calls  
Will Be Made 'at Night  
in Robe.'**

**LIKE MICHIGAN NOTES**

**Indiana Infested With Ar-  
dent Members, Says  
Detroit Prosecutor.**

Notes purporting to be from "The Black Legion" were found last night in Indianapolis and today were being investigated by United States Department of Justice agents at the request of Detroit authorities.

They were found in two near-North Side apartments, stuck in doorknobs. The notes promised the occupants that representatives of "The Legion" would call "at night in robe" to accept their memberships.

Duncan MacCrea, Wayne County, Mich., prosecutor, about whom centers the main probe of the organization's known activities, told The Indianapolis Times today that the notes bore marked characteristics of known Legion documents now in possession of authorities.

"We know definitely," he said, "that Legion members do appear at night in robes both to recruit new members and to force delinquent members to attend meetings.

**"Sound Authentic," He Says**

"The Indianapolis notes sound authentic to me, and I am asking Department of Justice agents, assigned to me by Atty. Gen. Homer Cummings for this investigation, to immediately probe the Indianapolis angle.

"I have already had several confidential communications from the Indianapolis area, which lead me to believe that the Legion is organized there and has been responsible for at least one outrage.

"There is no question in my mind, or in the minds of my associates, but that Indiana is infested with ardent Black Legion members."

The notes, found yesterday afternoon, each consisted of two pieces of paper. One was a salmon pink bond paper, six by four inches. On it was typewritten what was interpreted to be a membership blank. It read:

"Black Legion Membership."  
There followed blank lines for age, name, address, both city and state.

in Is Penalty"

Under that appeared:

"Oath:

"In the name of God and the Devil I will stand up to the Black Legion. I will follow my orders and will abide (misspelled) by the laws of the Black Legion. Never shall I betray its secrets to its ex-members.

"Death is the penalty for the breaking of a law or its oath."

This was followed on one note by the designation "11X7" and a blank preceded the word "Rank." The other note bore the number "610X7."

Last of all, at the bottom, appeared "Black Legion-611X7." The other note's number was "610X7."

**Message Is Typed**

Inside was a piece of cheap white paper, about the same size, upon which was typed the following message:

"Comrade:

"We must reorganize quickly. We suffered a shock that has broke our stride but we will get back to our feet and rush on through the night and show them haw (apparently typing error) it is done.

"The Chief has given the order:

"Fellow comrades we must not give up. We must make the symbol of the skull and cross-bone the terror of the world.

"We must and will take the law in our own hands by August."

"Please sign up now!

"A Lieutenant will call at your home soon (at night in robe). Give your membership to him. He will be your leader and you will get all information from him.

"MAJOR 29K1."

**Imprint of Stamp**

On each document was the imprint of a stamp in purple ink. The design had 16 points connected by seven circles. Indianapolis rubber stamp manufacturers said they believed no such stamp was manufactured and suggested that it may have been cut from cork.

The imprint, they said, did not appear to have been made by rubber.

The two pieces of paper were folded lengthwise and fastened by what appeared to be gummed paper tape similar to that used in groceries.

The occupant of an apartment at which one of the notes was left denied any knowledge of it. He said

he knew of no one who would have sent it either in earnest or jest.

At the same time, Lima, O., authorities disclosed that records of the Black Legion in that possession indicate that the organization went by various names in the different states and were designated as "Red Leg" in parts of Indiana, and "The Black Brigade" in West Virginia.

From Fort Wayne came information that an organization there, believed to be closely connected with "The Black Legion" was called "The Black Snakes."

A local newspaper writer called this writer's attention to a dispatch from Washington, D. C. which advised that United States Representative Clara Hoffman, Allegan, Michigan, had received a threatening letter which was mailed from Benton Harbor, Michigan, May 4, 1936.

This letter was apparently written by a crank and evidently has some connection with the Black Legion investigation now being conducted by State authorities in the State of Michigan.

An attempt was made to reach Congressman Hoffman at his home in Allegan, Michigan, but this writer was advised that he is presently in the City of Washington, D. C.

You are requested to contact this Congressman at once and ascertain the circumstances surrounding the receipt of this letter and whether or not it is the type of threatening letter over which this Bureau has investigative jurisdiction.

For your information, the Detroit office has received instructions from the Bureau that no investigation is to be conducted relative to "The Black Legion" without a specific authorization from the Bureau.

## U.S. Considers Joining Inquiry Cummings to Confer with G-Man Hoover

(From the Free Press Bureau)  
WASHINGTON, May 27—Attorney General Homer S. Cummings will reach a decision within 24 hours on sending G-men into Michigan to investigate the Black Legion, his office announced here tonight.

A telegram was received from Prosecutor Duncan C. McCrea, of Wayne County, asking that agents of the Federal Bureau of Investigation be sent into the state. Cummings will confer tomorrow with J. Edgar Hoover, director of the FBI, and announce his decision as to whether Federal matters are involved.

Before he received the telegram, Cummings announced that he had been following the investigation of the Black Legion through the newspapers, and that as far as he could see no Federal law was involved.

Rep. Clare E. Hoffman, of Allegan, today made public a letter in which he was threatened with death because of his opposition to the Townsend movement in Michigan. The letter was signed "K. K. K." and was forwarded from Benton Harbor. The envelope in

which it was forwarded carried the letterhead of the "Twin City Renovating Co., P. O. Box 401, Benton Harbor, Mich." Across the letterhead was scribbled the words "out of business." The Postoffice Department will attempt to trace the sender.

Hoffman has also received an abusive letter from a man signing himself "John Anderson, Aurora, Ill." The Representative was not inclined to take the threats seriously, asserting that he had received numerous abusive letters since he denounced the Townsend Plan. He could see no connection between this letter and the Black Legion.

Most of the contents of the letter mailed from Benton Harbor were unprintable, and the same applied to the letter from Illinois. The Benton Harbor letter spoke of a recent meeting at which Hoffman had been "condemned as a traitor and not fit to represent a dog house."

New evidence that the Black Legion is no new organization in Michigan was indicated by a statement from Rep. George A. Dondero, of Royal Oak, who represents the Seventeenth District. Dondero said that in 1932 and again in the 1934 elections it had been intimated that he could win easily if he would join the "Bullet Club." He said the invitations were always extended in a "kidding way," and that he did not think much about them until the disclosures following the Poole murder.

As far as could be learned today, no other Michigan Congressman has been threatened or asked to join the legion.



McCrea said he was seeking to learn the size of the auxiliary and whether members are required to vote as instructed by their superiors as is the case, he said with the Black Legion.

V. F. Effinger, whom McCrea has sought for questioning, asserted in Lima, O., today that the Black Legion has more than 6,000,000 members, and that "it will go right ahead promoting the best interests of America and American citizens, despite the unfortunate affair in Detroit."

Investigators here received without immediate comment a report from Columbus, O., that a witness before a legislative committee had testified that he was a member of the Black Legion and that a great many of its members had been placed as foremen on work (FERA) in Lima, O.

The witness, George Armstrong, of Lima, was quoted as saying members of the Black Legion got most of the jobs on relief work.

Father Charles E. Coughlin's original Shrine of the Little Flower on March 17, was on the list of unexplained fires, his investigators are checking for a possible connection with Black Legion terrorism.

### Many Angles To Probe

That is just one of a number of angles of our investigation," McCrea said. "Royal Oak (the site of the Shrine) is out of our jurisdiction, but if we uncover any new evidence it will be turned over to authorities there."

There were rumors in Royal Oak that investigation of the explosion of a black powder bomb in the basement of Father Coughlin's home several years ago also would be reopened.

Father Coughlin said he had heard nothing of renewed investigation of the Shrine fire or the bombing and declined to discuss any possible connection between them and Black Legion activities.

Effinger, who appealed to the prosecutor in Adrian, Mich., last summer for the release of three men arrested with weapons and black robes bearing the Black Legion's skull and cross bone insignia, said he knew nothing about the killing in Detroit or elsewhere by the Black Legion, and declared the organization deplors anything of that nature.

The questioning of Lupp followed discovery in Ernest's home of a letter signed "Art Lupp, B. G." In which Ernest was asked "how are you getting along with your ... If you're not, maybe

MEMORANDUM FOR THE ~~SECRETARY~~

Re: "Black Legion" matter.

I telephoned SAC Reinecke at the Detroit Office with reference to the publicity which has come out about the Federal authorities offering every cooperation in connection with the above matter in that vicinity. Mr. Reinecke said that this is absolutely all wrong; that he has not offered any cooperation to anyone in this situation. He said that he has been called by the papers on two or three occasions wanting to know if the Bureau was in on the case, to which he replied that since there are no facts to date indicating a Federal violation within the investigative jurisdiction of the Bureau, no investigation by the Bureau is being conducted. However, he said that the newspapers may have just put that in as a result of the identification by the Identification Division of the Bureau of the fingerprints of the murdered man. Mr. Reinecke said that the papers are trying to bring the Bureau into the investigation of this matter out there for news value, and, realizing this, he has very carefully handled every inquiry in order to make sure there would be no basis in fact or from innuendo which would indicate the Bureau is participating in the investigation. As a matter of fact, Mr. Reinecke said that the local authorities have not requested the assistance of the Detroit Office in this matter, and have not contacted that office either officially or unofficially about the case.

Mr. Reinecke said that so far as he can see at this time, there is not even a scintilla of evidence developed to date indicating a Federal violation of any kind. The victim of the murder, Poole, was found on the outskirts of the city, and the murderers were arrested in the city itself, thus eliminating the unlawful flight possibility. He said that from the newspapers, he understands a man died in Jackson, Michigan, some time ago and his wife is now claiming that shortly before his death, he was taken out and beaten by an organization such as the Black Legion, and that he died as a result of this beating. The death certificate shows his death to be from another cause. There is no Federal angle for consideration in this situation either. The victim was beaten on the outskirts of the city and the beaters apparently are still in the city itself. However, in the Jackson angle, Mr. Reinecke said the papers indicate a couple of prison guards were members of the organization, and that one of them has been suspended by reason of his membership.

Mr. Reinecke said that Poole, the instant victim, was found shot on the outskirts of Dearborn, Michigan. Through the identification of his

fingerprints by the Identification Division of the Bureau, it was found that he was originally from down in Kentucky. A check among his friends and acquaintances by the police out there resulted in several arrests, and the police obtained confessions from five or six who stated that they were members of this Black Legion. These people admitted, according to the papers, that they killed Poole for the reason that they had received a complaint at one of their meetings that Poole was mistreating his wife. This was the starting point of uncovering this Black Legion, a group of men who organized to promote Protestantism and Anti-Communism, etc. There were found among the personal effects of the men arrested some black robes which had been used by them. While there are claims running around to the effect that the organization is national in scope and has officers like the Army, Mr. Reinecke has no idea and has no way of knowing the extent or number of members of this organization.

Mr. Reinecke said that the people who are in custody and who have admitted killing Poole are people who have migrated into Michigan from Tennessee and Kentucky — George W. Barrett type. He said that they are just a bunch of low-type hill billies who have come out of the mountains of Kentucky and Tennessee and have obtained employment in the industrial enterprises in the vicinity of Dearborn, and it is easy to see how they would kill with impunity just on the violation of a woman.

Mr. Reinecke is doing absolutely nothing on this matter and will not do anything unless specifically advised by the Bureau.

Dr. [redacted] of the Ku Klux Klan, who resides at Atlanta, Georgia, called at this office about Noon today, after having been referred to this office by United States Attorney Lawrence S. Camp.

[redacted] when he arrived at the office, indicated he might have some information which would be of value to the Government in the investigation of the Black Legion. I informed [redacted] in keeping with instructions previously received from Mr. Tamm of the Bureau, that this Bureau did not have under investigation the Black Legion and was receiving no information regarding the activities of that organization. I informed him that in the event he had any information which he desired to furnish to interested officials, it would be proper for him to direct his information to the Detroit, Michigan local authorities.

[redacted] stated that his information was in the nature of theories developed as the result of his knowledge of secret organizations and organizers of such associations. He stated he had called at the office to advise that the Ku Klux Klan is ready and willing to aid the Government to its fullest extent in any investigation which may be conducted. He stated this Bureau should feel perfectly free to examine the books of his organization or interview any of the officials of that organization at any time.

He advised that inasmuch as the Federal Government itself was not interested in the Black Legion, he [redacted] would carry the matter no further. [redacted] requested that no publicity be given his visit at this office and his offer of cooperation.

On the evening of May 27, 1936, William Diedrich, Chief of Detectives of the South Bend Police Department telephoned Agent Jones at the latter's residence and stated that a man was in his office and wanted to speak to a Bureau Agent relative to the "Black Legion" activities in this section. The chief requested that Agent Jones go to the Police Station and talk with the above individual. Agent Jones diplomatically declined the invitation and advised Chief Diedrich that Agent had no authority to check into the matter or to talk to anyone concerning the same; that such an investigation must be first ordered by headquarters; that it was thought advisable not even to go to the police station and discuss the matter because of the dangers of false newspaper publicity. Accordingly, Agent Jones did not go to the police station and did not discuss the matter with anyone.

On the morning of May 28, 1936 while at the Police Department on other matters, Chief Diedrich called Agent Jones' attention to an article in the Chicago Herald and Examiner (Indiana Section) dated May 28, 1936, which article was purportedly written at South Bend, Indiana and was to the effect that a "Starke County man had discussed the Black Legion activities with a Department of Justice representative at South Bend." This information is false in every respect. Chief Diedrich explained that newspaper reporters were present after he, the Chief, discussed instant matter with the "Starke County man";



that he, Chief Diedrich, said nothing to them about telephoning Agent Jones and specifically requested the reporters not to even mention the fact that a Starke County Man had called at the Police Department to give information on Black Legion activities; that in spite of his, the Chief's, request, the attached article appeared in the Chicago paper.

Agent Jones is aware of none of the information offered by the Starke County individual and knows nothing of instant matter except that set out above and that which appeared in the attached newspaper clipping. Agent Jones examined both South Bend newspapers on May 28, 1936 for similar articles but apparently none appeared therein.

## FEARFUL 'LEGION' RECRUIT TALKS

*Starke County Member's  
Story Laid Before G-Man*

SOUTH BEND, May 27.—Information pertaining to the spread in northern Indiana of the notorious Black Legion, whose criminal activities in Michigan resulted in a nationwide investigation, was laid before a representative of the Department of Justice here today.

The information was volunteered to Assistant Chief of Police William Diedrich by a business man of Starke County.

The informant was said to be a member of the black legion who did not realize its criminal proclivities and fears now to renounce his membership.

An amazingly large membership in the legion in northern counties of the state is said to exist.

Alexander Campbell, assistant United States district attorney, stationed here, said this afternoon that nothing pertaining to the Black Legion's activities had been brought to his attention. Prose-

cutor George L. Rullison of St. Joseph County and his Mishawaka deputy, Paul S. Bryant, made similar statements.

However, it was reported that a branch of the United Brethren of America, said to be connected with the legion, is active in Mishawaka, where its members meet secretly in private homes. The United Brethren of America is not the official title of the Black Legion but the latter organization uses that title in some of its literature.

Chief of Police James L. Guy of Mishawaka said that the Mishawaka organization is apparently peaceful. It was reported active politically about two years ago.

One of the strange features of the Black Legion organization in Indiana, Diedrich was told, is that it is now, at least, not requiring payment of dues from its recruits. It is believed this has induced many men, unaware of the organization's true purpose of hate, to join.

**Cult's Armed 'Jury' Sits  
on Crescent Throne;  
Threatens Two  
With Death**

HAMMOND, May 27.

proximately 250 members of the Black Legion in Hammond were scheduled to meet at midnight, it was learned, to decide whether the unit should be disbanded in the face of developments in Detroit.

It was learned authoritatively that the Hammond branch has been in existence since last September. The local clan met for a while in a downtown club room and later in an office building.

FORT WAYNE, May 27.—Kidnaping of a former township official and his chief deputy were revealed tonight by Sheriff George W. Gillie as authorities pushed their investigation into the activities of the Mystic Order of Black Snakes, hooded cult, which the sheriff believes is an agency of the Black Legion.

The sheriff did not reveal the names of the cult victims, adding that he has no evidence tangible enough on which to issue warrants for arrest of the abductors.

The two officials, Gillie said, were strolling along Calhoun st. when four armed men ordered

Their hands tied behind their backs and blindfolded, the two were taken on a long, devious ride, finally being led into a circle of ominous, hooded figures, the sheriff said.

#### ADDRESSED BY LEADER.

According to the story told the sheriff by the two officials, twelve hooded men with pistols sat upon a crescent throne, surrounded by a silent circle of figures clad in black, unrevealing robes.

The hooded leader of the cult, the victims told the sheriff, then addressed them, stating that the cult had obtained information that the officials were contemplating the discharge of two of its members, who were in the township officials' employ.

Should they carry out their plans, the hooded figure warned, the officials would again be kidnaped and beaten with a vicious blacksnake whip—which lay on the ground before them.

The leader added that "worse consequences" might follow. This the two victims interpreted as a threat of death.

#### WPA WORKER'S STORY.

The township officials and his deputy then were taken back to the spot where they had been abducted and released.

A Works Progress Administration worker today also told the sheriff how he had been duped into becoming a member of the cult, but that he had never attended a meeting. He said that coworkers had recently advised him to attend meetings regularly "or suffer the consequences."



Dear Sir:

I do not know whether or not the Federal bureau of Investigation will interest itself in the purported investigation of the secret society, known as the "Black Legion", but the fact that I am an applicant for a position as Special Agent makes me vitally interested in the continued success of your organization, and I am writing now to give you what little information I have, about what I believe, might concern this so called secret society.

In order that I might acquire some experience as an investigator I applied for a position to Mr. F. N. Burns of the Burns Detective Agency here in Tulsa. I worked for him several Saturdays before he approached me on the subject of entering a secret society, which had for its purpose (according to Mr. Burns) things similar to the secret society already mentioned. Hoping that I might learn something of this society I kept an appointment, made for me, by Mr. Burns with two men in the Bliss Hotel. I spent an hour with them but obtained very little information. They wanted me to promote this society in Tulsa, but refused to tell me the name of it, or the names of its officers. I refused to join, and shortly after this, Mr. Burns asked me to return my identification card.

This is not being written with the intention to promote my own interest with your Bureau, neither is it because Mr. Burns asked for the return of my card. I would have written before this except for the fact that I did not think the Federal Bureau of Investigation would have jurisdiction, however it looks now as though it will have.

I sincerely hope that if the Federal Bureau of Investigation is interested in this investigation that I can be of some small help.

# Founder of Black Legion Is Just Plain 'Doctor Billy' to Bellaire Home Folks

**BELLAIRE, O.**—"General" Billy Shepard is a nervous, active little man with a jet black pompadour and squinting eyes.

To the 8,000 residents of this Ohio river town he is known as "Doctor Billy," and for 15 years he has been health commissioner of Bellaire at a salary of \$25 a month.

They know "Doctor Billy" as a joiner, a jovial drug store orator and a man who likes to be a bit mysterious at times, but, withal, a harmless fellow who can absorb a lot of kidding.

But William Shepard, commander-in-chief of the Black Legion in America, is a title which draws little more than mock solemnity or open guffaws from the sophisticated members of the Round Table Luncheon club, which meets regularly in the rear of Dankworth's drug store.

### Admits Founding Legion

Upon such a man are the eyes of the nation and many parts of the world centered today, for "Doc" Shepard has become an international figure as the founder and leader of the Black Legion.

He admits readily enough that he conceived the idea of the Black Legion when he was thrown out of the Ku Klux Klan 11 years ago because he formed his own "Black Guard" by coloring the white hoods of his followers with lamp black.

### Klan Was Jealous

"Grand Dragon James A. Colecott was jealous of the Black Guards' popularity," is the way Doctor Billy puts it. Colecott charged Shepard was trying to form a separate organization within the Klan.



## BLACK LEGION LINKED WITH FIFTY DEATHS

### Police Investigate Reports That 135,000 Night-Riders Be- long to Michigan Group

(Picture on Page 2.)

DETROIT, May 24.—(AP)—The roundup of "night riders" of the hooded Black Legion spread today as officials directed their inquiry to reports a membership totaling 135,000 in Michigan alone may be responsible for some fifty deaths.

In Detroit Prosecutor Duncan C. McCrea said murder warrants would be issued Monday for seven present at the "execution" of Charles A. Poole, young WPA worker. He declared the prosecution would include as many as may be identified of some fifty persons present at a Black Legion meeting which Poole was attending.

Ray Ernest, guard at the Southern Michigan prison, was held at Jackson for arraignment Monday on a charge of carrying concealed weapons, after he denied connection with the reported flogging of Paul Every, forty-two, also a prison guard, who died April 14 of what physicians pronounced heart disease and diabetes.

### CHECKING SUICIDES

State Police Capt. Ira H. Marmion, whose troopers have been investigating the secret vigilantes for months, said he was checking a report that fifty Michigan men had been marked for death, and that the Black Legion made its "exceptions" appear suicidal.

Harry Colburn, investigator for the Wayne County prosecutor's office, said he was informed the Black Legion's membership in the state grew in three years to 135,000, divided into five brigades of sixteen regiments each, that each member carried a pistol, and that the organization "is more dangerous than people think."

Claims in Black Legion literature seized by state police that it antedates the Ku-Klux Klan and that the Klan was an offshoot from it were ridiculed by investigators who said the claims were made to impress prospective members.

### KLAN DENIES CONNECTION

It takes an American professor to work out that theory.

The "Black Legion" of 100 per cent American patriots bent on establishing a better, brighter America by flogging and murdering, turns out to be an extensive organization. 

MEMORANDUM FOR THE DIRECTOR

Assistant Attorney General Jackson telephoned me and said this morning a lawyer friend of his in New York City telephoned and said that he had some information to offer relative to the above matter, and if the Federal Government is going to enter the case, he wanted to furnish it to us, but if only the State authorities were to investigate the case, he would want to furnish the information to them.

I advised Mr. Jackson that in the absence of any indication of a Federal violation in this matter, the Bureau is conducting no investigation whatsoever. Consequently, the Bureau would not be interested in the information which his friend in New York has to offer.
