Statement of, taken in the office of the Prosecuting Attorney
by Chief Investigator, Harry Colburn, August 6, 1936 at 10:45 a.
in the presence of Charley Spahr, Edna L. Barker, stenographer.

BY MR. COLBURN:

Q What is your address, Mr.

A Cincinnati, Ohio.

Q Mr. I am Harry Colburn, chief investigator for the
prosecuting attorney's office. This is Mr. Spahr, one of our
investigators and this is Miss Barker, a stenographer. I want
to ask you some questions relative to your offer of information
to this office in connection with the activities of the Black
Legion and one Virgil Effinger, its organizer at Lima, Ohio.
Would you care to tell me what you know about it and what
your experiences have been in this connection, starting from
the time you first met him, Mr. Effinger, just tell it in your
own way and in continuity, if you can?

A On July 6th of this year I wrote Virgil Effinger a letter
addressed to Lima, Ohio, asking among other things for information
relative to the organization known as the Black Legion
of which I understood at the time he was one of its heads and
in answer to that letter Mr. Effinger replied under date of July
10th to the effect that I should see him at his home, 1114 Harrison
Avenue, in Lima, relative to same. I didn't immediately
reply to the said letter and on July 16th I received a second
letter from the said Effinger again asking me to come to
Lima and have a personal interview with him in regard to the
Black Legion. On July 21st I went to Lima, Ohio on the Grey
Bus Lines under their ticket No. 93796 and arrived there at
12:30 the same afternoon. I immediately went to his home, Mr.
Effinger as above stated at 1114 Harrison Avenue and for the

first time made the personal acquaintance of the said Effinger. At this time I had a personal interview with him in regards to the Black Legion. Effinger informed me that before he could go into the affair in detail as I desired, that I would first have to become a member of the organization which I agreed to do and did so with him in his Ford V-8 to some miles past Elida, Ohio and was ushered into an old farmhouse at this place where they were holding some of their meetings, to join the organization and took the oath or obligation and was given a bullet, a symbol of membership in the while I was at this meeting place I asked if it was perfect safe, if there were any snoopers or spies that ever came around so at the solicitation of Effinger a fellow named Crawford whom I understand has a son-in-law on the Detroit Police Force brought forth a machine gun and told me that this was one of their main preventatives to keep snoopers and spies from approaching on their private property. After the obligation and on the way back to Lima a Chevrolet sedan bearing a Michigan license, it was a tan Chevrolet, passed and the car in which I was riding with Effinger, Effinger noticed the license right away, -I took the obligation about twelve o'clock, we stayed there until about one o'clock in the morning that would be the 22nd, - he said he was of the opinion that occupants of this car were there to kidnap him and take him back to Michigan authorities where the said authorities had passed a standard reward of a thousand dollars payable to any one that would get him into the State of Michigan. He flashed his headlights on and off three times and the car in front under license No. EJ 119 Ohio and the car in the rear immediately stopped to see what he wanted. He acquainted the occupants of these two cars with his suspicions and they immediately set out to overtake this car from Michigan and

so a short ways down the road and at the point of drawn guns and the display of badges these Black Legionnaires entered its occupants they were officers of the law looking for bandits in Michigan and was headed that way and they proceeded to search their personal baggage, rifle their pockets, go through their personal papers and after satisfying themselves that they were not from the Michigan Law Authorities they permitted them to proceed on their way. Later at Effinger's in Lima on this same day the question came up about killing their own members and I asked him if it would not be better if there had to be anybody gotten if it wouldn't be better get the real enemies fighting in opposition to the Black Legion principles. He then told me that line of talk was up his alley and then he showed me a square mechanism with metal tube affair and that he claimed was invented by workers at the United States Government poisonous gas factory at Edgewood, Maryland. It had a time clock arrangement which explained could be set for certain time such as a Jewish National celebration - one thing was it would have to be in the winter time when the windows of these Jewish synagogues would be all closed so that the gas could not escape, and he you can readily see that we can pretty well exterminate the Jews at one click, it will only take a few hundred loyal men this cause and a few of these machines to do this. He also showed me a typewritten list of what he said was their Jewish Synagogue in the United States and their location and mentioned the fact that these machines would only have to be used in centers where the Jewish people were largely congregated in order to be effective.

Q While you were talking to Effinger you told me that the subject of the Detroit situation came up and that Effinger told you they were out to get McCrea and that they were having affid

drawn up by members in Detroit who saw or were supposed to have seen Mr. McCrea take his obligation and that he also told you if it was the last thing he ever did he would not take Blankety Blank so and so, is that correct?

A Yes.

Q Now then you also said that he asked you to make out some sort of an affidavit, is that correct?

A That is correct.

Q Just what did he say to you in connection with the affidavit he wanted you to make out, did he say why it was so necessary?

A He said it was essential to produce in Court evidence to the effect that McCrea was a member of the Black Legion to dispute McCrea's statement that he was not a member and said that he needed some affidavits from men of my type that he considered would have weight and bearing in the courts to verify McCrea's membership in said organization. I asked him if it would be a sworn statement or just a signed statement, he said it would need to be sworn. I told him that brought up the matter of perjury of which I had a little knowledge and at this time I deferred ~~the~~ talking any further about this affidavit until our next closed meeting a week hence from this time.

Q ... a separate statement from the one which you
... this morning, I should like to ask you a few questions
... morning yourself and your own activities, do you care
to answer them?

A Well, if I see no reason why I shouldn't as long as it isn't
extremely objectionable as to being personal.

Q What is your profession Mr. ... or your means of earning
livelihood?

A Well, my profession and means of earning a livelihood has been
varied, I have been an organizer of things, of the Klu Klux
and other organizations, of a like nature. I have been in a
work as a Chair Store Manager; I have been in the apartment
house business in California.

Q What one, if any of these professions have you followed in
recent years or months?

A Apartment house business and management in California.

Q And what business are you engaged in at the present time
in Cincinnati?

A I am unemployed at the present time.

Q Where was your original home?

A I am a native of Atlanta, Georgia.

Q Are you married? A I am married.

Q Do you have children? A No children.

Q And your folks, that is to say your near relatives are all
at Atlanta?

A In Atlanta, Georgia.

Q What relatives do you have in Atlanta, Georgia?

A Mother, sisters, various nieces and nephews, my father is deceased.

Q Do you have any relatives in Los Angeles, California?

A No relatives in the state of California.

Q Was your purpose in communicating with Dr. Effinger on the Black Legion to gain resume your organization activities if the Black Legion met with your approval?

A It was, that was my purpose in contacting them.

Q Because of being unemployed at the present time you felt that you might resume organization activities and thereby make a living?

A That is right, at the same time be using my experience to advantage.

Q and your only purpose in exposing what you know of Dr. Effinger and the Black Legion and its activities was because you feel that it is an organization that is dangerous and has no place in the scheme of things in this country and that you want to do your share in helping to eliminate this outfit?

A It is, that is my entire purpose. I would like to keep the record and file of the present members and those that might be members of the Black Legion in being led into what I believe serious personal trouble by being led by men like I am convinced this said Virgil Effinger is and while he will protect himself no doubt, he will cause other men that would be good citizens otherwise to get into serious personal trouble and if, by staying in this immediate territory I can further be of benefit to the proper exposure of this organization, I will be glad to do so.

Q Do you have any fear of any uprisings on the part of any members?

A Not if I keep out of their back yards, away from where some radicals or irresponsible people might feel the desire of the leaders or expose their little un-American playhouse.

Q Now, you said that he, that ...
time-clock machine which was to be used for the expulsion of poison
was developed in the United States Government Factory at Edgewood,
A Edgewood, Maryland.

Q And that was developed by government employees?

A Yes.

Q Did he say whether or not those government employees who had developed
this apparatus were members of the Black Legion?

A No, he said that those inventors of this peculiar type of machine to
exterminate the Jews was developed by employees of the government at
Edgewood Poison gas factory by members of another organization who
some way co-related to the Black Legion, it was a superior organization
that the certain members of the Black Legion was picked after they
done certain deeds to prove themselves worthy and was transferred to
higher type organization, that's what he told me.

Q Did he mention the name of this other organization?

A No, I asked him for it, he said he would give me that at a later date.

Q Then he made you understand that even though they were members of a
different type, or higher type of organization, that that organization
was a ~~higher~~ part of subsidiary of the Black Legion?

A I took it that he meant that it was a more or less parent and superior
organization and that the Black Legion itself was a subsidiary of that
organization.

Q Did he profess to have control over those particular members in the
United States government factory?

A Through the executive offices in the other organization, I presume
Effinger himself, from what he told me, is a member of this superior
organization, radical organization.

Q Did he tell you anything about their going to influence the world whether they were in a position to produce in any of the ways he mentioned all over the country?

A Yes, he said that even today he predicted he would see a considerable amount of also a kind of the Jewish type would be... had the compilation of the... largely... take to enter into a large number of... about a million in one shot, a million Jews in one shot, these would supposed to be placed simultaneously in the different... Did he have any particular reference as to any of the... many Jews...?

A Yes, he did, he said that they were the real serious danger, so far in this country, that the present president and his administration being subverted by his Jewish advisors and several Jewish groups, like Longmuthau, and Sam Dickstein and Sam... or Jew or something in this state.

Q This state?
A Or Ohio maybe. Congressman Dolowitz, Samuel Dickstein, Sam... New York, Dolowitz as being one of these... and Frances Perkins was a Russian Jew, the... name, she was working with Dickstein, they... Jewish element was a real serious element against the... ideals of what he termed real Americanism, when they... exterminated that would automatically lessen the power of the... that the Jews were trying to give the Negro equal social and... equality, that we had women and men were freely associating in the... York nightclubs nightly, and he went on to say that the Jews in this country, that there was a certain number, let's see, about 8,000,000 soldiers killed in the world war and he named out of that 8,000,000 infinitesimal percentage that were Jews, that the Jews were... that out of the millionaires, made -- ~~most~~ millionaires were Jews, cause a war, the European world war, they had no nationality, they Americans, weren't Frenchmen, were internationally... and a...

... to submit the gentiles through the international conference held in ... , Mr. Dr. ... and a number of other prominent ... , ... there, he showed me an oath purported to be taken by these Jewish leaders to eventually subvert the gentile identity and he had this Black swilling oath and he claimed the Jews in that organization took it, he also gave me a little booklet, a booklet of a purported oath that the Catholics, Knights of Columbus take to protect the American political arena -- situation.

Did he have any particular plan of action as against the Catholics?

Yes, well, he didn't but a fellow riding in the V-8, Effinger's V-8 ... and Effinger, who suggested that this winter when the ... at Detroit quoted down that it was his suggestion that each Black Legionnaire kill at least two Negroes in some month this winter he said, he sat there and told me, he said, yes, that will be fine and I understand the population of the Negroes is ten per cent, Negro and I said will it be generally effective to do that and he said if Black Legion man will do it you will find it will be a big thing, of course, he's a farmer, illiterate type, but it was my impression that Effinger's main fight right now, he expects to use the Black Legion fighting his is against the Jews, that they are really the root of a lot of our American evils.

What about the Catholic situation as far as he was concerned?

He mentioned the Catholics in regard to the political situation, both predominated within our present administration by Catholics, through Jim Farley and his cohorts of Catholics, said that they are officeholders Catholics, Negroes and Jews were greater under this present administration than they were under Hoover's administration and he called my attention to the fact that I was from the south and was, no doubt, a Democrat and the oath of obligation they ask you if you are willing to vote for a political party that they deem more in sympathy with Black Legion principles, that is in the one I took, they asked me if I was willing to take part in the lynching, I told them I might be in certain cases where it involved the virtue of a womanhood, or on very serious like charge

The fellow that gave me that part of the oath, he asked Effinger soon about it, he said that's not definite enough, Effinger said, yes, it covers it, he answered it sufficiently if under certain circumstances will take part in the lynching. Went on to say that the conditions in this country, in the United States, that they would eventually lead to similar conditions in other foreign countries, he named Egypt the ancient times there were 100% Caucasian -- white, until they got to importing the black slaves for the white people until they got to affiliating with them on sexual and social basis and brought about the present conditions of Egypt. This country is getting to be just as hospitals all over the country white women giving birth to mulattoes all over this country, that he had evidence to that effect.

Q Did he say anything to you about some trouble that they anticipated in Cleveland, Ohio?

A He did.

Q Similar to that trouble which they were having in Detroit?

A He did.

Q What did he say about that?

A That started when I asked Effinger why the Legion members didn't burn or horsewhip the real -- what was considered the real enemies of the Legion instead of gentiles and his own members and he answered that of the hardheaded men in charge of local organization, such as Harvey Davis in Detroit, permitted those conditions and also he was expecting the same, he had a man in charge at Cleveland who had also permitted similar conditions as those in Detroit, was expecting sooner or later that to be uncovered and would prove very embarrassing to the Black Legion organization. I inferred from his statement in this regard that the Black Legion had murdered and horsewhipped some of its members and some citizens in and around Cleveland just as they were accused of doing in Detroit.

Q Did Mr. Effinger tell you about any other law enforcement officials in Detroit, or vicinity, that they intended to get even with in addition to Mr. McCrea?

A No, he didn't say any other official, he mentioned the fact that Dayt

Dean was crazy, it would be proven so and would be sent to the asylum soon after being sent there that he would be murdered for his exposure of Black Legion activities in Detroit. I told Mr. Sprue that a few days ago, I thought of it in the other room. Said Clayton Dean's life would be worth a Chinese pony, just as soon as this thing blew over, and was confined and convicted, that his life would be worth a Chinese pony, that they would certainly get him.

Q. What was the original purpose of ~~his~~^{your} communication with Mr. Liffinger regard to the Black Legion?

A. My sole and only purpose for communicating with Mr. Liffinger in regard to the Black Legion was to ascertain whether or not it was a really worthy American organization that would yield permanent good to America's institutions and traditions. I thought it possible that some individual Legion members had gotten out of hand and violated their obligation of membership and order and was acting contrary to its law and its officials' teaching and if such traditions and ideals of the had been thoroughly American, it was my desire to extend its activities anywhere that I might but after a thorough investigation and having initiated into its secrets and real intentions, the future motives, became ~~more~~ thoroughly convinced that I wanted to have nothing to do with it whatsoever.

Q. Did Mr. Liffinger explain to you the real purpose and the ultimate of this order called the Black Legion?

A. Yes, he said that it was the idea back of the Black Legion to re-assert real American traditions as intended by our founding forefathers which had been trampled upon by these various alleged enemies as heretofore mentioned.

Q. Did he discuss any plans with you whereby when their organization was in a proper manner that they planned eventually to take over the government?

A. He told me that it would be according to his idea, it would be an object matter to establish a Fascist or Nazist dictatorship, he mentioned the fact that Mussolini had only about one hundred thousand members who seized the government of Italy and that the present government of Italy

under Adolph Hitler was started with two men and that by having more strategic situations in this country and by seizing strategic points he named to me, it would be a very easy matter to establish the said dictatorship and also inferred that he would be wearing the crown of dictatorship and his shoes when this did eventually take place. He inferred after he had seized the American government and become its dictator that he would have to have men under him capable of retaining this said title for him -- position, and that I would be well taken of in this and he said it was men just like you, Mr. that what it's all about and are not afraid to act when the time comes, that we need with us in this move:

Q Did he describe to you the manner in which they hoped to take over strategic points and control of the government when the right time

A Yes, it was his idea to have sufficient affiliations with various plants and the army and navy and such like necessary subsidiaries and strong-arm forces in order to do this.

Q Well, when he explained to you that the cause for the trouble in Lima and the possibility of trouble in Cleveland was the responsibility of the few men in the organization who were allowing things to get beyond their control and then in the next breath talked about these plans of killing people of various denominations and creeds, didn't it seem like blowing hot and cold on his part?

A It did, and I mentioned the fact to him and he explained it that the ~~man~~ through and that this happening at Detroit would be proved to be a big boomerang for them and from that point on they were going to see that these things were not permitted to happen again, the rank and file were not going to be permitted to know the real motives and activities back of the Black Legion, that was going to be a good lesson to them. He found out you couldn't trust too many men with the actual knowledge of what was taking place.

Q Well, now, you say that you took your oath on the date mentioned in your statement in a little town not from Lima?

A Out from Elida.

Q After returning from Elida and, by the way, that was the trip upon which your car was stopped, wasn't it? -0-

A Yes.

Q Where did you go from that place? To Effinger's house?

~~XXXXXXXXXXXXXXXXXXXX~~

A We went from there to a little restaurant on the square of Lima, on the "Spot" which proved to be in reality a Spot where many of the Black Legionnaires get together, we had sandwiches and soft drinks from there we went to 1114 Harrison Avenue, at Lima. Mr. -- the name Mr. Effinger, and upon our arrival there we went into the basement of the house where Effinger maintains his office, has his desk, he goes to reading a, some sort, "I don't know what you call it, something "God Give Us Men" thing he has framed there, also referred me to a picture on one side of his desk, showing Paul Revere alarming his early and fellow -- fellow Americans -- of the impending danger and said that there was an organization in this country called the Paul Revere, that I should get some information about, they had the real American principles, I was sure I would believe in and want to know more about. It took me from this statement that he was also affiliated with said organization as a member or otherwise.

Q Was there any discussion as to what your activities in the organization might be?

A Yes, it was plainly understood that I was to be in charge of a given territory, embracing the city of Cincinnati, Louisville, Kentucky, Indianapolis, Indiana and other cities and towns and that I would be organizer ~~and~~ control said territory with only himself to account. That he would see that I got every assistance and a sufficient monetary return to enable me to live on a nice plane, not have to worry about my finances.

Q Did he at any time disclose to you the territory in which the Black Legion was operating at the present time?

A ~~MR~~ I asked him as to their numerical strength and he answered by saying it was in many states, in some states under names other than the Black Legion, but he did not definitely give me any numbers as to numbers or actual territory in which they operated but led me to believe that their organization and affiliated ~~organizations~~ they went -- di

this time, or intended in the near future, to extend over not only entire territory of the United States but also have dealings with governments and organizations that were thoroughly friendly to the Black Legion and its kindred organizations.

Q What interest did he explain, would any foreign countries have in the principles of the Black Legion, which apparently were concerned only with Americans?

A Well, Hoffinger plainly told me that he admired Hitler and his German Nazi government, due to the fact that he had done a wonderful job curbing the activities of the Jews and also mentioned the fact that dictator Mussolini had won his high estimation by taking over Ethiopia, Abyssinia, and instituting Jim Crow laws, segregation laws, and laws favoring the white and colored races and the discipline which he did, he told me Mussolini was establishing these Jim Crow laws.

Q Did he make mention/any time of a man by the name of Dr. William Joseph

A I asked Mr. Hoffinger if Dr. Shephard, as had been reported in the press the real leader of the organization and he answered by saying they are now talking with as much of the real leader of the Black Legion organization as it would be possible for you to talk to.

Q Did he say at any time that Dr. William Shephard was connected with the Black Legion?

A He did not.

Q Now/ did he affirm it?

A No/ he did not.

Q Did he have any further conversation with you concerning Dr. Shephard?

A He did not.

Q So that from what Hoffinger told you, you had every reason to believe that he was the absolute head of the order?

A I gained from Hoffinger's statement that he and other men in different localities were in complete charge of the Black Legion. I would say that I consider from his statement that it's composed and ruled more or less by what I would term a Board of Directors. Several men that get together and agree on policy, routine, and split the spoils and control its activities.

Q Did he -- strike that -- during his discussion with you, relating the Detroit situation, did he say anything about what their plans were, then to get Mr. McGowan to beat these charges that are being made against the local members?

A Well, I've got to understand that little better, is --

Q Did he discuss -- cross that out -- you say that Mr. Effinger told about his plans to get Mr. McGowan?

A Yes.

Q Now, did Mr. Effinger disclose to you any other plans they had in mind for the defense, or ultimate acquittal of the men now charged in the Legion activities in Detroit?

A Mr. Effinger told me it was his idea that Dayton Dean and Colonel H. Davis of the Black Legion, were expected to be convicted of the charges charged against them and he did not believe that any of the other others accused would be convicted. Michigan -- it being a non-capital punishment, did not have a capital punishment law, and they they would, could not be hung or electrocuted and that when, that Dayton it was his idea that Dayton Dean would be proved insane and would be committed to an insane asylum, after which that he would be killed loyal and devoted to the Black Legion for his exposing the conditions in Detroit in reference to this case.

Q Now, getting back to this timeclock mechanism, for the expulsion of gas, just where did you see that apparatus and, if possible, can you describe the mechanism and the approximate size of the device?

A I saw this device in Effinger's office, in the basement of his home, in the early morning hours, as previously mentioned, and would say from recalling faculties of my memory, that the said apparatus would be approximately about a foot and I would say it would be, let's see, it was a little taller than it was wide, not a great deal, it was approximately, I would say ten -- wait a minute, it will be more than that (indicating length of Stenographer's notepad) how much is that?

Q That's about nine inches.

A All right, I would say about eight inches wide and about ten inches height and was possessed of an apparently regular clock-like apparatus

that when, set at a certain hour and put into operation, would cause expulsion of the ingredients, which was to be held in a timing-arrangement adjoining the clock arrangement.

Q Was there an opening in this container?

A There was one metal arrangement that chaped up, it grew larger, it was larger at the top, it came up, let me get this thing here little bit better, it was a metal tube or a pipe that led into this gas chamber the box that led into a funnel-shaped like arrangement at the top of the prosian, and he explained to me that the gas was to escape through the arrangement when set off by the timeclock arrangement.

Q Did he explain to you what type of gas would be used in this apparatus?

A He mentioned that a mustard gas composition had been perfected and he to be perfectly conversant on the matter of the latest wrinkles of poisonous gases.

Q What did he say the action of this gas would be if released from this mechanism in a closed room or building?

A He said it would spread over the closed area immediately and would exterminate anything, immediately exterminate anything within this enclosed area.

Q Did he say how long a period of time it would take for this extermination?

A Nothing other than it would be instantaneous -- immediate in its action.

Q Did he discuss ways and means of planting these mechanisms?

A Well, he mentioned that one man could deposit this mechanism under the seat or porch and make an exit before the timeclock arrangement would function and would be well out of the way of its poisonous effects himself. It would only take a very small space and could be carried into a place with very little or any notice.

Q Now, after you learned of Mr. Effinger's plans, and had taken your oath and saw some of the workings of the Black Legion, did you decide to conclude your arrangement with Mr. Effinger as to the taking over of the territory that he offered you?

A Did I decide to conclude the arrangement?

Q After that started, did you decide to go through

A I decided to give no further contribution whatsoever to that or any other said organization.

Q And for the reasons, may I ask?

A Because I've followed it internally for years and I've observed its policy standpoint, its association with the KKK, I have considered carefully a number of the KKK precepts of its organization, of their ideals and policies and while I cannot say that I have ever been in the KKK, I lifted my eyes to the stars and was very sincerely thankful that I wasn't. I hope to discriminate alive after seeing these people's terrible experiences of those that I consider irresponsible.

Q Now did you attempt to contact the FBI at that office, was your name given anyone in this office for the information which you have given?

A I was not, I took it upon my own initiative to want to participate with the proper legal authorities to make these criminal wrongs that have and ~~infringe~~ that are now and that will be in the future to doubt whenever it permitted to continue and you, I, therefore, went together to Mr. Hanson G. Jackson, Major County Prosecutor, to advise and notify him that I had certain information, which I thought persons of conviction with the FBI and the other agencies that I thought it was important for him to know.

Q As a result of your having come this office, was your name given to anyone in this office, and what information was given to them?

A Yes, I was.

Q Were any promises made to you, or any other, regarding your name being given for your information?

A None whatsoever, other than the return of my actual expenses incurred upon making this said trip.

Q So that the information that you have given me is being entirely voluntary on your part in a desire to assist the legal authorities in dealing with this situation which you consider dangerous?

A It has been thoroughly voluntary.

Q Is there anything further that you wish to add to this case, sir?

A Nothing, that I can think of this time, or in future, other than to state that I am a citizen of the United States and I am a member of the KKK.



MEMORANDUM FOR THE ATTORNEY GENERAL

I am attaching hereto a photostatic copy of three statements in question and answer form purporting to have been made by [redacted] on August 6, 1936 to Harry Colburn, investigator for County Prosecuting Attorney McCrea of Detroit, Michigan. It will be observed from these statements that [redacted] alleges he entered the Black Legion and ascertained from one Virgil Effinger of Lima, Ohio that Effinger claims to have in his possession an infernal machine developed and perfected by employees of the United States Arsenal at Edgewood, Maryland. It will be further noted from [redacted] statements that Effinger claims the persons who perfected this instrument are members of some super-branch of the Black Legion evidently engaged in the Government's service.

The above statements were furnished to the Agent in Charge of the Bureau's Detroit Office by Harry Colburn, investigator for County Prosecuting Attorney McCrea of Detroit, Michigan, who requested that this Bureau initiate investigation in this matter because of the allegations that the gas bomb mentioned in the statements, was made by employees of the United States Arsenal at Edgewood, Maryland, and of the further mention of the plotted overthrow of the Federal Government by force and violence.

It is respectfully requested that you advise me what, if any, action you desire taken in this matter. I suggest that you may desire to refer copies of these statements to the War Department for appropriate attention and consideration by that agency.





Reference is made to Bureau letter dated May 29, 1936, which letter states it is desired that absolutely no investigation be conducted into the activities of the Black Legion in the absence of specific authorization from the Director of the Bureau and that if information is furnished to this office which is believed or alleged to constitute a violation of a federal statute within the Bureau's jurisdiction, no action should be taken thereon by this office other than to refer the facts immediately to the Bureau for transmittal to the Department for appropriate consideration.

On August 17th, 1936, Mr. H. C. Heiss, 906 Keith Building, Cleveland, Ohio, attorney for the Brotherhood of Locomotive Firemen and Enginemen, came to this office and exhibited two letters which were received through the regular mail on August 15th by Albert Phillips, General Secretary and Treasurer for said Brotherhood; and Dr. Z. T. Wirtschafter, physician for this Brotherhood.

These letters, which are practically identical, are typewritten apparently by an amateur with no handwriting appearing thereon. They were both mailed at 5 p. m., August 14th at South Bend, Indiana, and directed to the above-mentioned persons at 418 Keith Building, Cleveland, Ohio.

The letter to Mr. Phillips reads as follows:

"Mr, Albert Phillips we demand that you arrange at once to have Alba E. Kelley T. B. allowance restored to him at once. And restore it from March 1936. If you dont we are going to take you for a ride ,and you may never return."

Kelley mentioned in the letters is a member of the Brotherhood and gives his address as Box 251, Monon, Indiana, which address is that of a funeral home, and that Kelley supposedly owns this house and reserves a room there for himself. Kelley is a former railroad worker and has at different periods received a sick benefit from the afore-mentioned Brotherhood at the rate of fifty dollars per month because of tubercular trouble, but this benefit was cut off by the Brotherhood as of March 1st, 1936.

In view of the fact that these two letters are signed Black Legion and because of the instructions received from the Bureau, as set forth in the first paragraph of this letter, it is respectfully requested that this office be advised by wire or teletype whether or not these apparent extortion cases should be investigated.


Acknowledging receipt of your letter dated August 29, 1936, I must advise you that there is no information contained therein indicating a violation over which this Bureau has jurisdiction.

For your information, I would like to call to your attention at least six federal laws which make it mandatory upon the Department of Justice to go after the Black Legion. These laws prohibit (1) night riding; (2) kidnapping persons from one state to another; (3) threaten communication between states; (4) moving from one state to another to avoid prosecution for a felony or to avoid giving testimony; (5) interference with Federal Relief Administration (6) fraudulently obtaining federal aid given to rifle clubs.

I sincerely protest the evasion by the Department of Justice of its responsibility to investigate and prosecute the Black Legion.

John A. Moritz, Chief Investigator, Attorney General's Department, Lansing, Michigan, called at this office at which time the following interview was had with Special Agent James D. Cunningham.

Mr. Moritz stated that he had been at Lima, Ohio, attempting to remove Virgil Effinger, leader of the Black Legion, to Detroit, Michigan, for trial. Mr. Moritz advised that there are warrants in the State of Michigan for this man for carrying explosives and criminal syndicalism.

Continuing, Mr. Moritz stated that after much effort the extradition papers had been signed by the Governor of Ohio and warrants issued directing Effinger's removal to the State of Michigan. These warrants were turned over to Sheriff R. Marshall, Allen County, Lima Ohio, for service. Mr. Moritz further advised that the Sheriff's Office and Police Department at Lima, Ohio, had refused to cooperate in this regard and although Effinger is readily available at that point, they will not serve the warrant or cause his removal to the State of Michigan. Mr. Moritz stated further that he feels that if an attempt were made to remove Effinger it would result in bloodshed as Lima, Ohio, apparently is the center of the Black Legion activities and armed resistance would be given to any attempt to remove this man.

Mr. Moritz was interested in ascertaining whether there was any Federal Statute under which the Federal Bureau of Investigation could assist his office in removing Subject to the State of Michigan for trial. He stated that he heard of a recently enacted Statute that would probably cover this situation.

Mr. Moritz was advised by Agent Cunningham that the Statute he had in mind in all probability was the Interstate Flight to Avoid Prosecution Statute and it was explained to him that this Statute


only covers subjects fleeing the state of prosecution to avoid prosecution for certain specified felonies which were enumerated to him. It was further pointed out to him that the charges now pending in Detroit do not come within the specified felonies and further that apparently Effinger had not fled from Michigan to avoid prosecution as he is a resident of Ohio.

Mr. Moritz appeared satisfied with this explanation and stated that if he secured any additional information that made it appear that a Federal Statute was violated, he would communicate with this office.

Speaking generally, Mr. Moritz stated that he had information that the Black Legion had contemplated an armed rebellion on September 16, 1936, and that it appeared to him that this alone would be sufficient for the Government to take action. He was advised that this matter had already been referred to the Attorney General of the United States by Prosecutor Duncan McCrea of Wayne County, Michigan, and the Honorable Mr. Cummings had stated that, in his opinion, the facts disclosed at that time did not constitute a Federal violation.

As previously instructed by the Bureau, this office will not take any action in this regard without prior instructions from the Bureau.

In accordance with your instructions I communicated with Special Agent in Charge Newman at St. Louis on September 5, 1936 and made inquiry as to what his office was doing in this matter. Mr. Newman stated that he had not done anything other than that which is disclosed by his teletype above referred to, that is, he made inquiry of the Detroit office whether this matter was within the jurisdiction of the Bureau.

He stated that Sergeant Charles Meehan of the Detroit Police Department who had been in St. Louis and requested the cooperation of the Bureau in this matter had returned to Detroit, but that his partner was still in St. Louis. Mr. Newman was instructed not to conduct any investigation in this matter without specific Bureau authority.

I communicated by telephone with Special Agent J. D. Cunningham of the Detroit office in the absence of Agent in Charge Reinecke and he advised that Mr. John A. 

Dear Sir:

This will confirm the telephone conversation of September 5, 1936 between Mr. John Vincent of the Bureau and the writer concerning the request of the Detroit, Mich. Police Department for the assistance of this Bureau in securing the removal from St. Louis to Detroit of Clarence Prince, an alleged member of the Black Legion, for whom the Detroit Police hold a warrant charging assault with a dangerous weapon.

As Mr. Vincent was advised, this office has taken no action whatever in this matter and in conformity with the Bureau's instructions no future action will be taken.

For the information of the Bureau and the Detroit office, this is to advise that on September 1, 1936 Chief of Detectives John J. Carroll, St. Louis Police Dept., contacted this office advising that assistance was desired by officers of the Detroit Police Dept. in removing from St. Louis to Detroit Clarence Prince, who was wanted in Detroit for assault with a dangerous weapon.

At the St. Louis Police Dept., Special Agent H. G. Wiltse of this office was introduced to Detective Sergt. Charles Meehan of the Detroit Police Dept., who accompanied Mr. Wiltse to the St. Louis Bureau office and informed Mr. Wiltse and the writer that indictment No. 18594 was returned by the Circuit Court of Wayne County, Mich. on August 24, 1936 against Clarence Prince, Henry Van Horn, Rudyard K. Wellman, Whitney Fleming and Roy Hepner, charging that these persons acting in concert on May 15, 1933 at Highland Park, Mich. assaulted George Washer with an iron bar, club, or other dangerous weapon, to-wit., a blackjack, with intent to inflict great bodily harm less than the crime of murder. Sergt. Meehan had in his possession a warrant for the arrest of Clarence Prince issued by the Circuit Court of Wayne County, Mich., on August 24, 1936, charging this offense.

Concerning the alleged activities of Prince and others, Sergt. Meehan advised that on or about June 1, 1936 Prince, along with a number of other persons, were arrested in Detroit for questioning in connection with the Poole murder which was allegedly committed by members of the Black Legion. At that time the police had no knowledge as to Prince, be-

ing involved in the Black Legion crimes and at about 4:00 A. M. the day following his arrest he was allowed to go home, having first been instructed to return to the Police Department for questioning at 8:00 o'clock the same morning. Instead of returning Prince, upon going home, disposed of his furniture and other personal property and disappeared. Sergt. Meehan advised that after considerable investigation he had located Prince in St. Louis, Mo., through his brother who lives in East St. Louis, Illinois.

Sergt. Meehan advised that he is convinced that Prince is connected with several Black Legion murders and that he is guilty of the murder of James Delac in May, 1935 as the order to kill Belac must have been approved by Prince, who was a Lieutenant Colonel in the Black Legion organization.

Sergt. Meehan stated that the offense alleged in the indictment mentioned above is not the warrant upon which Prince will possibly be prosecuted, but that the Detroit Police Dept. is desirous of having him return to Detroit as it is believed he will be in a position to furnish valuable information concerning other crimes allegedly committed by the Black Legion. It is also Sergt. Meehan's belief that Prince can be convicted of murder in Detroit.

Sergt. Meehan stated that he had conversed with Prince since his arrest in St. Louis on August 31, 1936, but that he will not waive extradition and is unwilling to furnish any information of value. Sergt. Meehan requested the assistance of this office in securing authorization of Federal prosecution of Prince under the Unlawful Flight to Avoid Prosecution statute in order that he might be returned to Detroit inasmuch as the trial of some of the Black Legion members is now under way there and that Prince might prove a valuable witness to the State at this time.

Sergt. Meehan was advised that inasmuch as the substance of the offense for which Prince was indicted occurred before the enactment of the statute forbidding Unlawful Flight to Avoid Prosecution, Federal action in this regard could not be undertaken. Sergt. Meehan suggested that it might be possible for the U. S. Attorney at Detroit to institute some action against Prince which would permit his removal, and in view of this the teletype of September 1, 1936 was directed to the Detroit office. Immediately upon receipt of the Detroit telegram on September 1, 1936 Detective Lawrence Sheehy of the Detroit Police Department, who is working with Sergt. Meehan on this matter, was notified at the St. Louis Police Dept. that the U. S. Attorney at Detroit knew of no Federal law which would assist in the removal of Prince.
