It has been concluded that the Underwood typewriter #661828-14 was used to write the letters to Mr. Phillips and Doctor Wirtschafter submitted by the Cleveland field division in connection with the case, Black Legion; Night Riders; Bullet Club; Miscellaneous; Confidential, under cover letter dated November 27, 1936, Bureau file #61-7398. These specimens bear the serial #143 Q1 through Q4.

The extortion letters to Mr. Phillips and Doctor Wirtschafter submitted by the Cleveland field division in connection with the case of Unknown Subjects; Doctor E. T. Wirtschafter, Albert Phillips - Victims; Extortion, transmitted under cover letter dated June 5, 1937 were not written with this typewriter.

It is noted that in all of the letters in question the writer used the small letter "i" instead of "l" for the figure "1".

Mrs. [REDACTED] and [REDACTED] Minnesota, were referred to my office and neither could speak the English language very well.

I gathered from their conversation that Eli Babich, [REDACTED] had been killed on October 24, 1925, in the Guthrie Mines near Duluth, Minnesota and that they were both of the opinion he had been murdered by members of the "Black Legion" and that subsequent to 1924 one Amil Babich, who is not a relative of [REDACTED] had assumed the name of Eli Babich, who had been killed, and was presently a leader in the "Black Legion".

Both of these persons advised that they had never been threatened by members of the "Black Legion" in any manner but that they were afraid they would be threatened or even killed by these persons at some future date because of the fact that they had information the "Black Legion" had murdered Eli Babich.

I informed Mrs. [REDACTED] of the investigative jurisdiction of this Bureau and explained to her that the crime of murder was one within the jurisdiction of each individual state and that any information she had relative to a murder case should be given to the appropriate local authorities.

After learning that the Federal Government did not have jurisdiction over murder cases, Mrs. [REDACTED] advised that the "Black Legion" was planning on murdering President Roosevelt when he visited Minnesota in 1938 and that this Legion had sent a girl, whose last name is Madunich and who is a sister of a girl whose first name is Margaret and who works for the International Institute, Duluth, Minnesota, to Washington for the purpose of ascertaining inside information concerning the Government of the United States and to ascertain if President Roosevelt

For your information and any attention which you deem appropriate, I wish to advise that on August 13, 1937, Mrs. [redacted]


Duluth, Minnesota, called at this Bureau and advised that the "Black Legion" of Duluth, Minnesota, which is headed by one Eli Babich, is planning on murdering President Roosevelt upon his visit to Minnesota during the year 1938.

They also advised that a young girl whose last name is Madunich and who is a sister of a girl whose first name is Margaret and who is employed by the International Institute, Duluth, Minnesota, had been sent to Washington, D. C. by the "Black Legion" to ascertain the inside workings of the United States Government and to determine if President Roosevelt is planning on making a trip to Minnesota during the year 1938.

Neither of these persons had any definite information to offer as to where they had obtained the foregoing, although it was learned that Eli Babich, [redacted] had been killed in 1925 and that these persons believed he had been murdered by the "Black Legion".

know what was to happen ahead
for 15 years as did Cmila legion.

crying - he was able to cry because

for just thought of the things he
did. And he had to go to one
of the offices because the Legion sent
him. When he came back to Minnesota
he said he could buy an American
for a stick of gum. He received
all the money from the lodges insurance
which the men the Legion killed had. Joe
went from town to town in Yugoslavia
and found out the names of the
mothers and fathers the dead men
had and the United States will
send the ~~insurance~~ money money
from the banks the men had thru
the consul to which Joe sent the
names of mothers and fathers of the
men the Legion killed although Joe says
they did so he can get the money now I
don't think he got it yet. When the
United States sends the money watch for
the Bishop and you may catch him.
[REDACTED] says that men that you've
looked for and after heard that they're dead
are alive and they've got citizenship papers

registered at the United States Post office. This
is including only Serbian and Croations that
is just the ones my mother knew. I'm not
sure if it goes to the Post office but I think it
goes there.

laughing and saying to the other men that
they're alive in [REDACTED] place! They've got
their citizen papers and dead at the Federal
Bureau of Investigation. [REDACTED] says

Cross Is Burned at Sharonville

Negroes Warned to Stay Out of Sharon Woods.

A sign reading: "Negroes, beware! Stay in your place. Keep out of Sharon Woods. Danger ahead," and signed by the "Night Riders of Ohio, 800 strong," was found at the base of an 18-foot fiery cross by Deputy Sheriff Edwin Nolting on Wyscarver Road, south of Sharonville, Friday night.

Replicas of rifles were found around the bottom of the cross. Sharonville firemen extinguished the blaze after it had been viewed by occupants of several hundred automobiles.

The office of Sheriff George A. Lutz is investigating the burning of the cross.

A. M. Husted, head of the park police, said that every effort would be made to prevent any outbreak of violence within the park area.

Husted said that Negro card sharps recently had fleeced picnickers, using a marked deck. They were arrested.

The burning of the cross attracted the attention of hundreds of persons in Sharonville, and those riding in automobiles.
