BOWTIE is the code word for the case involving Christine Keeler and John Profumo.

The following was obtained from Mr. Carl Burrows, Immigration and Naturalization Service (INS), on July 9, 1963, with regard to Susie Chang who was referred to in the "New York Journal American" on June 29, 1963, as the paramour of a high elected U. S. Government official. As Esther Sue Chang, Susie Chang boarded Pan American Flight 101 on December 23, 1962, at London, England, and arrived the same day in New York City. She had passport number 31052 issued at Hong Kong, China, and a visitors visa issued at London on December 21, 1962. This visa was apparently issued on the basis of an affidavit in lieu of passport which was described as no longer valid. On arrival at New York City she was paroled for four days to allow her to obtain an extension of passport and to present the same at INS, New York. On her arrival it had been determined that neither the passport nor the affidavit in lieu thereof were valid documents. In connection with this arrival in the U. S. her home address was listed as 525 Nell Gwynne House, Chelsea, London, S.W., England. Her destination was given as [redacted] in care of a [redacted]. She departed for London on January 6, 1963, on Pan American Flight 2. INS records reflect that [redacted]

[redacted] became a naturalized U. S. citizen in the Southern District of New York on March 12, 1962. He is a [redacted] and resides at the foregoing address with his wife and four children. No record was found that Susie Chang had any contact with INS, New York, during the above visit. INS records reflect Susie Chang's father as [redacted] born in China, January 28, 1913. He entered the U. S. in 1958 from Brazil and is a [redacted]

[redacted] He has not been naturalized but has permanent resident status. Records reflect he has a daughter, Diana Chang, born February 1, 1943, in China and a daughter, Esther.

Susie Chang's mother, [redacted] born in China February 9, 1906, entered the U. S. at Seattle, Washington, May 1956, as a refugee. She is a [redacted] who resides at [redacted]

[REDACTED] She became a naturalized citizen December 18, 1961, at Wilmington, Delaware. Her daughter, [REDACTED] resides with her.

The INS file on Susie Chang's mother shows that her petition for naturalization lists a daughter, Esther, born November 23, 1935, who resides in London, England.

The mother's file also reflects that on April 3, 1962, the mother filed a petition in Philadelphia, Pennsylvania, for a second preference visa under the Chinese quota for her daughter Esther. The mother was represented, in connection with this petition, by the New York City law firm of Donovan, Leisure and Irvin. Burrows commented that this is the same law firm which James B. Donovan, recently involved in exchanges of Cuban prisoners, is a member of. The visa petition stated that Esther Chang is an experienced nurse whose services were needed at Princeton, New Jersey. The petition for visa was approved April 17, 1962, and the U. S. Consulate at London was notified of this fact. Burrows commented that if the Chinese quota had openings, she might conceivably be able to come into the country but there are no openings at this time. Burrows further commented that in view of the present situation in which Susie Chang is involved, INS is preparing a letter to State suggesting that State might wish to check with appropriate local British authorities in London before issuing her a visa to come to the U. S.

Burrows assured that the Bureau will be advised of any further information concerning Susie Chang which comes to INS attention.

Bowtie is the code name for case involving Christine Keeler and John Profumo.

This memorandum recommends that we forward to the Legal Attache, London, copies of reports in the White Slave Traffic Act (WSTA) investigation of Marie Novotny and [REDACTED]. The signed statement given by Novotny in New York admitting prostitution activities.

Marie Novotny is a British prostitute involved in this case. She is known to Dr. Stephen Ward, procurer for Christine Keeler. Novotny is currently married to one Horace Dibben, an alleged antique dealer, and it was at their home in London that the infamous dinner party occurred at which a titled Englishman served dinner wearing only a mask. Their home has also been mentioned as the scene of perverted and sadistic activity.

Novotny, at the request of Harry Towers, British television producer, came to the United States 12/14/60 and lived in New York until 3/3/61, when she was arrested on a charge of prostitution. We filed a WSTA complaint against Towers on 3/7/61. In April and May, 1961, Towers and Novotny fled from the United States.

In a signed statement dated 3/7/61 Novotny admitted that she had sexual relations with Towers in England before coming to the United States. She further admitted that she entertained prostitution dates in New York regularly and earned about \$400 per week and gave Towers \$300 per week.

The June 27, 1963, issue of the New York "Journal American" contained an article written by James D. Horan and Dom Frasca, which was entitled "Cuban Refugee Was Queen of United Nations V-Girl Ring". The article reflected that "A beautiful Yugoslavian show girl granted political asylum in the United States after leaving Castro's Cuba was revealed today as a leading madame of a United Nations call girl ring. She arrived at New York City in 1960, and went to work as an instructor in an east side school for prospective debutantes".

The following information was also contained in the article: "The girl was said to have spent five years in Cuba, and before leaving there applied for citizenship status and was awaiting naturalization. The information concerning the girl was contained in a copy of "secret government report" in the hands of these reporters".

United States Attorney Robert M. Morgenthau, Jr. recently reopened the Harry Alan Towers case after the "Journal American" disclosed that he had gained refuge in the Communist world. Subpoenaes had been issued for two girls sought in connection with the Towers probe. One was Delia Merino Bartet also known as Yvonne Mandot, and authorities were withholding the identification of the other girl who was a "familiar figure around the United Nations".

The unidentified Yugoslavian beauty allegedly arranged dates for Merino-Bartet.

The article said that another section of the "report" indicated that the unidentified girl was born in Yugoslavia on September 9, 1932, and arrived in Cuba in February, 1955, while traveling with a Yugoslavian passport on a tour in South America. She applied for citizenship in Havana, Cuba, on March 22, 1960, but did not complete the naturalization. She arrived at the Port of New York, on May 19, 1960.

The remainder of the article dealt with the Harry Alan Towers, Maria Novotny case.



Ivanov Turns Up Again--In Towers Case

Soviet diplomat Eugene Ivanov was among the clients of Mariella (Marie) Novotny, queen of the call girl harem that fugitive procurer Harry Alan Towers ran in New York and London diplomatic circles.

She met Ivanov at a London cocktail party in 1960. Towers, given asylum behind the Iron Curtain, was then near the end of his tenure as British representative for an American communications firm that has done work for the U. S. government on rockets and missiles.

This was revealed to the N. Y. Journal-American by the highest government authorities and confirmed reluctantly by Marie herself in a trans-Atlantic telephone interview from her London flat.

SECURITY QUESTION

Like Christine Keeler, Marie had an affair with Ivanov, that is believed to have far greater security implications than Christine's involvement with the man she called "a wonderful huggy bear."

"Certainly I was not knowingly part of any blackmailing or spying organization," Marie said in admitting she played the vice circuit with Ivanov the same as Christine had done.

Marie said she had often quarrelled with Ivanov because she differed with his political views. Once she stalked out on him in a rage.

Officially Ivanov was assistant naval attache at the Soviet Embassy in London.

He was recalled to Moscow last December, when rumbles were first heard about Christine Keeler accompanying

Ivanov and then British War Minister John Profumo in an affair that exploded into England's sex-security scandal of the century.

Members of the British government now describe Ivanov as a Soviet spy—an agent for the Russian military intelligence service.

HER PROCURER

The disclosure of Marie's involvement with Ivanov follows a revelation by this newspaper two days ago that Towers, her procurer, figured in the corporate setup of TelePrompter Corp., which has a New York office at 50 W. 44th st.

The firm is a supplier of communication systems for approximately 100 American military and civilian bases, including Cape Canaveral, the Pentagon, the White House and U. S. Navy European Command Headquarters in London.

Irving B. Kahn, president of TelePrompter Corp., acknowledged Towers held a franchise for "four or five years" that gave him territorial rights for all of England.

Mr. Kahn said Towers distributed only speech prompting equipment until early 1960 and

Towers, formerly a British television producer, brought Marie Novotny to New York in 1961 and shortly thereafter was arrested as her procurer.

Both skipped out on American authorities. Marie, then 19, returned to London.

FUGITIVE ESCAPES

Towers, 42, was first believed hiding somewhere in the Free World. But this newspaper gave Federal authorities information recently showing he had gained refuge behind the Iron Curtain and had commuted between Moscow and Prague, Czechoslovakia, for the past two years.

Latest intelligence reports have placed Towers at the Peking Hotel in Moscow.

During the interview, Marie Novotny balked when Towers was mentioned to her.

"If you are going to persist in a discussion of him," she said, "I shall get off the phone."

"I haven't spoken a word to Mr. Towers or communicated with him in any way since he has been a fugitive from American justice."

About Ivanov, she said: "He always had a great deal to say to me about the communist way of life."

"He did not appear to know my family background, though he may have been told."

"I often quarrelled with Ivanov because I disagreed so much with what he was saying."

"For example, I asked him once: 'Why shoot people down at the Berlin Wall?' He looked at me as if a friend had asked him a stupid question."

"If we don't," he replied, "they will shoot us down."

"That did it on this particular occasion. I stalked out of the room and I didn't speak to Ivanov again for a long time."

NOW MARRIED

Marie lives with her husband, Hod Dibbens, an antique dealer twice her age.

Her acquaintance with Ivanov belies any animosity she claims she has for Communists.

Like Profumo, England's disgraced former War Minister, Ivanov was a married man. He arrived in London in 1960 with his wife and remained there for nearly three years.

During Parliamentary debate, Laborite George Witt had this to say about Ivanov:

"He assiduously cultivated certain classes of the more diseased sections of our society, became a skillful bridge player . . . drove expensive cars, was expensively dressed and visited what are known as the hot spots."

Intelligence and immigration reports describe Marie Novotny as one of the most important call girls in a vice ring that was operated by Harry Alan Towers in New York and London.

This newspaper disclosed yesterday how call girls under his wing penetrated the United Nations here by delivering speech-promoting equipment to delegates as a "front" for



DR. WARD WAS WRITING AUTOBIOGRAPHY

CLIVEDEN WEEK-ENDS STORY

By R. BARRY O'BRIEN

IN the last weeks of his life Dr. Stephen Ward wrote in his own hand 25,000 words of an uncompleted autobiography. He was writing it until the strain of the trial made him incapable of continuing it.

One chapter, entitled "My Cottage in the Country," describes his Thameside cottage on Viscount Astor's estate at Cliveden and week-ends there with his guests.

Other chapter headings include "My Artistic Life" and "The Story they would Like me to Write," the latter being described as fictional.

In other chapters he writes of his friendship with Ivanov, his childhood, and his years in America before the war when he was a student at the College of Osteopathy at Kirksville, Missouri.

Mr. Pelham Pound, the literary agent, said last night that with proceeds from the sale of Dr. Ward's sketches and other earnings the osteopath's estate might eventually receive £20,000 or more after his legal costs, which are expected to amount to £5,000, are paid.

Apart from his unfinished autobiography, Dr. Ward's assets include his share in the film "The Christine Keeler Story," and in a television film he made before the trial depicting a typical day in his life.

His estate will also receive syndication fees from the sale of personal photographs, among them a selection from his family album and a set of coloured photographs taken at Cliveden by Ivanov.

BARRETT CONFESSION Yard inquiries

Two new developments in the cases of Dr. Ward and of Aloysius "Lucky" Gordon, the Jamaican jazz singer, who was freed from prison by the Court of Criminal Appeal last week, were disclosed yesterday.

Scotland Yard inquiries are to be made into a confession by Miss Vicky Barrett, which she retracted on Sunday, that she lied when she told the jury at Dr. Ward's trial that she went to his flat every week for 24 months to have intercourse with men.

A report is to be made by the Yard to Sir Theobald Mathew, Director of Public Prosecutions, on the results of further inquiries into the Gordon case since the quashing of his conviction and three-year sentence on a charge of assaulting Miss Christine Keeler.

The confession of Miss Barrett, 20, a self-confessed prostitute, was first published exclusively in THE SUNDAY TELEGRAPH and given in greater detail in THE DAILY TELEGRAPH yesterday, together with her retraction.

In the "Lucky" Gordon case the evidence on which his conviction and sentence were quashed but which was not disclosed in court is now in the hands of the Director of Public Prosecutions.

Cabinet Response Called Inadequate

Ministers, Security Services Cleared In Official Report on Profumo Affair

LONDON Sept. 26 (Thursday)—Britain's long-awaited Denning Report on sex and security today absolved ministers of the Macmillan government of any improper involvement in the Profumo scandal.

At the same time it indicated that Prime Minister Harold Macmillan and his Cabinet colleagues had not successfully met their responsibility in dealing with the Profumo case.

Former Minister of War John D. Profumo resigned in June and admitted that he had lied to the House of Commons about his affair with call girl Christine Keeler. Miss Keeler had acknowledged a simultaneous affair with the assistant

Soviet naval attache, Capt. Eugene Ivanov.

Lord Denning rejected as "utterly unfounded" the flock of rumors stemming from the Profumo case and directly or indirectly linking other ministers to sexual orgies.

There is no reason to believe that national security was or is endangered, the 60,000-word report said, and no evidence that standards of morality in public life have been lowered.

Although the recognition that the integrity of Macmillan and his Cabinet associates is beyond question produced an almost audible sigh of relief, other portions of the document yielded small com-

fort to them. Among the damaging observations were:

• That Profumo's conduct had disclosed a "character defect which pointed to his being a security risk" subject to possible blackmail.

• That as long ago as January Profumo had consulted with Attorney General Sir John Hobson about how to deal with rumors about his affair with Miss Keeler, and that Hobson's suspicions were enough aroused for him to report to government Chief Whip Martin Redmayne.

• That Home Secretary Henry Brooke rather than Macmillan is directly in charge of security services but was not told of what the

services already knew about the Profumo case at the time it became public in March.

The Labor opposition is sure to zero in on these points. Leader Harold Wilson asked that Parliament be recalled on Oct. 14 to 24 for a two-day debate on the Denning Report, but Macmillan refused. Now a debate cannot come until early November.

Even in advance of the report, it already had been branded by at least one Conservative member of Parliament as a "whitewash."

The 64-year-old Lord Denning, who as Master of the Rolls is the third man in Britain's judicial hierarchy, was appointed in June to investigate the Profumo case and any evidence that security had been endangered. He found no blame attaching to the security services.

The report disclosed Denning's own trepidations about a role in which he dealt with a million words of unsworn testimony from witnesses ranging from Macmillan himself to acknowledged prostitutes. None of the witnesses was subjected to cross-examination.

Ward Blamed

The detailed report also:

- Blamed many of the sub-sect rumors on the name-dropping habit of Dr. Stephen

Ward, the society osteopath and portrait painter who frequented the Cliveden Estate of Viscount Astor. Ward, 50, took a fatal dose of drugs shortly before he was convicted in August of living in part off earnings from prostitution. He died without learning of the verdict.

- Called Ward, who introduced Profumo to Miss Keeler "utterly immoral." Ward, the report charged "used to pick up pretty girls at the age of 18 or 19, often from night clubs, and induce them to come and stay with him at his house in London. He used to take these girls down at week-ends to his cottage. He seduced many of them himself."

- "He also procured them to be mistresses for his influential friends. He did not confine his attention to promiscuity. He catered also for those of his friends who had perverted tastes. There is evidence that he was ready to arrange for whipping and other sadistic performances. He kept collections of pornographic photographs. He attended parties where there were sexual orgies of a revolting nature."

- Rejected Miss Keeler's assertion that she and Ivanov had been lovers, although some sort of sexual relations might have followed a party at Lord Astor's estate.

Triangle Rejected

- Rejected the contention that Profumo and Ivanov had been "sharing her services," although it confirmed that Ivanov had asked Ward to procure information from his influential friends about whether the United States intended to arm West Germany with nuclear weapons.

- Suggested that Ivanov may have filled a new role in Russian technique. "It was to divide the United Kingdom from the United States by these devious means. If ministers or prominent people can be placed in compromising situations, or made the subject of damaging rumor, or the security service can be made to appear incompetent, it may weaken the confidence of the United States in our integrity and reliability."

sonate assessment of Miss Keeler, to whom it referred consistently as "Christine."

- "Let no one judge her too harshly. She was not 21. And since the age of 18 she had become enmeshed in a net of wickedness. I would credit her, too, with a desire only for a fair recompense and not an intention to exploit."

- Miss Keeler currently is out on bail after having been charged with conspiracy and perjury in her testimony in the case of Aloysius "Lucky" Gordon, Negro narcotics peddler with whom she once lived and whom she helped convict of assault.

- Disclosed that Profumo had attempted, through Ward and Lord Astor, to induce Miss Keeler to withdraw the story she had sold to the Sunday Pictorial, but that negotiations broke down over a misunderstanding that the 5000 pounds she asked was only 500.

- Recommended that the new British Press Council do something "to stop the trafficking in scandal for reward."

- Refuted categorically the rumor that a Cabinet minister had been the "man in the mask" at a party at which a man had appeared naked except for a mask and a small apron. Miss Keeler's friend, Marilyn Rice-Davies, had testified that an unnamed minister had indulged in "weird sexual practices."

- Perverted Parties Held

- Observed at the same time that "there is a great deal of evidence which satisfied me (Lord Denning) that there is a group of people who have held parties in private of a perverted nature. At some of these parties, the man who serves the dinner is nearly naked except for a small square lace apron around his waist such as a waitress might wear. He wears a black mask over his head with slits for

eye-holes. He cannot therefore be recognized by any of the guests.

- "Some reports say there and say that nothing was done place. It is thought that the turn and no more... well be so... parties. But... followed sexual orgies... the mask is a 'slave' who is whipped that the guests had dress and indulge in sexual intercourse one with the other and indulge in other sexual activities of a vile and revolting nature."

- Disclosed that the host and hostess had identified the man in the mask and that he was not the minister. The masked man had come forward to give evidence and "is now grievously ashamed of what he did."

- Also refuted a similar rumor that another Cabinet min...

ister had been the unknown man in a photograph in the recent Duchess of Argyll divorce case or had paid the Duke of Argyll a sum of money to have his head cropped from the photograph.

The minister in question voluntarily submitted to a medical examination which "proved conclusively" that he was not the man in the photograph.

• Suggested nevertheless that "public men are more vulnerable than they were, and it behooves them, even more than ever, to give no cause for scandal" since "scandalous information about well-known people has become a marketable commodity."

Summing up his investigation, Lord Denning said that it is not the job of the security

services to inquire into private conduct.

Immorality or discreditable conduct, he explained, "is only a security risk if it is committed in such circumstances that it might lead him to give away secret information."

Despite this somewhat anticlimactic end to an investigation of rumors that had spread like chicken pox at

least 1500 persons were lined up at the government stationery office when it opened at 12:30 this morning to see copies of the Denning Report.

That has been & is the key to the weakness of British security.




THE PRIME MINISTER.

INTRODUCTION

(i) Preliminary

1. On Friday, 21st June, 1963, you asked me to undertake an inquiry with these terms of reference:

"To examine, in the light of the circumstances leading to the resignation of the former Secretary of State for War, Mr. J. D. Profumo, the operation of the Security Service and the adequacy of their co-operation with the Police in matters of security, to investigate any information or material which may come to his attention in this connection and to consider any evidence there may be for believing that national security has been, or may be, endangered and to report thereon."

2. On Monday, 24th June, 1963, I started work. On Tuesday, 25th June, 1963, I started hearing witnesses and the hearings continued for forty-nine days. There were about one hundred and sixty witnesses in all. Some of them came more than once. Stephen Ward came three times. Christine Keeler twice. Mr. Profumo twice. Some of the witnesses did not wish their identity to be disclosed. I have not, therefore, appended a list of them. But they covered a wide range: The Prime Minister, eight Cabinet Ministers, four other Ministers, as well as three of the Law Officers, five Members of the House of Lords, 15 Members of the House of Commons, several Civil Servants, including the Official Head of the Civil Service, the Secretary of the Cabinet, the Permanent Under-Secretary of State for the Home Department; and the Principal Private Secretary to the Prime Minister; the Commissioner of the Metropolitan Police and several officers of the force; the Director-General of the Security Service, his Deputy and several members of his staff (I also visited twice the Headquarters of the Security Service); 25 members of the newspaper profession, including newspaper proprietors, editors, reporters and other journalists; six girls and nine men who knew Stephen Ward well; and several members of the general public who volunteered information. I received also numerous written memoranda. After hearing evidence, I have devoted four weeks to the preparation of this report. I would like to thank all of the witnesses who so generously gave of their time to assist me. I am also much indebted to my secretaries, Mr. T. A. Critchley of the Home Office, and Mr. A. J. M. Chitty of the Treasury Solicitor's Department, whose knowledge and experience have been of immense value. They have worked long hours and have shown much ability and courtesy in handling the many delicate situations that have arisen. The whole of the ancillary staff earned my warm gratitude. From the beginning to the end of my inquiry the high quality and excellent spirit of my staff were of the greatest possible assistance.

3. In preparing this report, and following the terms of reference, I have divided it into four Parts.

The First Part sets out "the circumstances leading to the resignation of the former Secretary of State for War, Mr. J. D. Profumo".

The Second Part is my examination of "the operation of the Security Service and the adequacy of their co-operation with the Police in matters of security".

The Third Part gives my Conclusions on the First and Second Parts.

The Fourth Part is my investigation into the "information and material which has come to my attention in this connection" and my consideration of "any evidence there may be for believing that national security has been, or may be, endangered".

4. Before embarking on the Report, however, I must point out that my inquiry has been subject to some unavoidable limitations.

(ii) Limitations of the Inquiry and Report

5. It has been much debated what is the best way to deal with matters such as those referred to me. The appointment of a tribunal under the Tribunal of Inquiries Act, 1921, is an elaborate and costly machine, equipped with all the engines of the law—counsel, solicitors, witnesses on oath, absolute privilege, openness to the public (so far as possible) and committal for contempt—but it suffers from the invincible drawback, in doing justice, that there is no prosecution, no charge, and no defence. The appointment of a Select Committee of one or both Houses of Parliament is a very representative body, but it is said to suffer from the drawback (to some eyes) that the inquisitors are too many and may be influenced in their, often divergent, views by political considerations, so that there may be too much dissent to carry authority. Now there is this inquiry which I have been entrusted with *alone*. It has the advantage that there can be no dissent, but it has two great disadvantages: first, being in secret, it has not the appearance of justice; second, in carrying out the inquiry, I have had to be detective, inquisitor, advocate and judge, and it has been difficult to combine them. But I have come to see that it has three considerable advantages. First, inasmuch as it has been held in private and in *strict confidence*, the witnesses were, I am sure, much more frank than they would otherwise have been. Secondly, I was able to check the evidence of one witness against that of another more freely. Thirdly, and most important, aspersions cast by witnesses against others (who are not able to defend themselves) do not achieve the publicity which is inevitable in a Court of Law or Tribunal of Inquiry.

6. You were good enough to say that, if I needed further powers, I was to ask for them. I have not felt the need. Every witness whom I asked to come, has come, without being subpoenaed. Every witness has answered the questions I put to him, without being threatened with contempt. I have been told as much truth without an oath as if it were on oath. It was not the lack of powers which handicapped me. It was the very nature of the inquiry with which I was entrusted.

7. At every stage of this inquiry I have been faced with this great anxiety: How far should I go into matters which seem to show that someone or other has been guilty of a criminal offence, or of professional misconduct, or moral turpitude, or even incompetence? My inquiry is not a suitable body to determine guilt or innocence. I have not the means at my disposal. No witness has given evidence on oath. None has been cross-examined. No charge

has been preferred. No opportunity to defend has been open. It poses for me an inescapable dilemma: *On the one hand*, if I refrain from going into such matters, my inquiry will be thwarted. Questions that have been asked in the public interest will not be answered. Suspicions that have already fallen heavily on innocent persons may not be removed. Yet, *on the other hand*, if I do go into these matters I may well place persons under a cloud when it is undeserved: and I may impute to them offences or misconduct which they have never had the chance to rebut. Above all I have to remember that the information that I have been given has been given in confidence. In order to enable every witness to speak frankly and truly to me, I have assured each one that what they tell me is in strict confidence and will be used only for the purposes of my inquiry and report. This means that, whatever I say in this report, it should not be used for any other purpose: in particular none of it should be used for the purposes of any prosecution or proceeding against anyone. But I cannot, of course, prevent anyone from seeking evidence *aliunde* and acting on it.

8. Such being the inescapable difficulties inherent in this form of inquiry, I have come to the conclusion that all I can do is this:

When the facts are clear beyond controversy, I will state them as objectively as I can, irrespective of the consequences to individuals: and I will draw any inference that is manifest from those facts. But when the facts are in issue, I must always remember the cardinal principle of justice—that no man is to be condemned on suspicion. There must be evidence which proves his guilt before he is pronounced to be so. I will therefore take the facts in his favour rather than do an injustice which is without remedy. For from my findings there is no appeal.

9. To those who in consequence will reproach me for "white-washing", I would make this answer: While the public interest demands that the facts should be ascertained as completely as possible, there is a yet higher public interest to be considered, namely, the interest of justice to the individual which overrides all other. At any rate, speaking as a Judge, I put justice first.
