AT NINE FORTYFIVE PM TODAY, DEPUTIES OF THE FORSYTH CO. SO, WINSTON-SALEM, NC, ENTERED THE BPP HEADQUARTERS AT ONE THREE SEVEN TWO UNDERWOOD ST., APT. A. THERE WERE NO INDIVIDUALS IN THE APARTMENT AND A SMALL QUANTITY OF FURNITURE AND OLD CLOTHES WERE REMOVED BY THE DEPUTIES WHO THEREAFTER PADLOCKED THE APARTMENT. THE ONLY FORTIFICATION OBSERVED IN THE APARTMENT WERE OLD DOORES NAILED OVER THE INSIDES OF THE WINDOWS.

Attached advises that on March 8, 1971, Sheriff's deputies entered apartment housing Winston-Salem, North Carolina, Black Panther Party (BPP) headquarters to serve eviction notice. Headquarters unoccupied. No violence occurred.

On March 8, 1971, one Winston-Salem BPP officer sentenced to four to six months by county court on charge of carrying a concealed weapon and released on bond. He called Judge obscene name when leaving courtroom and was immediately arrested and jailed on contempt charge.

C. DUE TO THE FACT PANTHERS WERE NOT ALLOWED THE USE OF THE SCHOOL FACILITIES. TOTAL OF APPROXIMATELY SIXTY PEOPLE ATTENDED ALTHOUGH THERE WAS NOT THAT MANY THERE AT ANY ONE TIME. in obtaining recordings of black and New Left extremists
through [REDACTED]
However, in two recent occurrences, arrangements have been
made for the recordings of speeches by ZAYDE SHAKER of the
BPP "New York 21" and JANE FONDA, actress and New Left
activist. However, efforts failed due to difficulties
in the recording equipment. In addition, with BPP activities
occurring at Winston-Salem, and High Point, N. C., and
informants of proven reliability in a position to attend
BPP functions carrying concealed recording devices, it
would appear justifiable at this time for Charlotte to be
in a position of a concealable recording device.

EXP. PROC.

Due to the above, it is requested that Charlotte
be assigned an Edwards Binaural Recorder or its equivalent
for such coverage.

[REDACTED] advised on [REDACTED] that FAYE ANNETTE SWITZER was the financial secretary for the National Committee to Combat Fascism in Winston-Salem, North Carolina.

[REDACTED] advised on [REDACTED], that on that date subject was seen at the National Committee to Combat Fascism Headquarters, and it was noted she was there regularly and was an active member.

The same source advised on [REDACTED], that subject SWITZER continued as an active member in the National Committee to Combat Fascism.

[REDACTED] advised on [REDACTED] that among several others, FAYE SWITZER, was an active member of the National Committee to Combat Fascism and lived at the National Committee to Combat Fascism "pad" at 1050 North Cleveland, Apartment N in Winston-Salem, North Carolina. This source also noted on [REDACTED] that FAYE ANNETTE SWITZER and other National Committee to Combat Fascism members were noted at headquarters viewing a film possibly entitled "Off The Pigs."

[REDACTED] advised on [REDACTED] that FAYE SWITZER lived at Apartment N, Colony Place Apartments, with other National Committee to Combat Fascism members and they were reputedly [REDACTED]

[REDACTED] advised on [REDACTED] that subject SWITZER had dropped out of the National Committee to Combat Fascism along with several other members in a power purge. This source advised on [REDACTED] that FAYE SWITZER was living with other former National Committee to Combat Fascism members at the former National Committee to Combat Fascism "pad" in the Colony Place Apartments, but all of these individuals were out of the National Committee to Combat Fascism.

The Black Panther paper dated July 4, 1970 held an article entitled "Purge Winston-Salem, N. Carolina," which stated in part that the subject along with ROBERT GREER, JESSE STITT, JACKIE PEOPLES and DAVID BLAIR had decided to leave the National Committee to Combat Fascism at their own accord rather than accept being reduced to community workers.

BLACK PANTHER PARTY (BPP),

Black Panther Party For Self-Defense

According to the official newspaper of the BPP, the BPP was started during December, 1966, in Oakland, California, to organize black people so they can take control of the life, politics, and the destiny of the black community. It was organized by BOBBY G. SEALE, BPP Chairman, and HUEY P. BINTON, Minister of Defense, BPP.

The official newspaper, called "The Black Panther," regularly states that the BPP advocates the use of guns and guerrilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are urged to arm themselves against the police who are consistently referred to as "pigs" who should be killed.

The newspaper, in its issue of September 7, 1968, had an article by the then Minister of Education, GEORGE MURKAY. This article ended with the following:

"Black men, black people, colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is revolutionary culture. Change. Freedom everywhere. Dynamite! Black power. Use the gun. Kill the pigs everywhere."

The BPP newspaper, issue of October 5, 1968, had an article introduced with the following statement: "We will not dissent from American government. We will overthrow it."

DAVID HILLIARD, Chief of Staff, BPP, in a speech at the San Francisco Polo Field on November 21, 1969, said "We will kill Richard Nixon."

DAVID HILLIARD, in the "New York Times," issue of December 13, 1969, was quoted as follows: "We advocate the very direct overthrow of the government by way of force and violence."

In the issue of April 25, 1970, the BPP newspaper had an article by Minister of Culture MARK DOUGLAS as follows:

"The only way to make this racist US government administer justice to the people it is oppressing, is . . . by taking up arms against this government, killing its officials, until the reactionary servants are dead, and those that are left turn their weapons on their superiors, thereby passing revolutionary judgment against the number one enemy of all mankind, the racist U. S. government."

The BPP Headquarters is located at 1042 Paralta Street, Oakland, California. Branches of the BPP, and Committees to Combat Fascism, under control of the BPP, have been established in various locations in the USA.

You should in the future advise the Bureau by appropriate expeditious communication of information developed which could lead to confrontation between police and members of the BPP. The Bureau has no prior knowledge (prior to your routine monthly summary) that eviction action was contemplated by the High Point, North Carolina, Police Department, occurring on 2/10/71, which led to a shoot-out in which one officer was critically wounded, one Panther slightly wounded and four arrests made.

In the future it is expected that such contemplated action by local authorities which could lead to armed confrontation will be more timely submitted by appropriate communication. You should not delay submitting such information until the submission of the routine monthly summary.

The activities of this group should be closely followed and your informant development should be intensified.

Promptly submit LHM reflecting details of shoot out.

NOTE:

A shoot-out occurred between local authorities and Panthers at a Panther Community Information Center at High Point, North Carolina, on 2/10/71, as a result of eviction action being served by local authorities. Bureau had no prior knowledge (before Charlotte routine monthly summary airtel dated 2/4/71, received 2/9/71). They are severely handicapped at Winston-Salem by lack of space and are unable to hold their usual activities, such as Political Education classes, etc.

Since previous airtel no underground cells or members have been identified or interviewed and no information that funds are being furnished any underground group from North Carolina. There have been no reported thefts of weapons or explosives for use of underground or secret organizations. There have been no recent acts of violence on police which appear to have been perpetrated by black extremists underground operatives.

On [REDACTED] in the Winston Salem National Committee to Combat Fascism, now cooperative on interview, had no information concerning any underground operation and noted that members who have purged or who have left the group are classed as "renegades" who have turned their backs on the people.

Continued efforts to interview and locate [REDACTED] met with negative results, it being noted that she can be located by telephone, however, fails to keep appointments with Bureau agents.

[REDACTED] advised in his contacts with [REDACTED] she is of the opinion that agents may try to harm or kill her, and he has not been able to convince her that she should meet with agents for interview.

On February 9, 1971, [REDACTED] Guilford County Sheriff's Office, High Point, North Carolina, advised that during the past week eviction of the Black Panther Party (BPP) Headquarters, 612 Hulda Street, High Point, North Carolina, was ordered by Mandenhall - Moore Realtors as the house had been rented under false pretense with the claim it was to be occupied by a family. Eviction proceedings were undertaken after a court magistrate notice was given several weeks ago and the local authorities waited a mandatory 72 hour notice period before undertaking the eviction. The required cash bond was not posted to provide a legal delay until the case could be heard.

[REDACTED] further stated that eviction would take place 7:00 AM, February 10, 1971, by employees of the local Sheriff's Office and Police Department.

On February 10, 1971, [REDACTED], Police Department, High Point, North Carolina, advised that at approximately 6:30 AM that date some 35 to 40 officers of the police department and sheriff's office surrounded the BPP house at 612 Hulda Street. Chief of Police LAURIE PRITCHETT accompanied by Deputy Sheriffs LARRY LINTHICUM and Lieutenant G. A. ARRINGTON, Guilford County Sheriff's Office, walked on the porch and spoke to the occupants through the closed door advising of their presence for the

Civil Rights cases and another unidentified attorney in his firm were on the scene taking photographs and interviewing persons.

[REDACTED] further asserted that LARRY LITTLE, a BPP member, Winston-Salem, North Carolina, subsequently appeared on the scene with several other Negroes from Winston-Salem, North Carolina, and also engaged in picture taking and talking with Negroes in the area.

[REDACTED] said that about 20 Negro children were removed from the Hulda Street house around midnight before the confrontation as well as other weapons. Around 4:00 PM, February 10, 1971, he stated a leaflet appeared on the street in the Negro areas, claiming the Black community information center was attacked by the "High Point Pig Department" and that above listed subject had been kidnapped. The leaflet concluded with a request, "Ransom Money Needed Now," and to contact occupants of 612 Hulda Street, which, however, is closed and boarded up.

BLACK PANTHER PARTY (BPP),

According to the official newspaper of the BPP, the BPP was started during December, 1966, in Oakland, California, to organize black people so they can take control of the life, politics, and the destiny of the black community. It was organized by BOBBY G. SEALE, BPP Chairman, and HUEY P. NEWTON, Minister of Defense, BPP.

The official newspaper, called "The Black Panther," regularly states that the BPP advocates the use of guns and guerrilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are urged to arm themselves against the police who are consistently referred to as "pigs" who should be killed.

The newspaper, in its issue of September 7, 1968, had an article by the then Minister of Education, GEORGE MURRAY. This article ended with the following:

"Black men, Black people, colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is revolutionary culture. Change. Freedom everywhere. Dynamite! Black power. Use the gun. Kill the pigs everywhere."

The BPP newspaper, issue of October 5, 1968, had an article introduced with the following statement: "We will not dissent from American government. We will overthrow it."

DAVID HILLIARD, Chief of Staff, BPP, in a speech at the San Francisco Polo Field on November 15, 1969, said "We will kill Richard Nixon."

DAVID HILLIARD, in the "New York Times," issue of December 13, 1969, was quoted as follows: "We advocate the very direct overthrow of the government by way of force and violence."

In the issue of April 25, 1970, the BPP newspaper had an article by Minister of Culture EMORY DOUGLAS as follows:

"The only way to make this racist US government administer justice to the people it is oppressing, is. . . by taking up arms against this government, killing the officials, until the reactionary forces. . . are dead, and those that are left turn their weapons on their superiors, thereby passing revolutionary judgement against the number one enemy of all mankind, the racist U. S. government."

The BPP Headquarters is located at 1046 Feralta Street, Oakland, California. Branches of the BPP, and Committees to Combat Fascism, under control of the BPP, have been established in various locations in the USA.

Source later advised that [REDACTED] of the Winston-Salem NCCF, contacted BPP National Headquarters, speaking with [REDACTED] informing him that the Black Community in North Carolina had received letters, stating that [REDACTED] was a "Pig" and that the NCCFs, which were operating in North Carolina had been disbanded and were no longer functional. Source said that [REDACTED] knew nothing about the matter.

Of further interest, source advised that [REDACTED] then spoke with [REDACTED] regarding articles being submitted by him for inclusion in the BPP newspaper.

[REDACTED] stated that he and all of the other brothers that had been arrested in North Carolina are now out on bail. He said that on the day of the preliminary hearing, the courtroom was filled with people from the Black Community, and the Judge, FRANK GIBSON, had said that he would not let a mob enter his courtroom and had the "Pigs" clear the courtroom. [REDACTED] further reported that a 15 year old brother, by the name of CARY COLE (phonetic), had been held for five days incommunicado and had turned states evidence. In this regard, COLE had apparently stated that [REDACTED] had been involved and furnished other testimony implicating [REDACTED], (which was not detailed by [REDACTED]).

Source later advised that an unknown female (presumably [REDACTED] at BPP National Headquarters, contacted [REDACTED] informing her that the BPP definitely did not send the letters about which [REDACTED] had inquired and that they were probably sent by the "Pigs." [REDACTED] further informed on this occasion that other "mothers" in Winston-Salem had also received these letters.

The unknown caller inquired about the signatures appearing on the letters and [REDACTED] told her that they were signed by EMORY DOUGLAS, DAVID HILLIARD, and JUNE HILLIARD. She was then, again, informed that these were not valid letters and they should be disregarded.



During previous two weeks, no underground sales or members have been identified or interviewed and there is no indication that funds are being submitted to any underground group from North Carolina. There have been no reported thefts of weapons, or explosives for use of underground or secret organizations. There have been no recent acts of violence on police which appear to have been perpetrated by black extremists underground operatives.

On [redacted] at Winston-Salem, N. C. [redacted] was interviewed.

[redacted] was cooperative during the interview and theorized about the Black Panther Party group at Winston-Salem [redacted]

He had no information that any of the individuals [redacted] with him had done so for reasons of joining underground apparatus and to his knowledge all were living and working under their true names, although some have extreme distaste for law enforcement. [redacted] was of the opinion that the entire group at Winston-Salem is "dead" but does not realize it, since they have no community support and are in fact, thieves and hoodlums.


