This source also noted that "Darruba" had a body guard who traveled with him. "Darruba's" speech was the normal Black Panther speech in which he referred to situations in New York City and the meeting closed at approximately 8:30 P.M. without incident.

BLACK PANTHER PARTY,

Black Panther Party for Self-Defense

According to its official newspaper, the Black Panther Party (BPP) was started during December, 1966, in Oakland, California, to organize black people so they can take control of their life, politics and the destiny of the black community. It was organized by Bobby Seale, BPP Chairman, and Huey P. Newton, BPP Minister of Defense. Newton was sentenced in 1968 to serve 2 to 15 years after being convicted of manslaughter in connection with the killing of an Oakland police officer.

The official newspaper, "The Black Panther," which further describes itself as the "Black Community News Service," states that the BPP advocates the use of guns and guerrilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are urged to arm themselves against the police who are consistently referred to in the publication as "pigs" who should be killed.

"The Black Panther" issue of September 7, 1968, contains an editorial by BPP Minister of Education, George Mason Murray, which ends with the following:

"Black men. Black people. colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is a revolutionary culture. Change. Freedom everywhere. Dynamite! Black Power. Use the gun. Kill the pigs everywhere."

Included in the introduction to an article appearing in the October 5, 1968, edition of "The Black Panther" is the statement "...we will not dissent from American Government. We will overthrow it."

Issues of "The Black Panther" regularly contain quotations from the writings of Chairman Mao Tse-tung of the People's Republic of China and feature Mao's statement that "political power grows out of the barrel of a gun."

The national headquarters of the BPP is located at 3106 Shattuck Avenue, Berkeley, California. Branches have been established at various locations throughout the United States.

The following information was furnished
by [redacted] (SF T-16), a highly confidential source
on 5/10/70.

[redacted] (phonetic) advised BPP Head-
quarters in Berkeley, Calif. that one of his associates
from the BPP was departing from Winston-Salem on that
date en route to Atlanta and then San Francisco. He
wanted to be met at the San Francisco Airport by
someone from National Headquarters.

San Francisco Headquarters subsequently ad-
vised that LARRY LITTLE was coming to San Francisco
from Winston-Salem, North Carolina, and would be
conferring with BPP leaders in Berkeley.

The exact purpose of the trip of LITTLE
to San Francisco was not stated by the source. From
the manner of the reception of the news that he was
coming, it would appear that his visit was not
totally unexpected by Berkeley Headquarters.

GREER has been reported as the area Captain. (u)

N.C. On April 21, 1970, a source advised that the "Tower of Power Auditorium" was actually the auditorium of an old church which is now Russell's Business School operated by WILLIE E. SMITH who is currently a Negro candidate for mayor of Winston-Salem, North Carolina. According to this source, JACQUELINE PEOPLES, known by source to be a member of the Black Panther Party in Winston-Salem, arranged for use of the auditorium for May 3, 1970.

A second source advised on April 29, 1970, that the identity of the representative of the National Headquarters of the Black Panther Party who is to speak at Winston-Salem on May 3, 1970, is not known by the individuals at Winston-Salem who are sponsoring the rally; however, apparently arrangements have been made for prominent Black Panther Party member to speak.

Secret Service and military intelligence agencies advised.

Newton was sentenced in 1968 to serve 2 to 15 years after being convicted of manslaughter in connection with the killing of an Oakland police officer.

The official newspaper, "The Black Panther," which further describes itself as the "Black Community News Service," states that the BPP advocates the use of guns and guerrilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are urged to arm themselves against the police who are consistently referred to in the publication as "pigs" who should be killed.

"The Black Panther" issue of September 7, 1968, contains an editorial by BPP Minister of Education, George Mason Murray, which ends with the following:

"Black men. Black people. colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is a revolutionary culture. Change. Freedom everywhere. Dynamite! Black Power. Use the gun. Kill the pigs everywhere."

Included in the introduction to an article appearing in the October 5, 1968, edition of "The Black Panther" is the statement "...we will not dissent from American Government. We will overthrow it."

Issues of "The Black Panther" regularly contain quotations from the writings of Chairman Mao Tse-tung of the People's Republic of China and feature Mao's statement that "political power grows out of the barrel of a gun."

The national headquarters of the BPP is located at 3106 Shattuck Avenue, Berkeley, California. Branches have been established at various locations throughout the United States.



On 2/22/70, _____ reported that on 2/19/70, (C) WILLIAM RICE and LARRY LITTLE appeared at Winston-Salem State University (a predominantly Negro school) where they spoke and had a question and answer period. It was apparent from questions and lack of enthusiasm that the group was not well received and one student commented before the group that he felt the Panthers were uncouth and stupid and many of the questions concerned the lack of education, administrative ability and the goals for the Panther group. The talks by RICE and LITTLE were primarily derogatory and ran down the college and instructors for their lack of black identity and black involvement.

It was learned on 2/21/70, approximately 4 carloads of Panthers went to a dance at Winston-Salem, N.C., State University which was a part of black identity week and ROBERT TAYLOR GREER yelled and cursed at people at the dance for their lack of support for the BPP, threatening to forcibly shave some of the Afro hairdos.

Concerning pertinent BPP activities, it is noted that the group at Winston-Salem, N.C., regularly receives approximately 600 copies of BPP newspaper and are observed selling these papers on streets in Winston-Salem, N.C.

The group held their Huey P. Newton Birthday rally on 2/15/70, a complete transcript of which has previously been furnished to the Bureau. Of interest was the fact that no collection was taken for the Huey P. Newton Defense Fund.





On 2/24/70, [REDACTED] NISO, Camp Lejeune, N. C., advised that [REDACTED] was the source of information concerning the Black Panther Party (BPP) greeting card.

On 2/27/70, [REDACTED] Jacksonville, N. C., advised that local attorney [REDACTED] very reputable attorney and community servant, had received a BPP greeting card which was signed "Doc." [REDACTED] was very concerned and did not know who would send him such a message.

On 3/13/70, Mr. [REDACTED] Attorney, [REDACTED] Jacksonville, N. C., advised he had received a BPP greeting card from Greensboro, N. C., signed "Doc" and was very concerned as to its origin. He had given the card to [REDACTED] to determine its source. The name [REDACTED] aka Doc, was discussed with Mr. [REDACTED] who stated he recalls [REDACTED] having lived and worked in this area but had never approached [REDACTED] as a client. [REDACTED] in-law, (FNU) [REDACTED] had worked as a domestic (maid) for [REDACTED] but their association was always pleasant and Mr. [REDACTED] has always had the reputation of representing the Negroes in legal matters in the community and is highly regarded. Mr. [REDACTED] stated he is having the matter checked through his Negro friends to determine if [REDACTED] is the person who sent the card, and will advise the results.

On August 3, 1969, ten (10) members of the group at Charlotte, North Carolina, desiring affiliation with the BPP were driving around in a rented panel truck. They started following a vehicle occupied by four white teenagers at speeds as high as 50 miles per hour approximately six feet from the bumper of the white teenagers' automobile. The white teenagers' automobile stalled and its occupants ran into the yard of a house on Bellhaven Boulevard, at which time the group in the panel truck fired six shots at them without any known provocation. The panel truck continued on down Bellhaven Boulevard for approximately one-half mile, at which time it was wrecked and the occupants ran into the nearby woods. Local authorities arrested the ten individuals, charging all under the common law of "going armed to the terror of the people" and in addition, one was charged with assault with a deadly weapon and speeding too fast for conditions. Located near the truck were two 12 gauge shotguns and two pistols.

On August 16, 1969, at approximately 3:00 a.m., OTIS BLACKMON, Negro male, owner and operator of the Chick-N-Ribs

Drive-In, and his son observed two members of the group at Charlotte desiring affiliation with the BPP prowling around the restaurant delivery truck. The two were ordered to leave and an argument developed. Approximately one hour later the two individuals, along with an additional group of Negroes, returned to the drive-in. At this time all were dressed in black with black berets. There were a total of thirteen Panthers around with various weapons who started shooting at the building containing the Chick-N-Ribs Drive-In, with OTIS BLACKMON and his son OTIS JAMES BLACKMON returning the fire.

During the shoot out OTIS JAMES BLACKMON was shot in the upper arm.

Concerning the BPP members, JAMES MICHAEL BLACK received a minor gunshot wound in the hand and was arrested by the Charlotte Police Department and charged with assault with a deadly weapon with intent to kill. VERONICA HAGANS, Negro female, received a stab wound in the stomach with a butcher knife from OTIS BLACKMON when she attempted to enter the restaurant. CHARLES HENRY SAMPSON, JR. received a minor gunshot wound, however, required no medical treatment. JAMES MICHAEL BLACK and JAMES EDWARD PRATHER were charged with assault by discharging a firearm into an occupied dwelling. Seized from the Panther group were a .22 caliber rifle and a 7 millimeter bolt action rifle. VERONICA HAGANS refused to make any statement as to how she was stabbed or to bring charges against anyone, however, claimed that upon her being released from the hospital she would kill OTIS BLACKMON herself. As of January 5, 1970, this threat has not been carried out.

On March 13, 1969, a strike of food service workers was in progress at A and T State University, a predominantly

Negro school at Greensboro, North Carolina. Supporting the food service workers were a number of students and outsiders who considered themselves to be members of the BPP, the leader of which was ERIC PATRICK BROWN. Contributions were being asked from merchants in the area to support the striking workers, however, the owner of Sid's Curb Market, Mr. BAIN, refused to donate. On the afternoon of March 13, 1969, a group of Negro males led by ERIC PATRICK BROWN who, at that time was the area captain for the BPP in Greensboro, ransacked Sid's Curb Market, doing approximately \$1200 damage and stealing \$400 from the cash register. Mr. BAIN was severely beaten, requiring five stitches to close cuts. ERIC BROWN was identified as the individual removing the money from the cash register and received two to six years on the charge of common law robbery.

During May, 1969, racial violence erupted at Dudley High School, Greensboro, North Carolina, with the major issue being the refusal of the school administration to allow a militant student to run for class president. This situation continued until May 21, 1969. That morning, at approximately 8:15 a.m., over one hundred students from Dudley High School, instead of going to class, stayed out of school and listened to representatives of the BPP and at approximately noon the group went back to the school and refused to go to class or disperse, at which time tear gas was used. Rock throwing and sniping at police started that night and continued until the next morning. National guard elements were moved in to assist the police. In the early morning hours no police cars could get in the area of A and T due to heavy fire. With the approach of darkness on May 22, 1969, the sniping resumed and information was received that large quantities of guns and ammunition were observed in Scott Hall. Shortly after 1:00 a.m., May 23, 1969, two regular Greensboro police officers and three auxiliary policemen were hit by gunfire from the area of the Student Union Building. On the morning of May 23, 1969, the campus

was cleared by officers of the North Carolina National Guard using armored personnel carrier. Bottles of sulfuric and hydrochloric acid were tied to limbs of trees as booby traps and four operable weapons were found in Scott Hall. One student was killed and one injured during the disruption. According to sources, [REDACTED]

[REDACTED] have bragged of their participation in the racial disturbance at A and T State University.

PLANNED ACTS OF VIOLENCE

During January and February, 1969, individuals at Greensboro, North Carolina, who considered themselves to be members of the BPP, discussed creating a disturbance in a Negro area by rock and bottle throwing to draw a large crowd of police cars. One area mentioned was a dead-end street off Laurel Street in Greensboro. After drawing a crowd of police cars, snipers would then shoot the police officers. It is noted that during the disturbance at A and T State University during March, 1969, five police officers were injured in the area of Laurel Street by some snipers.

On February 8, 1969, a white employee of the Thrifty Curb Market, East Market Street, Greensboro, was involved in an altercation with a Negro male. This information was given to the Black Panthers, who had already discussed the fact that all of the white merchants in the Negro section "had to go." The Black Panther group discussed bombing the Thrifty Curb Market on the night of February 10, 1969, but subsequently called this plan off before five of the Panthers went to the Thrifty Curb Market in African regalia. This was to make their presence known and shake up the manager of the market.

During the last week of May, 1969, [REDACTED] and other BPP members rode around Greensboro and Winston-Salem, North Carolina. [REDACTED] was planning to locate a place in Greensboro in a better class white residential neighborhood

to fire bomb in order to keep up the tension in Greensboro. Their purpose for going to Winston-Salem was the fact that [REDACTED] claimed the panthers needed more guns and he had picked out a hardware store to burglarize. However, no information was received that either plan was carried out.

EXTREME CAUTION MUST BE EXERCISED DURING ALL ENCOUNTERS WITH MEMBERS OF AND ASSOCIATES OF THE BPP AS THEY ARE REPORTEDLY ATTEMPTING TO PREARRANGE THE LOCATION OF INTERVIEWS IN ORDER TO KILL FBI AGENTS. DUE TO THEIR PROVEN RECORD OF ATTEMPTS TO KILL POLICE OFFICERS, ALL BPP MEMBERS AND ASSOCIATES ARE CONSIDERED ARMED AND EXTREMELY DANGEROUS.

BLACK PANTHER PARTY

According to its official newspaper, the Black Panther Party (BPP) was started during December 1966, in Oakland, California, to organize black people so they can take control of the life, politics, and the destiny of the black community. It was organized by BOBBY GEORGE SEALE, BPP Chairman, and HUEY P. NEWTON, BPP Minister of Defense. NEWTON is presently serving a sentence of 2 to 15 years on a conviction of manslaughter in connection with the killing of an Oakland police officer.

The official newspaper, "The Black Panther," which further describes itself as the "Black Community News Service" states that the BPP advocates the use of guns and guerilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are urged to arm themselves against the police who are consistently referred to in the publication as "pigs" who should be killed.

"The Black Panther" issue of September 7, 1968 contains an editorial by BPP Minister of Education, GEORGE MASON MURRAY, which ends with the following:

"Black men. Black people, colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is a revolutionary culture. Change. Freedom everywhere. Dynamite! Black Power. Use the gun. Kill the pigs everywhere."

Included in the introduction to an article appearing in the October 5, 1968, edition of "The Black Panther" is the statement, "...we will not dissent from American Government. We will overthrow it."

Issues of "The Black Panther" regularly contain quotations from the writings of Chairman MAO Tse-tung of the People's Republic of China and feature MAO's statement that "political power grows out of the barrel of a gun."

On March 5, 1970, SF T-16 reported that [redacted] of Winston-Salem, North Carolina, had advised the National Headquarters of the Black Panther Party (BPP) at Berkeley, California, that in connection with an eviction proceeding for nonpayment of rent Deputies had moved a woman's belongings into the street and these were returned by brothers to the house with armed guards posted after which the law enforcement officers withdrew from the scene.

On March 12, 1970, Forsyth County Deputy Sheriffs [redacted] and [redacted] advised that on approximately the third of March, 1970, they went to the area of Locust Street and first went to a residence at [redacted] Winston-Salem, North Carolina, with eviction papers.

A Negro woman, [redacted] was sick in bed so they did not evict this family, but told them to find another place to live as they would have to come back in a few days to evict them.


They then went to [redacted] with a magistrate's order of eviction for the residents, noting they had previously been served with a magistrate's summons on eviction. No one was home and the door was padlocked on the outside. They pulled the hasp with a crowbar and started putting the furniture in the street as ordered by the magistrate's order of eviction. This

was listed as the home of [REDACTED] but after they had removed approximately one half of the furniture, an unidentified woman who was drunk and yelling and swearing said that this was her furniture and not to set it out. She picked up a hammer and started after the people moving the furniture, but the deputies told her to leave and she did.

During this time, another drunken Negro female, identified as [REDACTED] came in swearing and yelling but she also left. The deputies advised they started to move the cook stove, but could not do so as it would fall apart so they left it in the house.

They then went to a house at the corner of Locust and 16th Street, with papers for eviction, but found there was a drunk blind elderly Negro man in the back room. He had apparently accidentally kicked over a portable oil stove as there was oil on the floor and the house was full of smoke. The deputies advised they set the stove back up to insure there was not a fire hazard and told him of the eviction, but as he was old and blind, they did not evict him and told him to find a new place to stay as they would have to come back in a few days and evict him.

During this time, the Negro female identified as [REDACTED] came into this house, swearing and yelling, and was told to leave or she would be arrested for cursing and abusing an officer. She said "You go to hell, you don't have enough authority to arrest me because we all stick together over here." She then ran out and went down Locust Street yelling "let's all stick together."

The deputies advised they then went on about their normal business and did not ever see any Panthers in the area. These activities occurred at approximately 10 AM and at approximately 2 PM [REDACTED] Forsyth County Sheriff's Office, called them on the radio and told them the rent had been paid on all three of the above-described places and not to evict them.

The deputies emphasized there had been no encounter with Panthers and no racial incident and they had not even seen any Black Panthers in the area.

The March 3, 1970, issue of The Twin City Sentinel, Winston-Salem, North Carolina, daily newspaper, contained an article which states in part that that morning two members of the Black Panther Party stationed themselves outside a house on Locust Street, whose occupant had been evicted earlier by Deputy Sheriff after moving her furniture and possessions back into the house. The newspaper article quoted the Panthers as stating they would resist attempts to re-evict the woman.

The Journal, daily Winston-Salem, North Carolina, newspaper, in its issue of March 4, 1970, contained an article under the caption "Donor Pays Rents, Avoiding Evictions," which article is quoted in part as follows:

"An anonymous donor paid \$540 in back rent and court fees yesterday and postponed the evictions of three East Winston tenants.

"The action averted a possible armed confrontation between sheriffs' deputies, who were making the evictions, and Black Panthers, who were posted around the area with loaded guns.

"The money was paid to L. F. PEED and Son real estate company about 3 PM yesterday by ROBERT LAW, a staff member of the Experiment in Self-Reliance. LAW would not reveal where the money came from.

"MARK H. FREEMAN, director of the Urban Coalition, said last night that a person had given the money to the coalition, and that the coalition would use it to reimburse the Experiment, which took the money from its emergency fund."
