

Birth

SE [Redacted] caused a search to be made of the records of the Veterans Administration, 252 7th Avenue, New York City, and found on file information indicating that the subject was born July 2, 1910, at New York City, the son of HARRY COHEN and SARAH COHEN.

Marital Status

The records of the Veterans Administration further indicate that the subject married one LENA PETKA during July of 1941, at Norwich, Connecticut and further indicate that this marriage was performed on July 13, 1941, and that the subject's wife was born in Adanes, Massachusetts.

Military Record

The records of the Veterans Administration indicate further that the subject served as a Technician/5 under Serial Number [Redacted] in the United States Army organization Detachment G-36, Company B2, MG Regiment. The subject was inducted into the

United States Armed Forces on July 8, 1942, and entered the military service on July 22, 1942, at Fort Jay, New York, with a military occupation of cook. These records show further that the subject received an honorable discharge from the Army on November 6, 1945.

These records show that the subject, prior to his entrance into Teachers College, had five and one-half years of college education during which time he received a degree of Bachelor of Science in English in 1935 from Mississippi State College, Storkville, Mississippi. These records indicate further that the subject on May 27, 1947, registered in the course of Student Teacher at Columbia University with field work as a student teacher at Benjamin Franklin High School, New York City. The subject received the degree of Master of Arts February 26, 1947, and entered Columbia University on February 2, 1948, to receive his teacher's license.

Employment

The records of the New York City Board of Education indicate further that the subject was licensed in the Day Elementary School on June 9, 1949; the Day High School Social Studies on June 30, 1950, and the Junior High School Social Studies July 10, 1950. These records show that the

Mr. HARRY COHEN, the subject's father, Apartment 6G, 2020 Walton Avenue, advised SA [redacted] on 5/4/55 that he has no information as to the whereabouts of the subject. He stated that the subject and his wife, "LONA", left NY and went to California about five years ago. He stated that he and his wife, SARAH, recently deceased, had received a few letters from their son during the first few weeks after his move to California but that since that time, they have received no word of any sort from the subject. b7c

Mr. COHEN also stated that to the best of his recollection, the subject had indicated in his letters that he was living in a small town in the Los Angeles, California area. The subject had also advised that he and his wife had worked on a small farm for a short time, and the last information received from subject was that he was doing some sort of private teaching.

Mr. COHEN advised that VA compensation checks continue to come addressed to the subject at 2020 Walton Avenue, and that he has been holding said checks until such time as he is able to learn the subject's whereabouts and turn said checks over to the subject.

In conclusion, Mr. COHEN stated that his son's long unexplained absence had been the cause of considerable concern and sorrow to his late wife and himself and that it was also likely a contributing factor to his late wife's death and his own broken health. He stated that the subject had always been a fine son and a good boy, and that under the circumstances he was at a loss to explain the subject's long absence. He stated that inasmuch as he and the subject had always been on friendly terms, he felt sure that he would be the logical one to know the subject's whereabouts if anyone would.

Los Angeles is requested to contact logical informants and exhibit a photo of subject and his wife, and also to conduct any other appropriate investigation in an attempt to develop information concerning subject's whereabouts. Reference is made to telephone conversation between Departmental Attorney Kevin Maroney and Inspector D. E. Moore of this Bureau on August 13, 1957. Mr. Maroney advised that the arraigning judge has indicated that if Abel has not secured an attorney by August 16, the court will appoint an attorney. Mr. Maroney also advised that the judge has inquired of the office of the United States Attorney, Eastern District of New York, as to whether the Government will place any claim against the money taken from Abel. Approximately \$6,000 was found in the possession of the subject when he was arrested June 21, 1957, and \$15,000 was found in the safe-deposit box rented

During a later interview, the photographs of Shirley and Morris were displayed to [redacted] and she identified Shirley as Lona Cohen [redacted] and she claimed she did not know the identity of the man.

A review of our files reflects that Morris Cohen is the subject of a Security Matter - C investigation which originated in 1953 upon receipt of information that he was a radical communist and had held Communist Party meetings in his home. Investigation has reflected that Morris Cohen, the subject of this investigation, is the husband of Lona Cohen and is identical with the male whose picture was located in the package of money. Investigation has also developed that Morris and Lona Cohen left

New York City suddenly sometime in 1950, allegedly to travel to California. No trace of either of these persons has been developed since that time. Inquiry made of both the families of Morris and Lona Cohen has been negative. Vigorous investigation is being conducted to locate these persons.

The including of two photographs in a package of \$4,000 might indicate this money was earmarked for these two individuals and the writing on the backs of the photographs could possibly be a parole for a meeting with them by "Mark" or one of his agents. You will recall that during an interview of "Mark" by Agents of this Bureau on July 1, 1957, he was asked concerning the material that was located in his hotel room at the time of his arrest. Our Agents asked "Mark" why he had opened the door to the room when he had so much money in the room. Concerning the money, "Mark" stated he had for years carried fairly large sums of money and no one had ever tried to harm him in any way. As to the other material, "Mark" said that had the FBI called at any other time it would not have found the material in his room. "Mark" said he had brought the material into his room to work on it the night before. He said he would not have had the material in his room two hours later as he would have by then sent it out. Thus, the possibility exists this money had been prepared by "Mark" for delivery to the Cohens or to one of his agents. In view of the above, you may wish to consider the \$4,000 of evidentiary value in this case.

On August 12, 1957, Agents of our New York Office attempted to reinterview _____ and he advised the Agents he would definitely not talk to them without his attorney's being present. You may wish to consider issuing a subpoena to bring _____ before a Federal Grand Jury and have him questioned concerning his associations and relations with the subject of this case and with Morris and Lona Cohen. b7c

[REDACTED] recalled LONA COHEN and identified a photograph of LONA COHEN and MORRIS COHEN, after having viewed approximately 8 to 10 other photographs having no connection with the COHENS. [REDACTED] that LONA COHEN worked in a defense plant somewhere in NYC but never mentioned the name of the plant. He recalled that LONA COHEN and her husband had lived at 178 E. 71st St., and that approximately one year [REDACTED] the COHENS had left NYC. (It is noted this would place the COHENS' departure in 1950.) [REDACTED] b7c b7D

[REDACTED] that MORRIS COHEN was a school teacher and he noted that LONA COHEN had parents in Connecticut. He described LONA COHEN as a "free thinker," who had funny ideas and who was a pretty heavy drinker. b7c b7D

[REDACTED] had never received any mail from the COHENS once they left NYC and they had not indicated to him that they were considering leaving the city in 1950. He said he had no idea where they might have gone. b7c b7D
