There are enclosed for the Bureau: "The Welding Distributor," issue September/October, 1964; one sheet headed "'Escalating' the Viet Nam War; one document headed "Factors Operative in a Post-Arms Control Situation" dated April, 1965, bearing the imprint "Christian Crusade, P. O. Box 977, Tulsa 2, Oklahoma"; one envelope postmarked Shreveport, Louisiana.

The above material was made available to this office on October 20, 1965, by [REDACTED] Northern Welders Supply Co., 2402 East Hennepin, Minneapolis, Minnesota, a welding supply distributor.

His firm regularly receives the publication "The Welding Distributor." He has noted, from reviewing the publication, that its editor-publisher, Mr. T. B. JEFFERSON, frequently writes editorials of a right-wing character.

His firm recently received the enclosed sheet and the document dated April, 1965, in an envelope postmarked Shreveport, Louisiana, which contains no indication of the sender. He became alarmed that what purports to be a contract with the North American Aviation, Inc., should have been made available in one way or another for public distribution.

It is noted that in the sheet headed "Escalating"

the statement is made that the document, referring to the contract, had been "discovered" quite accidentally by some workers in the Downey, California, plant of North American Aviation. ██████████ said that he then compared the printing on the enclosed envelope with the printing appearing on the mailing address sticker which comes to Northern Welders. He is convinced that the printing on the envelope and on the publication are identical, meaning that the publishers of "The Welding Distributor" made their addressograph plates or other addressing machine available to the distributors of the above contract and sheet.

"The Welding Distributor" purports to be published by the Welding Engineer Publications, Inc., Post Office Box 28, Morton Grove, Illinois. The postmark on the publication indicates that it is mailed from Rochelle, Illinois.

For the information of offices receiving copies of this communication, there is enclosed for each of such offices a Xerox copy of the sheet headed "'Escalating' the Viet Nam War."

A review of the so-called contract indicates that it is some sort of a projection, presumably of the nuclear situation up to the year 1965; also of the possibility of a bilateral U.S.-USSR agreement on the exchange of military missions.

It is recalled that some time ago there was some publicity in the press that the U. S. Air Force had commissioned some firm, not recalled, to make such a projection.

It is believed that the enclosed material was distributed at least to all subscribers of the publication "The Welding Distributor"; therefore, no letterhead memorandum for dissemination is being prepared at this time since this matter probably has already come to the Bureau's attention.

"Escalating" the Viet Nam War....

....reminds us all too painfully that defending America must become again the most important, exclusive job that any of us has to perform. And, welding is one of the most vital links in our chain of defense.

Any weak link in that chain, therefore, should be of the utmost concern to those of us in the welding industry.

It is for that reason that I feel impelled to send to you, enclosed with this letter, a copy of an UNCLASSIFIED defense document--an official contract (#4916387) between the Air Force and North American Aviation, dated April, 1965.

IT IS A THOROUGHLY FRIGHTENING DOCUMENT, BECAUSE IT FORECASTS THE TOTAL DISARMAMENT OF THE UNITED STATES AND THE LOSS OF OUR NATIONAL SOVEREIGNTY--WITHIN TEN YEARS!

It "schedules", month by month, year by year, the wars that are yet to be fought, the leaders who are to be assassinated, the subversion that is to be accomplished, the governments that are to be overthrown--AND THE CONCESSIONS TO BE MADE BY OUR NATION.

The document was "discovered", quite accidentally, by some workers in the Downey, California, plant of North American Aviation. Requesting copies of the contract, they were freely distributed. One of the employees, an electronics research specialist, was so alarmed and incensed that he took the contract to his pastor. He attempted to publicize its contents, but found a wall of silence from the press. Copies were sent to several United States Senators and Congressmen. Still no repercussions.

Then he brought it, personally, to Dr. Billy James Hargis, founder and director of Christian Crusade, the nationally-known anti-communist organization, who immediately broadcast its implications over a nationwide radio network, and reproduced the entire document for the education of members of his Crusade. Thus, it was brought to my attention, and after reading it thoroughly, my responsibility was obvious: to bring it to the attention of our industry, and ask for your action.

Read it carefully. Digest its meanings. Discuss it with your friends and associates. AND THEN, ACT. Don't merely write your Congressmen--DEMAND their investigation and action. You have power and influence, as an individual citizen and as a member of a vital industry. Use that power IMMEDIATELY for the preservation of present and future generations of Americans.

On November 20, 1965, [redacted] Hillsboro Hotel, Tampa, Florida, telephonically advised that he was in possession of some Communist Party literature which had been found by a customer of the hotel. The customer was of the opinion that the material might belong to one Karl Prussion, another guest of the hotel, and representative of a group called The Christian Crusade.

On November 22, 1965, [redacted] advised that three individuals representing themselves as Christian Crusaders, checked into the Hillsboro Hotel on November 19, 1965. These persons, H. B. Kelly, Cleo Beavers and Karl Prussion, all gave their address as 219 S. Boston, Tulsa, Oklahoma. The reservation called for the rental of a room in which to hold a meeting of The Christian Crusade and the hotel's Tampa Room, with accommodations for 150 was set aside. After seeing the room, Mr. Prussion stated that it was too small and he was then rented the Empire Ballroom which seats 250 persons.

The meeting began at 7:30 PM and continued until about 11:00 PM. [redacted] was unable to estimate how many people were in attendance as guards were placed at the door to prevent outsiders from entering. There were no facilities for food or drink provided.

Sometime during the evening, one [redacted] Miami Beach, Florida, and entertainer for the USO and

guest of the hotel, gave some Communist Party literature to the desk clerk which he said he found in front of one of the elevators. This literature was comprised of the following:

1. A booklet entitled, "The Second Declaration of Havana - Cuba's Answer to the OAS", price \$.25, published by Pioneer Publishers, 116 University Place, New York 3, New York.
2. A booklet entitled, "Stop the U. S. Power Grab", by Bruce Magnuson, published for the Communist Party by Progress Books, 44 Stafford Street, Toronto 3, Ontario.
3. A leaflet stating, "Vote Against U. S. Troops in Viet Nam, Support Clifton De Berry for President, Edward Shaw for Vice President on the Socialist Workers Party Ticket", sponsored by the Students for De Berry and Shaw, Post Office Box 205, New York 3, New York.
4. A torn copy of, "The Militant", a weekly Socialist paper with offices at 116 University Place, New York, New York.
5. A subscription blank for the "Christian Crusade" with photograph of Karl Prussion.
6. A universal-type blank check made payable to The Christian Crusade, Tulso, Oklahoma.
7. A contribution envelope entitled, "For Christ - Against Communism", Christian Crusade, Tulsa 2, Oklahoma.

Upon receipt of this literature, [REDACTED] an employee of the hotel, had [REDACTED] go up to the Empire Room to see if he could obtain more of this type literature. [REDACTED] was not allowed to enter the ballroom.

On November 20, 1965, Mr. Cleo Beavers was questioned concerning the literature and he stated that a large, dark-complected man attempted to break into the Christian Crusade meeting on the previous evening and intermingle the Communist literature with the Crusader literature. The man was caught and escorted out of the Empire Room.

[REDACTED] stated that the description of this individual given by Beavers did not match that of [REDACTED]. He said, however, that it did match the description of another guest, who is touring as a singer with the Tosca Opera, [REDACTED], who gave his address as [REDACTED] Avenue, New York City.

[REDACTED] checked into the hotel on November 17, 1965, and checked out on November 21, 1965.

[REDACTED] further advised that one [REDACTED] who is in charge of the USO in Tampa, had spoken with [REDACTED] on November 20, 1965, and had told her that it would be impossible for [REDACTED] to have distributed this literature as he had been with [REDACTED] all that previous evening.

[REDACTED] stated that on the morning of November 20, 1965, [REDACTED] went up to the room of Prussion, Kelly and Beavers, to pick up their bags. [REDACTED] thought it odd that they did not allow him to enter the room until the suitcases were packed. Later when [REDACTED] picked up one of the bags in Beaver's room, it opened

and he saw a piece of literature with the wording, "Christ for Communism" inscribed on it.

b7c [redacted] stated that he asked Beavers before he checked out if his organization was pro-communist or anti-communist due to the literature that was found. Beavers said that the organization was anti-communist and that he also had some of the Communist Party literature and was taking it back to Tulsa for analyzing

[redacted] said that he had also engaged in conversation with Prussion, who told him that at one time he was a member of the Communist cell and that he had also been a counter spy for the FBI, but that he was no longer affiliated with either.

This document contains neither recommendations nor conclusions of the FBI. It is the property of the FBI and is loaned to your agency; it and its contents are not to be distributed outside your agency.

# U.S. Gradually Selling Out to Reds, Hargis Claims

The U. S. government presently is following a plan of disarmament that will deliver this country into the hands of communism within six years, an anti-Communist evangelist said in Oklahoma City this week.

Dr. Billy James Hargis, director and founder of Christian Crusade, a Tulsa-based anti-Communist organization, brought along a briefcase full of notes to back up his claims.

By 1971, Hargis said, we will be living in a one-nation, one-government world which will come about because of a Christian compromise with communism.

"This will happen, he said, unless the 'terrifying' plan is thwarted.

Hargis based his claim on his statement that U. S. Air Force contract with North American Aviation, Inc., a Los Angeles firm which previously has entered into numerous governmental projects, including the Saturn air space program.

The latest contract called for a study of disarming the United States, the final phase to take place in 1976, Hargis said.

The study was completed last April and a detailed report given, he said.

The report predicted, to the month, when the Strategic Air Command would begin destroying obsolete aircraft. Phasing out of bombers began this month.

Early in 1966, the report says, Communist China will be admitted to the United Nations. In about August, 1967, Berlin will be internationalized under UN control.

The "traterous sell-out," the "gradual surrender to world government with

Communist Russia," has been and is being instigated through a series of meetings, called the Pugwash Conference, between Russian and American officials, Hargis said.

The obvious question that rises out of this statement is, how can only two countries determine a world government? What about all those other countries?

"You and I are idealists," Hargis said. "We can't imagine our country interfering with the government of another country. But we've already had that dream shattered.

In the name of collective security we have invaded countries—Katanga, the Katanga who never did us any harm, and the Dominican Republic."

The Dominican Republic leaders who were thrown out by the United States were anti-Communist, Hargis said, and the new rulers who were installed were and are Communists.

"I predict that the Dominican Republic will be President Johnson's Bay of Pigs," he said.

The only reason he favors American action in Viet Nam is because the South Vietnamese government asked for intervention, he said.

On the other hand, in 1962 he petitioned the late President Kennedy to invade Cuba during the Soviet missile crisis there.

In the past, Hargis has bombarded U. S. foreign aid and the United Nations as being Communist inspired and has flung charges that the National Council of Churches is infiltrated with Communists.

His latest charge of a Communist sellout is supported by military authorities in addition to the North

American Aviation report, Hargis said.

Gen. Thomas S. Powers, commander of the Strategic Air Command from 1957 to 1964, resigned his post when he learned of the disarmament plans, Hargis said.

"And he's no right-winger," the evangelist said.

Both Powers and a top naval officer have told Hargis that the aviation company's report is tame compared with the government's "general and complete disarmament" program, Hargis said.

And apparently, he added, the American people are going right along with it without much concern.

"Apparently they have accepted the Bertrand Russell theory: 'Better Red than dead.'"

# Birchers, Fundamentalists Slaves to Fear, Pastor Says

The word "freedom," when it stands by itself, is about as useless a word as you can find in the English language.

Freedom may mean something different to everyone: freedom from slavery, freedom from discrimination, freedom from prison or freedom from having to work for a living.

### Ultimate Freedom

"Love," on the other hand, is all-inclusive, like God. It needs no explanation or qualification. It defies both.

But there is an ultimate freedom, a visiting Methodist minister said in Oklahoma City this week. And there is only one way to achieve it. With love.

### Opposite: Fear

"The opposite of love is not hate — it's fear," Rev. Jene Miller, pastor of the First Methodist Church of Blackwell, said.

And the "ultimate freedom," the freedom mentioned in the Bible, is freedom from fear, he said.

### Fear Is Slavery

Fear itself is a form of slavery, and it is in his discussion of fear that he tramples on the toes of such formidable opponents as the John Birch Society, Dr. Billy James Hargis and fundamentalists in general.

"We have a choice of love and fear," Mr. Miller said. "The man who chooses fear is a slave because he can be controlled by threats. The person who loves his enemy is the only person who is free."

Extremism in all forms — from communism over to fundamentalist doctrine —

slavery because it is based on fear, fear of making decisions, he said.

"These groups escape decisions by making an absolute decision," he said. "All extremism is an attempt to avoid decision."

As an example, he cited the John Birch Society, which has planted itself firmly against anything communism is for.

Robert Welch, leader of the Birchers, was once told that communism was in favor of feeding milk to babies and was then asked what his stand was. Welch was unable to answer the question, Mr. Miller said.

Likewise, fundamentalists have escaped making decisions about the meaning of the Bible by saying they believe literally what the Bible says.

"The Christian ethic denies anyone the flight from reality. For years the ethic was based on threats of heaven and hell, but their Gospels play this down. Paul's letter to the Romans doesn't mention heaven and hell.

"Any theology based on fear is not freedom."

Nowadays, Mr. Miller said, few people ever think of themselves as hell-bound or worry about going to hell if they break God's laws. Few people believe in hell.

"If there were no sheriff, would I kill my child?" Mr. Miller asked. "If there's no hell, why not lead an evil life? Well, maybe I don't want to lead an evil life."

The decision is the individual's, and "right and wrong rests on what God tells you," he said, not on fear.

### Goal Firm

"Communism is a Judeo-Christian heresy. Its goal is to help people, but it will kill anyone who gets in its way. Communism is a religion — that is, it's a value system. It's materialistic."

Priorities, sometimes called values, are something each individual must set up in his own mind and in his own heart, Mr. Miller said.

They are a form of decision making.

The doctor, for instance, must decide how to answer the patient when the patient asks, "Will I die?"

Sometimes a white lie is best, sometimes not, he said. "Right and wrong are not black and white, not absolute," he said.

### Course Offered

Love, fear, decision making and priorities are the basis of a six-session course that will make up the third annual Layman's Theological Institute which Mr. Miller will conduct.

Beginning at 7:30 p.m. Thursday, and held each Thursday night through March 3 (except February 17) on the Oklahoma City University Campus, the

course will cover "The Making of Ethical Decisions."

Cost of the course is \$10, and anyone interested is asked to register by Friday.

On 3/29/66 [redacted] Anti-Defamation League, 41 Exchange Place, N. E., Atlanta, Ga., furnished SA [redacted] with a document entitled, "The American Nazi Party, Dallas, Texas", and a document entitled, "Gordon Report Number 10 - BILLY JAMES HARGIS, The Christian Crusade". # Anti-Communist Session To Hear Ex-Gen. Walker

Edwin A. Walker, resigned U.S. Army major general, will speak to an anti-Communist seminar in Tulsa next week. He is expected to question military strategy and tactics in the Vietnam war.

Scheduled to speak to the Tuesday night session of the sixth annual Anti-Communist Leadership School, Walker will detail "the changes I would make in the conduct of the Vietnam operations if I were in command," according to a statement from his home in Dallas.

A West Point graduate in 1931, Walker commanded the 3rd Regiment of the 1st Special Service Forces in 1943 against the Japanese in the Aleutian campaign.

In 1944, Walker commanded the 1st Special Forces group in the attack at Naples-Anzio beachhead, the battle of Casino and the Southern France campaign.

Following the outbreak of the Korean war, he became assistant commandant of the Ranger training command at Ft. Benning, Ga., In 1951 he commanded the Division Artillery of the 2nd Infantry Division in the Heartbreak Ridge area of Korea. He later was named commander of the 7th Infantry Regiment of that Division.

He resigned from the U.S. Army in 1961, refusing his retirement pay, following Presidential criticism.

Another member of the school's faculty will be Gen. Richard B. Moran, Kerrville, Tex., retired former U. S. Army Signal Corps commander during World War II.

Moran serves as chairman of the national advisory board of Christian Crusade.

The Christian Crusade school will be held February 20-24, and will offer three class sessions daily. All sessions are open to the public. Advance tickets are available at Christian Crusade's headquarters, 2808 S. Sheridan Road.

# Hargis Denies Birch Merger

Tulsa evangelist Billy James Hargis denied Thursday his right-wing Christian Crusade plans to merge with the John Birch Society.

The Institute of American Democracy, Washington, D.C., said Hargis was pressing toward the merger.

The IAD described itself as an educational organization "concerned with exposing the anti-democratic nature of Far Left and Far Right organizations."

Hargis branded it a "left-wing gestapo outfit organized by Walter Reuther."

Charles Baker, IAD executive director, said "it is pretty obvious" Hargis wants to move into the Birch Society to broaden the power base of his Christian Crusade.

"The Christian Crusade plans no merger with anybody," Hargis said.

"We have a high regard for the Birch Society. And they do for us. That's all."

"There's not a shred of truth in the statement. There's not even any basis for a merger."

Baker said "Hargis' Christian Crusade in Tulsa Aug. 3-6 will be a western facsimile of the John Birch Society-promoted New Eng-

land Rally for God, Family and Country' in Boston."

Hargis said he met Baker at the New England rally.

He accused Baker of releasing the statement simultaneously with the opening of the crusade convention "to cause consternation in conservative ranks."

Baker said speakers at the convention include Curtis Dall of the Liberty Lobby and Gen. Edwin A. Walker, both of whom spoke at the Boston rally.

"Some of our members are the same," said Hargis.

"I'm sure there's a tremendous overlap. But the idea of a merger is ludicrous."

Keynote speaker at the convention is Georgia Gov. Lester Maddox.

STATEMENT OF BILLY JAMES HARGIS

On Friday or Thursday, July 18 or 19, I was at The Summit Hotel, Manitou Springs, Colorado. Around 10:00 a.m. in the morning, the telephone operator said there was a call for me from Boston from Campus Crusade for Christ. I went to the phone in the lobby of The Summit Hotel as there are no phones in the individual rooms. The voice on the other end said he was a representative of Campus Crusade for Christ in Boston. I didn't catch his name. Since Campus Crusade for Christ is a respectable organization and thoroughly a Christian organization, I assumed that it was a legitimate call and the man was a legitimate representative of the group. He said they were having a convention in Boston in September. He either said September 14 and 15, or September 21 and 22.

About this time I became aware that there was another voice on another phone listening in on the conversation for every once in a while he would mumble something to the guy who was talking to me. I still was not suspicious, however, that they were anything but what they claimed. They asked if I could speak at their convention in Boston. I asked them how long the convention would last and one of the voices said four weeks. I thought this was an extra long convention, but I felt that what they meant was that they would have campus activities in the Boston area for a four-week period.

I told them that I did not speak at any youth meetings except those that were Christian or conservative - I didn't have time to waste among these radical groups or before belligerent radical college audiences. I guess I was sleepy and just wasn't thinking. Ordinarily I would have become suspicious long before I did. As I look back on it now, I realize that I told them my schedule for the rest of August and all of September. I told them that I would be at a Convention in Tulsa August 1-4 and couldn't come then and then I would spend most of the month at The Summit Hotel where we have the Christian Crusade Youth University during August. I also told them about the We, The People Convention that I am speaking at in Chicago, September 20-22, and I said that it was possible that I could fly up there

on Sunday after my church service in Chicago. I understood there were several non-stop flights from Chicago to Boston and I could fly up and speak on Monday.

I asked them if they knew Bill Bright, who is the head of Campus Crusade for Christ and then they said they didn't know him. Then I became suspicious. Finally, the voice that had been talking to me left the line altogether and this low sounding mumbling voice did the talking. He said, "Oh, it has all been a mistake. This is not Campus Crusade for Jesus Christ. This is Campus Crusade for John Christ who is running for the legislature." And, with that, they hung up.





# LEFTISTS HIFT LID ON REVOLUTIONARY PLANS

from THE FREE ENTERPRISE

Phoenix, Arizona, June, 1969

by Ed Montgomery

Leftist militants are organizing a Revolutionary Party designed to overthrow "the establishment" by terrorist activity including assassinations and bombings. The Examiner (S.F. Sunday Examiner & Chronicle) has been told. The information came from persons within the movement itself - persons who said a target date of 1973 has been set for a nation-wide "revolutionary takeover."

How many individuals are involved has not been made clear. However, one activist said the party's top echelon will be made up in the main of militant leaders of an underground organization headquartered in Menlo Park and calling itself the Red Guard. Others would be from the Black Panthers, Students for a Democratic Society, the Resistance and other Maoist groups.

## A DEATH LIST

This extremist, an instructor at the far-out Mid-peninsula Free University, listed a frightening set of action plans at a recent Maoist study meeting of a group of "revolutionaries" in his own Palo Alto home.

A member of the Red Guard, he named certain businessmen and community leaders who would be the first to die "when we make our move to liberate downtown Palo Alto." The individuals named have since been forewarned.

He said young revolutionaries, including scores of black militants, are being trained in a camp near Havana, called "Camp May Fifth" in honor of Lenin's birthday.

## SHOOT IN BACK

And he gave this advice to those attending the meeting at his home:

- \* Don't fight the draft. Go to Vietnam and shoot your commanding officer in the back.
- \* Become an airplane mechanic and learn to sabotage planes.
- \* The Army can be won over from within. The police and the leaders of the establishment are our prime objectives.
- \* All police and members of their families must be killed and law enforcement demoralized.
- \* All jails and prisons must be opened and inmates liberated.
- \* All counter-revolutionaries, or imperialists, who would fight "liberation" must be cut down.
- \* Create as many police confrontations as possible. Scream "police brutality" and discredit the "pigs" to win public sympathy. (He cited Chicago Democratic Convention as example.)
- \* Terror is a necessary weapon and must be used to "get the cooperation of the masses."
- \* "Revolution has already begun in ghettos & in Berkeley. Weapons & explosives are available."

## ACQUIRE WEAPONS

Another informed person, a former Red Guard & SDS member, identified a number of Red Guards who have been acquiring weapons. Among them, he said, is a Stanford student whose father is a prominent San Francisco physician.

This person said Red Guard membership is not limited to college students and that a number of Palo Alto-Redwood City high school boys and girls are involved. He said, "You can pick up preliminary indoctrination literature any day of the week from a table at Palo Alto High School." A visit to the school proved his statement correct.

Still another source of information on the revolutionary party was H. Bruce Franklin, an associate professor of English at Stanford. Franklin, who considers himself a revolutionary, spoke on "Who Should Run the Universities?" at a meeting at the Madison Hotel at Washington on Jan 23 and 30. He said:

"The revolution is coming - the elements of revolution already are here."

## LOOKS TO PEKING

In a subsequent interview in his Menlo Park home, Franklin was asked how he could justify the proposed takeover of a privately endowed university. He maintained Stanford could not exist as it does without huge government subsidies, which represent public funds. He further contended that the Leland Stanford fortune, with which the university was endowed, was gained through exploitation of the working class and that the masses therefore are entitled to the fruits of the endowment.

Franklin previously had spoken in glowing terms of the revolutionary takeover of the university in Red China. He included among his "contacts" Christopher Milton, who returned from Peking recently claiming to be a Red Guard. He also mentioned "among others" William Howard Hirst, an author who also returned from behind the bamboo curtain.

Asked about the 1973 target date for the revolution and for comments on the remarks given by the Red Guard lecturer in Palo Alto, Franklin replied with marked irritation:

"I don't want to be quoted as saying, 'No comment.' I have nothing more to say - I don't want to be quoted as saying, 'No comment.'"

Billy James Hargess, an ordained minister, who is a leader of the Christian Anti-communist Crusade, headquarters Tulsa, Oklahoma, an avid conservative, will speak before a gathering of the Indiana Teachers Association during the evening of 4-30-71. Hargess is reputed to be a fiery speaker. It is reported that Hargess has opened a college which is called the All American College. No further information is available in regard to this college except that it will be holding a summer school this year in a location at the foot of Pikes Peak, Colorado.

Hargess is apparently intending to take control of the Conservative Book Store located on Thompson Road between Routes 31 and 135, Indianapolis, Indiana.

**[REDACTED]** has received 500 copies of a Klan pamphlet entitled "Its Time To Save Our Schools," and 500 copies of another Klan pamphlet, title unknown. The above pamphlet is identical with the one recently passed out during a meeting of the Indianapolis School Board. A copy of above pamphlet is attached.

1. Sensitivity training is a form of self-criticism conducted in groups. It is NOT to be confused with group psychotherapy. Sensitivity training is designed to destroy old moral values and inhibitions. New (Leftist) values are then taught to members of the group.

Sensitivity training is in fact a new form of BRAIN-WASHING. It has long been used in the Soviet Union and in Red China to create political and moral conformity among the captive population.

Sensitivity training is now being given to teachers (especially sex education teachers) as well as students.

2. The Leftist National Education Association has been the moving power behind the sensitivity training program for teachers and students. The NEA has consistently pushed the destructive ideas of Karl Marx and John Dewey onto innocent children. The NEA sensitivity training program was started by the National Training Laboratories (a sub-division of NEA).

3. In Darien, Connecticut, 36 public school teachers were forced to attend a sensitivity training session in June 1969 in order to get credits for increased salaries as instructors in sex education.

One of the teachers forced to participate in the session later reported: "We weren't allowed to talk. Only joy achieved by touch was acceptable. . . Anything that was pleasing to the touch or to the emotions was the thing to do. . ."

"The leaders enjoyed themselves sensually. One trainer. . . never left the side of one young girl, but remained wrapped in a blanket with her at every meeting experiencing joy.

"All outside responsibilities were ignored, or told to be forgotten. Live only for the moment and experience joy.

"Expose yourself to your group. . . Self discipline was not acceptable.

"When my trainer. . . attempted to. . . kiss me - and wouldn't stop trying - I walked out in shock. . ."

4. Body awareness games used in sensitivity training are now being used in high schools. Games involving touching, feeling, smelling, rolling around on the floor, crawling into piles, etc. are being taught to boys and girls together between the ages of 14 and 18 years.

5. Sensitivity classes in public schools include such degeneracy as placing small groups of boys and girls in broom closets with instruction to pet and touch each other.

6. The Federal Government is now financing sensitivity training. In 1967 the U.S. Office of Education started funding sensitivity training for 7th and 8th grade students in the Garden Grove School District of California. A requirement for mandatory student attendance to sensitivity training sessions was attached to the federal funds.

7. Sensitivity training poses grave danger to young people. In Evanston, Ill. a high school English teacher, Thomas Klein, started sensitivity training in his classes. Klein learned part of his sensitivity training at a week-end session sponsored by the National Training Laboratories (subdivision of NEA).

After a few sessions in class, Klein's students started their own sensitivity training course.

One teen age girl became hysterical and abusive to her parents after one session of sensitivity training in her home.

Several other teen-agers who took part in the session said they were unable to sleep that night.

One boy awoke to find himself wandering in the middle of town, several blocks from his home at 3 a.m. He did not remember getting out of bed and leaving home.

Another boy told of being picked up by his playmates at

## IS LEGAL BUSING

H.E.W. Secretary Robert Finch has continued to demand school busing be required in order for local areas to receive Federal funds. Finch's action is in open violation of the Federal law which specifically prohibits busing to achieve racial integration.

## FORCED INTEGRATION

The Supreme Court has just destroyed the freedom of choice school attendance plan. President Nixon's new Chief Justice voted with the other Leftists on the Court to increase race mixing. It's a safe bet that none of the children of Court members will ever attend a mongrelized public school.

2. Addict crime creates tremendous cost to the taxpayers. Washington, D.C. area citizens alone lose \$30 million dollars a year to addict connected crime.


3. Heroin killed 28 people within ten days in New York City alone.

Ever before have children been so violently attacked by their enemies from within their own Nation!

Along with the big educational budget have come a legion of "experts." Every fraud and charlatan who in former times would have been a peddler of snake oil or miracle cures is now a "professional educator."

Whether in powerful trade associations, "professional educators" use the political power thus believed to press their demands upon school districts across the Nation.

## WHAT DANGERS AWAIT YOUR CHILD IN THE PUBLIC SCHOOLS?

The American educational system is being destroyed. The public schools present increasing dangers to your children. The dangers come from many sources. The following are only a few examples of the terror and degeneracy your child will be confronted with in today's schools:

### SOME FACTS ON VIOLENCE

1. A high school vice principal had his throat cut by a former student while chaperoning a dance at a high school in Prince Georges County, Md.
2. A San Bernardino, Calif. high school English teacher suffered a broken rib, concussion and serious chest injuries when he was knocked down and kicked while trying to aid the school principal who was himself fighting off several pupils.
3. A White Brooklyn, N.Y. high school teacher was brutally assaulted by a gang of Black students and later set afire in the hall of the school.

7. Statistics clearly show that racial disorders have the highest number of incidents. In the four month period 132 racial incidents took place in 27 states.
8. The city of Chicago alone reported 1,085 assaults on teachers in 1968. *760 of the assaults were by pupils in grades 1 through 6.*
9. Both the Pro-Marxist National Education Association and the newer more radical AFL-CIO American Federation of Teachers, are opposed to placing police in the schools to maintain order.

## SOME FACTS ON SEX EDUCATION

1. It was suggested at a meeting of the American Association for Humanistic Psychology that *sex education requires teachers who sense and transmit their own sexuality.* Perhaps sex education teachers will have to prove their sexual ability to school principals before they get the job.

Some people attending the meeting advocated *teaching the sex act in class.* Sound fantastic? Remember that *today's liberal sex fantasies are tomorrow's liberal dictated school rules.*

2. Montgomery County, Maryland, sex education teachers will be "selected because they are by character and experience suited to conducting such a program."

6. An Associated Press story told of the parental reaction after a high school teacher sent boys and girls into a darkened room to fondle and caress each other. The students were then supposed to come out and write essays on the sensations they experienced.

7. The ultimate threat from sex education appeared in an article in *Nude Living* (No. 54, Vol. 9, No. 2) written by Iris Bancroft. *Nude Living* is published by Elysium Inc. which is very closely associated with SIECUS (Sex Information and Education Council of the U.S.). The great part of sex education materials used in today's schools comes from SIECUS which is also the strongest force pushing sex education.

The article suggests "SCHOOLS FOR SEX." "Many of the teachers would have to be accepted on the recommendation of others — until we could establish some standards. But such 'good lovers' would be likely to be superior teachers. . . ."

"For health reasons. . . it might be wise to require that pupils refrain from all outside experimentation for the duration of the lessons, in order to protect the teacher. . . ."

"There would be some people who, due to archaic morality, would object to such instruction for themselves or for their children. *But there are already established channels for handling such situations.*"

The intent is clear. "Mental health" concentration camps are to be used for those who will not go along with "Sex Schools."

Today our children are taught obscene language and shown pornography in school. *Tomorrow it is not unrealistic to expect 'sex schools' and 'mental health' concentration camps for decent parents.*

Dr. Roy Brown of New Braunfels, Texas wrote to Jesse Stephens the head of the "New Minutemen" on 20 June, 1971 and offered to get him a membership in Ordre Et Tradition, an anti-communist organization in Portugal. He also informed Stephens that he had to correspond better if he was to get Brown's mailing lists which Stephens has wanted for some time. In the past Stephens has complained about lack of time to write. (copy of letter enclosed).

John Zemanek, National Coordinator of American Volunteer Groups was written to by Dr. Roy Brown. He offered Zemanek memberships in two European anti-communist groups. He also enclosed a tape and some dues money in the amount of ten dollars. (copy of letter enclosed).

James K. Warner the head of the New Christian Crusade Church was written to by Brown. This is a fairly new anti-semite group not connected in any way with Christian Crusade of Tulsa, Oklahoma. From the letters and literature sent out by Warner he is connected with Colonel (Rev.) William Gale, the head of the California Rangers. (copy of letter enclosed).

There is a paper being printed on the campus of Southwest Texas State University, Lyndon Johnson's Alma Mater. It is called Weather Report and is revolutionary in content. The cartoons are reminiscent of the old Communist Daily Worker and the articles are suggestive of SDS Weathermen influence. One of its advertizers is Washington Spring, 1779 Church St., NW, Washington, D.C. which boosts the project "Mayday" and other revolutionary activity. (copy of Weather Report enclosed).

Dr. Billy James Hargis, head of Christian Crusade of Tulsa, Oklahoma is now more desperate for funds than ever. He has his computerized mailing lists sending out pleas for money to people who have quit his organization under unpleasant circumstances. Hargis is officially on the George Wallace for President bandwagon and has offered Wallace the use of Hargis' computer and mailing lists. (copy of a letter enclosed).
