According to the December 7, 1939 issue of the People's World the "International Night in Chinatown" was being sponsored by subject organization at 947 Stockton Street for the purpose of raising funds for the People's World. This function was to take place on December 24, 1939 and would feature Chinese food and entertainment.

The May 23, 1942 issue of the People's World carried a feature regarding the telegram sent by subject organization to the president and signed by SAM YOUNG, which demanded a second front.

The San Francisco Chronicle of October 10, 1949 carried a front page article stating that a meeting held under the auspices of the Chinese Workers Mutual Aid Association at the Chinese Americans Citizens Alliance Hall, 1044 Stockton Street on Sunday night October 9, 1949 was broken up by a group of some 40 young Chinese. According to this article and also another article appearing in the San Francisco Examiner on October 11, 1949, this meeting was held to celebrate the Chinese Communist victories in China.

According to these articles the invaders armed with lead pipes, eggs, and blue dye rushed into the building just at the time WILLIAM KERNER, [redacted] began

to speak. The article stated that the microphone was smashed from KERNER's hand and according to KERNER was thrown at the American Flag. These articles, continuing, stated that the invaders scattered blue dye among the audience and tore down the New China Flag.

The articles further stated that one AL WONG, age 36, of 1940 Fillmore Street, was injured in the melee. [redacted]

Reference is made to my memorandum to you entitled, "Chinese Hand Laundry Alliance, Internal Security - C," dated October 11, 1949, wherein mention is made of a demonstration at San Francisco involving captioned organization. Additional information has since been received which is being set forth below for your possible interest.

The San Francisco "Chronicle" of October 10, 1949, carried a front page article reporting that a meeting held under the auspices of the Chinese Workers Mutual Aid Association at the Chinese American Citizens Alliance Hall, 1044 Stockton Street, San Francisco, California, on Sunday night, October 9, 1949, was broken up by a group of some forty young Chinese. According to this article and other press items, this meeting was held to celebrate the Chinese Communist victories in China.

According to press items, the invaders were armed with lead pipes, eggs and blue dye, and they rushed into the building at the time William Kerner [redacted]

There is also being forwarded to the Bureau as an enclosure a leaflet supposedly containing fifteen names of Chinese Communists. [redacted]

[redacted] this leaflet was distributed in the Chinatown Section of San Francisco on the evening of October 10, 1949. [redacted] does not know who was responsible for the publication or distribution of the leaflet.

The Bureau is requested to make translations of any pertinent material relating to Chinese Communist activities contained in the booklet or the leaflet. Any pertinent information contained in this booklet or on this pamphlet should be furnished the San Francisco Office. The Bureau's attention has been called to a list of the officers of the Chinese Workers Mutual Aid Association supposedly appearing on page one of the booklet and also the article appearing in this booklet by WANG FU-SHIH, [redacted]

Special attention should be given to these two items.

[redacted] supposed that the leaflet being forwarded is the leaflet referred to in the referenced letter, wherein it was indicated that such a leaflet had been published and was being distributed in San Francisco.

The San Francisco Office is continuing to follow the incident reported in referenced letter and, although it appears that the incident has just about run its course without attracting any national publicity, the Bureau will be furnished any pertinent information regarding this matter.

The Bureau may return both the booklet and the leaflet upon the completion of its translation of the pertinent material contained therein.

ReBufile 100-36500 and Bulet to Chicago dated 11/9/49.

[redacted] a part-time Chinese translator of this office, has advised that she has lost the leaflet supposedly containing 15 names of Chinese Communists which was transmitted to this office for translation by referenced Bulet.

[redacted] explained that she was translating another piece of correspondence in the bedroom of her home on March 6, 1950 and had inadvertently placed the envelop containing the aforementioned leaflet on the bed by her desk. Subsequently her two and one half year old daughter came into the bedroom and took a nap. After the daughter had arisen from her nap [redacted] returned to the living room of her home and found the envelop enclosing the aforementioned leaflet lying on the couch. However, the leaflet was no longer in the envelop.

[redacted] immediately questioned her daughter but was unable to learn what the daughter had done with the leaflet. The daughter admitted removing the leaflet from the envelop but she was unable to say what she had done with it. [redacted] then thoroughly searched her house without success. She pointed out that their garbage had been collected during the period when her daughter could have disposed of the leaflet. [redacted] made inquiry at the garbage disposal plant of the village of Glenview, where she resides, and was told that there is no separation of trash and that each load is disposed of as it received at the disposal plant.

b7c [redacted] has gone to considerable effort to locate the leaflet and has expressed regret that she should be guilty of such an oversight. In addition, [redacted] stated that her children can not open the chest where the translation material is stored and further that no repetition of a similar loss will occur. In addition, [redacted] is continuing her search for the leaflet and should it be located the Bureau will be promptly advised.
