liberation because they have the correct leadership of the Chinese Communist Party, which is a political party of the proletariat. He called on the people to continue their struggle to put into realities the eight points for peace demanded by MAO Tse-Tung who really looks after the benefit of the people, by overthrowing the rotten reactionary regimes, destroy the old forces which obstruct the people's progress, liberate the entire nation, and bring Socialism into reality.

Writing on "The liberation of our native country is also our liberation" Liang-Pin (M) Leung-Bun (C) pointed out that the liberation of China will return the governing power to the people, because the people will be freeing themselves from the oppressions of imperialism, feudalism, and bureaucracy.

WANG Fu-Shih (M) WONG Fook-Shee (C) wrote his article "Discussing the construction of New China and talent" to take issue with a remark of HU Shih that the Chinese Communists have no talent and that if they take over China, they will fail in a short time. WONG pointed out that the pioneering experience of the Soviet Union had shown the power of the people to overcome all obstacles. He urged all Oversea Chinese to prepare themselves to quickly learn some skill and return to China to build up a new society to show-up HU and others that they are all wrong.

Writing on "The death bell for the CHIANG dynasty is tolling" YU Lo-San (C) YEE Lork-Sam (C) pointed out some of the wrongdoings of the Kuo Min Tang government and expressed his opinion that the victory of the Chinese Liberation Force was due to the fact that they satisfied the needs of the people.

The eight laws of the Chinese People's Liberation Force were the laws contained in the order issued by MAO Tse-Tung and CHU Teh on April 25, 1949, to direct the actions of the Chinese People's Liberation Force and to call on all the people in the nation to obey. These laws called on the soldiers to protect the people's property, protect all public institutions, refrain from seizures and swindles, and other molestations, and called upon them to confiscate bureaucratic

property, punish the reactionaries and war criminals, and give to foreigners full protection. The complete text of the order was published.

The airmailed message congratulating the ~~Chinese~~ People's Liberation Force on their brilliant victories was sent on April 25, 1949 by four Chinese organizations in San Francisco. They were:

The message was addressed to MAO Tse-Tung, Chairman of the ~~Chinese Communist Party~~, CHU Teh, Commander-in-Chief of the Chinese People's Liberation Force, and all the soldiers, read as follows:

"The Kuo Min Tang reactionary government has rejected the peace proposal. The one million strong army of the Chinese people successfully crossed the river in one day and liberated Nanking in three days. The brightness for South China is not long in coming, and the unity of the entire nation will soon arrive. All of us overseas who hear the news are greatly overjoyed. We especially send you this telegram to congratulate you on your victory and to offer you our regards. From now on, the task of exterminating the remnant forces, punishing the war criminals, establishing the government, and carrying on the construction work will depend on you, to guide the people of the nation in expending their

fullest effort to go forward. We shall support you with all our efforts. Furthermore, as our great forces were crossing the river, the British battleship fired on the northern banks of the Yangtze. This act not only obstructed the progress of the Liberation Force, but also violated our territorial integrity. We are extremely angry at hearing such news. Luckily, the gunmen of our Liberation Force gave them heavy blows with their god-like skill. The cables report that our side will demand that Britain compensate us for the losses. We feel that that was a proper act. We swear to give you full support. We send you our revolutionary respect."

The remainder of the publication was devoted to news about the feelings of the Oversea Chinese against the British, the opposition to the JUDD Bill before the U. S. Congress (H. R. 199, 80th Congress), and the progress of the Liberation in Kwangtung, especially the Sze Yup areas.

(b.) Anniversary Celebrations

The October 5, 1951, issue of the "China Daily News" reported that on September 30, 1951, the California Chinese Workers Cooperative Association held a celebration to commemorate the second anniversary of the Chinese People's Republic and the fourteenth anniversary of the association. Attending the celebration were representatives from both American and Chinese organizations. The article reported that some of the representatives included Miss AI-NA (ph) from the Civil Rights Congress (CRC), Dr. IO-BUT (ph) (could be ROBERT) from the School of Labor (Liberal), CHIEH Wing-chang, aka HSIEH Jung-chung (6200/2837/1813) from the Chinese American Democratic Youth League (CADYL) and other representatives from the Seaman's Union, who delivered speeches. The article reported that the speeches were interpreted by LEE Chung-tong, aka LI Chung-t'ang (2621/0112/1016).

The October 11, 1952, issue of the "China Daily News" on page 5 also reported that the California Chinese Laborers Cooperative held a celebration in honor of the third anniversary of the Chinese People's Republic and its own fifteenth anniversary. This celebration was held in San Francisco on October 5, 1952.

On this occasion ~~HUANG Hsia-li (M)~~ ~~WONG Ha-lei (C)~~ (7806/1115/2746), made a speech pointing out that "on this great day every patriotic fellow Chinese should celebrate the event with enthusiasm. Today's fatherland has not only eliminated the feudalistic, treacherous, bureaucratic, capitalism, which rode over the heads of the people, but it is also developing with daily increasing speed, various kinds of reconstruction, both cultural, educational, economic, industrial, and commercial."

On this occasion also a Mr. ~~BARIBANO~~ spoke as a representative from the ~~American Independent Progressive Party~~. He advocated stopping the Korean War and putting into effect fair employment laws, opposing racial discrimination, and abrogating the Smith Act.

The October 11, 1952, issue of the "China Daily News" also reported that at the anniversary celebration of the CWMAA held on October 5, 1952, a speech was made by a representative of the Democratic Youth League in San Francisco, who said that the brotherly friendship between the Chinese Laborers Cooperative and the Democratic Youth League and their spirit of cooperation henceforth would become stronger and stronger. *Call*

A translation of the CEN issue of October 6, 1955, reflected the following article which appeared on page 5 under the title "San Francisco News Report":

"The California CWMAA is a large overseas Chinese organization with members spread throughout the State. On the evening of October 2, this organization held a great celebration to celebrate the 6th anniversary of the People's Republic of China and the 18th anniversary of the founding of the organization. A large number of overseas Chinese participated in the festive occasion.

"The ceremony began with the Chairman's opening address followed by a speech by Miss LU Mu-te (M), LUK Mo-tuck (C), 7120/1970/1795, Editor of the 'Far East Report' (literal translation), who gave an account of the forging progress made by China since her establishment six years ago and China's contributions toward peace in Asia and the world. She also pointed out that at the present time there are 28 nations which have established diplomatic relations with Red China and 60 nations which are presently carrying on trading and cultural relations with China. She stated that the American people, and even certain portions of the United States Government personnel are urgently appealing for trade with New China to forestall impending economic disaster...."

The San Francisco News, issue of March 7, 1956, page 10, carried an article which stated that LIM AH FOO had testified before the Federal Grand Jury on March 6, 1956. This article stated that LIM AH FOO, a busboy, was questioned about the CWMAA, of which he was once secretary. According to the article, LIM stated the organization was dissolved in 1945 and that it had been a sort of clearing house for Chinese who worked in the Alaska fish canning trade.

It is noted that on March 20, 1956, U. S. District Judge OLIVER CARTER, San Francisco, ruled the Chinese organizations did not have to answer the subpoenas to produce their records inasmuch as these subpoenas were "unreasonable".
