At 8:25 AM, the writer telephonically contacted Assistant to the Director L.V. BOARDMAN, and requested authority to develop a highly confidential source at the residence of [redacted] NY, NY Apartment [redacted] which is located on the [redacted] floor.

Mr. BOARDMAN was informed that [redacted] was contacted by agents, was cooperative, and did not know the identity of the agents who contacted him as agents. It was developed that [redacted] had been gone from their apartment for the past [redacted] weeks and it was believed that they were in [redacted]. It was ascertained that some individual, identity unknown, picks up the [redacted] mail periodically at infrequent intervals of every week or so. It was ascertained that there are three other apartments on the [redacted] floor of these premises, and that the persons occupying the apartments are out most of the day.

Mr. BOARDMAN was advised that we have two agents who know [redacted] and if his wife and he appeared in the area, they would contact him on the street and interview him. It was anticipated that we would have sufficient personnel in operation and through the use of wackie-talkies, would be able to notify the agents who were developing the confidential source, SA [redacted] being in charge of this assignment.

Mr. BOARDMAN was assured that we guarantee security and that we hoped to obtain information concerning contacts [redacted] and a photograph of him since one was not presently available. Mr. BOARDMAN was advised that it was anticipated that this development would take place about 9:30 AM today.

Mr. BOARDMAN authorized the development of this confidential source, requesting that he be advised later if there were any significant developments.

I. BACKGROUND

The CHLA was chartered in 1933 to render legal and protective services to its members who operate laundries in the New York City area.

[redacted] advised on June 20, 1957 that the CHLA was infiltrated and controlled by Communists during the 1930's and most of the Communists who gained control of the CHLA are still in control of it at the present time.

A confidential informant who has furnished reliable information in the past on March 25, 1955 advised that when he was last conversant with such activity in 1952, a group of persons within the CHLA, whom he described as Communists, had as their purpose the furtherance of Chinese Communist interests in the New York City area by operating through the CHLA.

The October 12, 1949 issue of the "China Daily News" (CDN) reflected that at a meeting held at CHLA headquarters in New York City on October 9, 1949 to celebrate the founding of the "Peoples Republic of China" as well as to celebrate the Chinese National holiday the five star flag of the "New Government" was flown and expressions of loyalty and support thereto were voiced by speakers.

II. LOCATION

The CHLA is located at 191 Canal Street, New York City, and utilizes the entire second floor of that loft building.

The highly confidential and anonymous source will be contacted at that address.

III. SECURITY ASPECTS

The building at 191 Canal Street is a six story brick loft building structure. The CHLA occupies the entire second floor. The other occupants of the building are as follows:

From then until the end of the survey the CELA was in complete darkness and no further activity was noted.

It is contemplated that physical surveillances will be placed on the CELA from 9:00 pm until 8:00 am for two days prior to the development of the contemplated source, and from 9:00 pm on the evening before up through the development of the source. Spot telephone calls will be made to the CELA at various times in the early morning hours in order to determine if anyone is in there.

It is believed that the best for the assignment to take place is between the hours of 2:30 am and 4:00 am, on a weekday morning.

Security will be assured prior to entry on this operation.

#### IV. PURPOSE OF THIS ASSIGNMENT

It is expected that the highly confidential and anonymous source will make available both membership and financial statements of the CELA. It is also expected that the official relationship between the CELA and CDN as well as the general Chinese Communist activity in the New York area, will be established. It is also felt that this source will establish that liaison exists between the "Peoples Republic of China", and the pro-Communist element in the United States. This source may also disclose any official connection between the CPUSA and the pro-Communist Chinese groups in the United States.



The following is a summary of the attempts to develop highly confidential anonymous sources and misur coverage in connection with the Top-Hoodlum Program.

As the Bureau is aware [redacted] was developed and contacted on 12/13/57 at the apartment residence of [redacted] [redacted] resulted in the obtaining of valuable information in that case. At the time of the development of this source consideration was given also to the possibility of misur coverage of the apartment, however, it was ascertained through pretext interview of the building superintendent that the latter, although not hostile, was uncooperative and could not be relied upon to render any assistance whatsoever either in developing a highly confidential anonymous source or in effecting misur coverage. The highly confidential anonymous source was developed without the cooperation or even the knowledge of the superintendent and the presence within the premises therefore necessarily was and would have to be of a short duration. This circumstance together with the uncooperative superintendent and the fact that there is no available glass-by suitable apartment which could be utilized as a plant suggests the possibility of a misur at this time. However, consideration will be given to an additional future contact of [redacted] and in the event of changing circumstances to future misur coverage.

In connection with the development of highly confidential anonymous sources and the effecting of misur coverage discreet surveillances of Top-Hoodlum subjects have been conducted on a continuing basis. As a result of these surveillances several hang-outs of the subjects surveilled have been determined as well as associates identified through car registrations. Information concerning these results has been set out in the weekly summary airtels. In addition, information concerning their employments and business establishments has been obtained and this data is being checked for the possibility of developing highly confidential anonymous sources at these places.


