I. BACKGROUND

The National Office, the New York Local, and various publishing ventures of the Socialist Workers Party (SWP) have their headquarters on the second, third and fourth floor of 116 University Place, New York City. Party records, correspondence, membership lists, etc. are maintained on these premises. The Bureau has recently instructed that all offices with active SWP branches under investigation should intensify their investigations in view of the recent examples of the SWP seizing the initiative from the CP in some fields.

II. SECURITY ASPECTS

The building at 116 University Place is a four story building with the Sherbee Antique Shop occupying the ground floor (with its own entrance) and the SWP occupying the upper floors. The Sherbee Antique Shop is not open on Sundays and it has been found that foot and vehicle traffic in the neighborhood is at its least on Sundays.

It is contemplated that entry will be made on 4/19-20/59, by use of key previously obtained to SWP headquarters. Security will be assured prior to entry. After entry is made, the entrance to the building will be made secure. Security guards will be discreetly placed outside the building and will be in radio contact with agents developing this source.

It is noted that sources at SWP headquarters, [REDACTED] and [REDACTED] were developed on 11/22/58 and have been successfully contacted since.

III. PURPOSE OF ASSIGNMENT

The Bureau has recently instructed that all offices with active SWP branches under investigation should intensify their investigations in view of the recent examples of the SWP seizing the motive from the CP in some fields.

II. SECURITY ASPECTS

The building at 116 University Place is a four story building with the Sherbee Antique Shop occupying the ground floor (with its own entrance) and the SWP occupying the upper floors. The Sherbee Antique Shop is not open on Sundays and it has been found that foot and vehicle traffic in the neighborhood is at its least on Sundays.

25 It is contemplated that entry will be made on Sunday, 1/20/59, by use of key previously obtained to SWP headquarters. Security will be assured prior to entry. After entry is made, the entrance to the building will be made secure. Security guards will be discreetly placed outside the building and will be in radio contact with agents developing this source.
