

For the information of receiving offices, plaintiffs, the Socialist Workers Party (SWP), its youth group, the Young Socialist Alliance (YSA), and fifteen individual plaintiffs, filed captioned civil action during 7/73, alleging that defendants, the FBI, other Governmental agencies and officers, have denied them constitutional rights as a political party. They seek substantial damages as well as broad injunctive relief.

As part of pretrial discovery proceedings, the Bureau has released a number of documents to the plaintiffs. We are still attempting to locate any documents which may exist relating to surreptitious entries or "bag jobs" which may have been perpetrated against the plaintiffs. We have already advised the plaintiffs that there is no central index, file, or document listing surreptitious entries directed against domestic organizations. The reporting of information from such entries was designed to conceal the method by which the information was obtained. Because such information is not retrievable at Headquarters, it is necessary for each office which may have documents relevant to this lawsuit to conduct reviews of their own records.

Specifically, the plaintiffs have requested "all documents relating to any intelligence gathering burglaries perpetrated by or with the knowledge of the FBI against the SWP, the YSA, or anyone suspected to be a leader or member thereof."

However, Los Angeles responded to all the above allegations in an airtel to the Bureau dated 8/2/73. No mention was made in this airtel to [REDACTED] which pertained to the photographing of documents in the residence of [REDACTED] Los Angeles, on 4/30/60, because there was no mention made in the complaint of the photographing of any documents and because there was no separate entry into [REDACTED] residence to photograph the documents. The photography was done at the same time that entry was gained to install [REDACTED]. Hence, Los Angeles has reported all known surreptitious entries. It is also pointed out that the photographing of documents was not considered as an act of "burglary" by SA [REDACTED] inasmuch as no object of value was removed from the residence of [REDACTED].

There may have been a misunderstanding of the semantics involved in the terminology of "burglary" in 1973, as opposed to the present usage in 1976, of the words "surreptitious entries."

The last paragraph on page two of aforementioned Bureau airtel dated 8/9/73 reads as follows:

"Concerning allegations made in the complaint regarding wiretapping and general allegations regarding commission of illegal acts by defendant public officers and their agents, a separate communication will be sent at a later date to all offices for information with which to answer these allegations."

In view of those instructions from the Bureau indicating that additional information would emanate from Bureau Headquarters as to how to answer the allegations, Los Angeles continued to wait for such; which were not forthcoming until 1/8/76. Upon receipt of those instructions, Los Angeles conducted the necessary file reviews which resulted in Los Angeles airtel dated 1/22/76.

Concerning allegations made in the complaint regarding wiretapping and general allegations regarding commission of illegal acts by defendant public officers and their agents, a separate communication will be sent at a later date to all offices for information with which to answer these allegations.

NOTE:

This concerns a law suit filed on 7/18/73 by SWP and other plaintiffs against the Attorney General of the U.S. and numerous other defendants, including the Director of the FBI. This law suit requests damages in excess of 27 million dollars and further requests an injunction restraining defendants from interviews of SWP and YSA members, development of informants, mail covers, electronic surveillances and burglaries of these members. Suit also requests that SWP be stricken from the Attorney General's list of subversive organizations.

Details concerning this law suit were furnished in memorandum dated 8/8/73 from R. L. Shackelford to Mr. E. S. Miller. In that memorandum it was noted that request for information would be made to those offices covering locations where specific allegations were made in the complaint. This is being done by instant communication. At a later date, we will survey all offices concerning electronic surveillance and illegal acts generally alleged in the complaint.

This matter is being coordinated with the Office of Legal Counsel (OLC), which has furnished summons and complaint in this case to the Department of Justice. Allegations 8, 10 and 17 of the SWP Class Action Suit indicates CHRISTY WALLACE, MACEO DIXON and CHARLES BOLDUC are plaintiffs.



It is noted, however, that on various occasions during investigations of individuals, Houston has obtained information relative to change of addresses for various YSA and SWP members from the U. S. Postal Inspector's Office, Houston, Texas.

- e. Complaint, page 17, paragraphs 73 and 74, reflects that a bomb exploded on 3/12/71 at the campaign headquarters of the SWP, Houston, Texas, terrorizing campaign workers, destroying valuable papers and otherwise disrupting campaign activities and that agents of the FBI and other agencies had foreknowledge of the bombing, its planning and execution.

Houston Comment:

SWP headquarters, 3806 Wheeler Street, Houston, Texas, was actually bombed during the early morning hours of Friday, 3/12/71. This case was investigated by the Houston Police Department and the U.S. Alcohol, Tobacco and Firearms Unit, Houston, Texas. In June, 1971, a Harris County Grand Jury investigating terrorist acts in the Houston area, returned a two-count indictment against Klan members LOUIS RAY BBAI, JR., and PETE LOOT, JR. for possession of a bomb and injuring property.

On 3/29/73, Assistant District Attorney for Harris County, Texas, WARREN WHITE, advised that these indictments against BLM and LOUF have been dismissed. NOTE:

In connection with the SWP/YSA civil suit, the New York Office caused a search of their records and located a number of documents relating to surreptitious entries conducted by that office. These records dated from the 1940's through 1975 and therefore fall within the period of time of interest to the Civil Rights Division.

By teletype of April 5, 1976, New York's Internal Security Division furnished results of its review of the above documents as they relate to entries in the domestic security area.

We are now asking New York to review the same documents for entry activity, from January 1, 1966, to the present, in the counterintelligence area. This communication follows a telephonic conversation with New York Supervisor [REDACTED] who advised SAC Denz was aware of FBIHQ's oral request for entry information and had requested in confirmation a communication from Headquarters.

Attached for recipients are copies of two memoranda: Bulet to Assistant Attorney General (AAG), Civil Rights Division, February 5, 1976, and the AAG, Civil Rights Division, response thereto dated February 24, 1976, both captioned as above.

For several months, the AAG, Civil Rights Division, Department of Justice, has been conducting an inquiry at the instruction of the Attorney General into FBI investigative matters which involved surreptitious entries. The Civil Rights Division has advised that the purpose of the inquiry is to determine if any of the entries conducted under authority of the FBI constitute a violation of Title 18, U.S. Code, Sections 241 and 242. Section 241 concerns conspiracy against the rights of citizens and carries criminal penalties of a fine of not more than \$10,000 or imprisonment of not more than 10 years, or both. If death results, the penalty is imprisonment for any term of years or for life. Section 242 concerns deprivation of rights under color of law and carries criminal penalties of a fine of not more than \$1,000 or imprisonment of not more than 1 year, or both. If death results, imprisonment for any term of years or life.

In a request of January 20, 1976, the Civil Rights Division asked that FBIHQ inquire "of all present Bureau personnel at the level of SAC or higher in the field and Section Chief or higher in Headquarters, their complete and full knowledge of any and all break-ins or surreptitious

entries performed by Bureau agents or by others with prior or subsequent knowledge by your agents, since January 1, 1966." The officials cited are asked in this request to provide "personal communications" in response to the inquiry. The "personal communications" will be forwarded to the Department as received.

Field personnel at the level of SAC and higher should promptly sunitel their response under the caption "Request of the Assistant Attorney General, Civil Rights Division, For Information Concerning Surreptitious Entries." Response should be based on your knowledge of entry activity, including entries in connection with installation of electronic surveillance, feasibility surveys, and entries to collect information, i.e. "bag jobs." You should respond with your recollections, however incomplete.

You should use the following in responding to this inquiry, and responses should be in the first person:

3. If you have pertinent information you should submit whatever details are recalled, including pertinent dates targets, and file number(s) where information might be located. For instance, if you recall an entry, the date and place of the entry, and the case Agent or Field Supervisor handling the case

but not the subject of the entry, you should make an effort to identify the case through the case Agent or Supervisor. If those sources are unavailable, you should report what information you do have. Reference is made to your memorandum dated January 20, 1975, your reference JSP:WLG:vap, captioned as above.

The following concerns Item 1 of your memorandum; Items 2 - 14 will be answered by separate communication.

You requested that I inquire of all present Bureau personnel at the level of Special Agent in Charge (SAC) or higher in the field and Section Chief or higher at FBI Headquarters concerning "their complete and thorough knowledge of any and all break-ins or surreptitious entries performed by Bureau Agents or by others with prior or subsequent knowledge by your Agents since January 1, 1960." You also requested that these Bureau officials respond to this inquiry with personal communications rather than by letterhead memoranda.

Before initiating this inquiry, I would appreciate having your advice on exactly what information should be provided to each Bureau official contacted concerning the purpose of the Department's investigation and the possible consequences arising from the responses of these officials to this inquiry.

In your memorandum dated January 20, 1976, you stated that the inquiry was made in order to fully respond to the Attorney General regarding the scope of the Bureau's use of break-ins or surreptitious entries. Your memorandum dated August 19, 1975, indicates that the Department was conducting inquiry to determine whether any of the surreptitious entries conducted under the authority of the FBI constitute violations of Title 18, United States Code, Sections 241 and 242. If the Department is currently contemplating possible criminal prosecution of FBI personnel involved in surreptitious entries, I believe, in the interest of fairness, we should advise our officials that this is the purpose of the Department's current inquiry.

It also appears that disclosure of the identities of FBI personnel involved in surreptitious entries could result in civil litigations in which our personnel would be defendants. If you agree that such civil litigation is a significant possibility, then I believe that we should so advise the FBI officials to whom we direct this inquiry. In that connection, I would appreciate a statement from you regarding the position of the Department of Justice on providing representation for FBI personnel in civil litigations arising out of surreptitious entries made in the scope of FBI employment in order that this information may also be furnished to personnel concerned.

With due regard for the effect of this inquiry on morale in the FBI, I would, of course, like to advise our personnel as fully and as appropriately as possible, and your advice is solicited in furtherance of that objective.

In response to a January 20, 1976, request of the Civil Rights Division, Department of Justice, referenced communication asked all field offices personnel at SAC level and higher to furnish their knowledge as to "any and all break-ins or surreptitious entries performed by Bureau agents or others ...since January 1, 1966."

A recent court order in the Socialist Workers Party (SWP) civil action against the Attorney General, et al., asked that the FBI produce materials relating to intelligence gathering burglaries directed against the SWP. Subsequent to that order, an all-office communication instructed that any materials of this nature be brought to the attention of FBIHQ. The ensuing search of field office records resulted in the discovery in a small number of offices of documents relating to surreptitious entry activity of those offices. These documents, relating not only to entries against the SWP, were, in one office, in the form of unserialized, chronologically ordered "SAC Folders." Much of the activity noted therein occurred prior to January 1, 1966; however, there were materials concerning entries conducted subsequent to that date and therefore falling within the period of inquiry established by the Civil Rights Division.

Accordingly, you are instructed to take the necessary steps, including consultation with knowledgeable personnel within your office, to determine whether or not similar

Reference is made to your letter of May 11, 1976, in which you ask for information concerning articles appearing in the May 11, 1976, editions of the New York Times and the Washington Post relating to published reports of the SSC.

The Times article states "at least 491 surreptitious entries (were made) between 1960 and 1975 to install listening devices in the homes or offices of criminal suspects, and that 509 microphones had been surreptitiously installed by the bureau in domestic intelligence cases during the same period."

Our memorandum of October 17, 1975, to the SSC, a copy of which was furnished to your office, provided statistics showing 491 entries from 1960 to 1975 to install microphones in criminal investigations. From 1960 through 1965, there were 394 such entries; from 1966 through 1968, there were none; and from 1969 through June, 1975, there were 97. These 97 entries were conducted pursuant to court order in accordance with provisions of Title III, Omnibus Crime Control and Safe Streets Act of 1968.

The Times statement that 509 microphones had been installed in domestic intelligence cases is incorrect. Our memorandum of October 17 stated that there were 509 microphone installations "in connection with targets of counterintelligence internal security, and intelligence collection investigations." On May 11, 1976, a survey of material used as a basis for our October 17 memorandum to the SSC showed that over 50 percent of the 509 microphone installations were in connection with foreign counterintelligence and foreign intelligence collection investigations.

The Post statement appears to refer to the 509 microphone installations mentioned in the Times article. A breakdown of these 509 installations shows: from 1960 through 1964, there were 245 installations; in 1965 there were 59; and from 1966 to June, 1975, there were 104. Some of these installations did not involve surreptitious entry but were accomplished by encapsulation or installation prior to occupancy.

Our records show no warrantless surreptitious entries conducted for installation of microphones against "internal security" targets following the "Keith" decision of June, 1972. As you are aware, however, the Civil Rights Division has been conducting an inquiry into certain FBI investigative matters which, we have determined, involved warrantless surreptitious entry not in connection with microphone installation against domestic security targets as late as April, 1972.

DETAILS:

On 4/20/76, Mr. William L. Gardner, the Civil Rights Division's Attorney handling the Department's inquiry into investigative matters where surreptitious entries were made, requested he be furnished a copy of R. W. Smith to Mr. W. C. Sullivan memorandum of 7/12/66 captioned "Microphones-Policy Brief."

The Smith memorandum is a lengthy, in-depth study and history of the Bureau's policies in the use of microphone surveillances. It examines the question of trespass, cites significant court decisions, shows guidance furnished by the Department, and outlines our interpretation and application of those guidelines. In addition, the memorandum details our considerations with respect to use of microphones in organized crime and criminal intelligence investigations and, in considerable detail, sets forth data showing the knowledge Attorney General Robert F. Kennedy had of our use of microphones in organized crime investigations.

Mr. Gardner reviewed the Smith memorandum on 4/20/76. This review was authorized by memorandum F.J. Cassidy to Mr. T.W. Leavitt, "Surreptitious Entries," 4/5/76.
