





A person is placed in these albums for prominent extremist activities and possible travel. He may be deleted for various reasons, generally that he is no longer active. However, there is no guarantee he might not in the future come to the attention of some office outside his normal residence, with resumption of extremist activities. It seems a mistake to destroy the information, unless he is deceased.

The main advantage would be keeping the pertinent information and photo available, to aid investigation and evaluation if the name should arise. No estimate of monetary savings can be made; the savings would be in investigative time and communications costs.

From past experience, the Madrid Office does not feel that our operational capacity abroad requires the continued use of the albums presently in our possession. The infrequent use of these albums is not commensurate with the time required for keeping them up-to-date. In addition, these albums occupy considerable space in our limited number of file cabinets, this being particularly true of the Extremist Photograph Album, which consists of six volumes approximately two inches thick each. Also, in case of an emergency where our files would have to be destroyed, these albums would consume considerable destruction time.

INTELLIGENCE DIVISION ADDENDUM, 12/11/73, [REDACTED] 7C

This suggestion proposes that Forms FD-432 and 432a (relating to the Extremist Photograph Album and the [REDACTED] be [REDACTED] 61) revised to allow for entries indicating the subject is a Potential Police Attacker (sic) and/or is on the Extremist Bureau Fugitive List. Suggestion is unfavorably recommended. Potential Police Assassin is a category handled by Division 9 and it is not believed this item should be imposed on a Form dealing with extremists and [REDACTED] handled in Division 5. No useful purpose would be served. In addition, we definitely believe that a subject's fugitive status should not be a factor with regard to either of these Forms. In fact, current instructions make it clear that the Extremist Photograph Album is not to be used as a device for identifying fugitives. Whether or not an individual is a fugitive could fluctuate from day to day and thus our Extremist Photograph Album could include erroneous information in this regard for an extended period of time.

Since these albums were furnished to Tokyo, we have derived practically no benefit from them, and have devoted an estimated 200 hours of clerical time to their maintenance, including indexing.

The greatest burden has been making minor corrections, additions and deletions in the Weatherman and Extremist Photograph Albums, including data on education, address, office of origin, category, type of automobile driven, etc. -- which is practically worthless to a Legal Attache. This was pointed out in a Suggestion by this office on 6/28/72, but Bureau was not at the time able to adopt this suggestion (to furnish only major changes to Legats) because more work would have been entailed at FBI Headquarters.
