

MEMORANDUM FOR THE ATTORNEY GENERAL

In re: International Criminal Police Commission Meeting.

I am returning to you herewith the letter from Mr. Carr, Assistant Secretary of State. Presumably any of the members of your Advisory Committee on Crime would be eligible for nomination as delegates to attend the meeting of the International Criminal Police Commission referred to in Mr. Carr's letter. Just who might be willing to accept such a designation with the understanding that he should pay his own expenses is, of course, a difficult question to answer. William Dwyer Lewis told me at the time of the meeting of the Advisory Committee that he expected to go to Europe shortly after the meeting of the American Law Institute, so it is conceivable that he might be willing to extend his trip long enough to attend the meeting in Copenhagen. Presumably any of the outstanding law school men would be free at that time of the year as most of the schools close about the middle of June.

Dean Pound is, of course an outstanding authority, Thorsten Sellin of the Department of Sociology of the University of Pennsylvania is an outstanding authority in this field. He was a delegate to your Crime Conference in December, he is the editor of the Annals of the American Academy of Political and Social Sciences and has an international reputation as a criminologist. Perhaps Chief Siccardi might be interested in attending, especially in view of the fact that the meeting is featuring police work. From the Department of Justice I would assume that J. Edgar Hoover would be the most

MEMORANDUM FOR THE DIRECTOR

The Executives' Conference considered the contents of a letter brought up by Mr. Schilder dated April 10, 1935, from the International Bureau at Vienna containing an offer to distribute for the Bureau in the "International Public Safety", the periodical issued by the International Bureau, information concerning badly wanted Bureau fugitives.

The Conference was of the opinion that it would be advisable and possibly advantageous to the Bureau to accept the above offer, even though the Bureau itself has forwarded copies of the Identification Orders to the principal bureaus reached by the said publication.

The suggestion was made by Mr. Schilder that possibly some financial assessment or other obligation might be attached at a later date to this activity.

The Conference, however, felt that this problem could be solved when it arose; that even though some cost might be involved later in connection with this activity it would be advantageous for the Bureau to have its fugitives listed in the International Public Safety organ.

In the event you concur, there is attached a memorandum addressed to Mr. Edwards advising the offer should be accepted.

I beg to acknowledge the receipt of your letter of April 13, 1935, your Int.B.12/35, wherein you refer to the cases of Volney Davis and three other individuals whose fingerprints were dispatched to you recently by the Bureau. I desire to thank you for the information you have furnished relative to these matters.

I would like to convey to you also my deep appreciation for your kind offer to publish the descriptions with the photographs and fingerprints of these persons in your periodical, "International Public Safety". In compliance with the suggestion contained in your letter, I am transmitting to you under separate cover 49 additional photographs of William J. Harrison, Harry Sawyer and Harry Campbell, Davis now being in custody. I am sending duplicate original photographic copies of our fugitive circular or identification Order concerning these persons in the belief that the glossy finish of these photographic copies possibly would enable better reproductions to be obtained in your periodical.

You may be assured that if any of these persons is arrested, appropriate steps will be taken to secure his extradition to the United States.

Would you kindly advise me whether photographic reproductions of our fugitive circular would be required in the future to enable the publication of their fingerprints, photographs and descriptive data in your periodical. I definitely concur in the impression that it is highly advisable to give this fugitive information widespread circularization and I assure you of my intention to afford you the best information available in these cases.

MEMORANDUM FOR MR. TOLSON

Re: International Criminal Police
Commission.

The entire file in connection with this organization is attached hereto.

It will be observed from the tickler copy of your memorandum from the Director to the Attorney General, under date of May 13, 1935, that on that day the Director suggested either Mr. Bruce Smith or Mr. Leonard Harrison, both of New York City, as gentlemen who might be considered qualified to represent the Department of Justice at the eleventh annual meeting of the Commission to be held at Copenhagen, Denmark, from June 17 to 20, 1935.

The history, purposes and functions of this organization, according to a statement enclosed with a letter from the Department of State, addressed to the Attorney General under date of March 26, 1935, shows:

The International Criminal Police Commission was founded on the occasion of the International Police Congress which convened at Vienna in 1923, and has for its object the furnishing of a practical basis for the organization of international cooperation of police authorities with a view to suppress international crime and to curb the activities of international criminals. The Commission is described as a permanent working committee composed of representatives of the States (countries) interested in the work of the Commission.

The following countries are represented on the Commission by official delegates: Austria, Belgium, Bulgaria, Chile, the Czechoslovak Republic, the Free City of Dantzic, Denmark, Finland, France, Germany, Great Britain, Hungary, Ireland, Italy, Latvia, Lithuania, the Netherlands, Norway, Poland, Portugal, Rumania, Spain, Sweden, Switzerland, Turkey, and Yugoslavia.

A number of prominent criminalistic experts of these countries

participate in the work of the Commission as extraordinary members, and these experts are supposed to work with the offices of the International World Police with headquarters in New York. The Commission, without citing examples, claims to have enjoyed many successes, and states that they have been especially successful in the suppression of counterfeiting.

The Commission states that many of the countries belonging to the Commission have established offices which are in close relation with the International Central Offices in Vienna at the seat of the Federal Police Directorate of Vienna, which is apparently maintained as a Federal criminal clearing house of criminal data by the Austrian Federal Police. Some of the branches of the Federal Police Directorate include the International Central Office for the Suppression of Counterfeiting Currency, Cheques and Papers of Monetary Value; the Information Service concerning International Criminals; the Service of International Research; the International Register of Persons Detrimental to Society; the International Bureau for the Transmission of Fingerprints and Photographs of International Criminals, and the International Central Office for the Suppression of Forging Passports. By exchanging criminalistic material concerning international criminals, the central offices are said to do very useful work. Two special publications, one in English and one in German, are sponsored by the Commission, the title of the English publication being "International Public Safety".

Two International Police Congresses were sponsored by the Commission, the first in Berlin in 1926, and the second in Antwerp in 1930. Ten additional meetings have been held as follows: Vienna - 1924, 1926 and 1930; Berlin - 1926; Amsterdam - 1927; Berne, Switzerland - 1928; Antwerp, Belgium - 1930; Paris - 1931; Rome - 1932; and Vienna - 1934.

The Commission states that the League of Nations is also interested in the work of the International Commission, but does not claim that the International Commission has any connection with the League.

Ever since the foundation of the Commission, as set forth above, it has had its headquarters in Vienna, Austria. The present Police President of Vienna is the President of the Commission. He is Dr. Michael Skubl, Police President and Director of Public Safety, Vienna, Austria. He is at present assisted by seven Vice-Presidents, who are the representatives of Denmark, France, Germany, Holland, Hungary, Rumania and Yugoslavia. In addition, he is assisted by an administrative committee composed of two Permanent Reporters, one from

Brussels, and one from Vienna, and ten Ordinary Reports from various countries represented on the Commission. The expenses of the Commission, which are stated to be small, are taken care of by contributions from the countries represented, on the basis of one Swiss franc (about 25 cents) for every ten thousand inhabitants of the country represented.

A memorandum to you from the Director, under date of September 26, 1932, records a telephone call which the Director received from Mr. Barron Collier at New York, inviting the Director to attend the annual meeting of the Commission to be held in Rome, Italy, October 15 to 20, 1932, which the Director declined.

On January 3, 1929, the Bureau received through the Attorney General, notice of the annual convention which was held at Berne, Switzerland, during September, 1928.

I have studied the program of this particular meeting, which is set out in detail, and it impresses me that the discussions and activities of the Commission deal almost entirely with the technical and scientific phases of crime detection. Several foreign publications dealing with these subjects are set out in the program.

It is my idea, after a review of the entire file, that the organization, while probably not very practical in its activities, nevertheless is a good one, and that it might be worth the while of the Director to attend the Copenhagen, Denmark meeting in person.

In this connection, I suggest that the Director might desire to communicate directly with Mr. Barron Collier at New York for more detailed information concerning the Commission, since Mr. Collier's recently organized organization, known as the International World Police, is apparently the American representative of the International Criminal Police Commission.







My dear Director Hoover:

It has been a genuine pleasure to hear from you from time to time and thus to appreciate your thoughtfulness both as to keeping in touch with an old friend and keeping him in touch with your very interesting developments.

I have had the pleasure of conferring from time to time with one of your many friends and correspondents, Police President Welhaven of Oslo. He is a fine fellow and extremely intelligent, both as to his own national police problems as well as those of countries abroad. I was interested to discover in our first conversation that he was so familiar with the latest developments of your organization, whereupon we discussed you and the wonderful work you have been doing, and I find that he was in constant correspondence with you. When, on January 24th, I received your welcome letter, and the enclosed discussions of "finger prints," I brought it down to his office to discuss the details with him. He expressed sincere interest in the work you are accomplishing and his appreciation of your fine cooperation with his own Bureau.

I shall now have the pleasure of discussing with him the enclosure entitled "Local Law Enforcement in Relation to National Crime", attached to your letter of the 15th. The last time we met, President Welhaven and I talked much of you - so your "ears must have burned to the boiling point." We both agreed that it would be a fine thing for the forthcoming International Police Conference if you could attend. We felt that it would likewise be helpful to the F.B.I., for an exchange of ideas at that time might not only prove mutually beneficial for the present but also for future cooperation. I explained, and he thoroughly appreciated how busy you were, and how difficult it would be for you to absent yourself from your arduous task in order to attend the Conference. Therefore, we

both concluded in hoping that it would be possible for you to send a representative; to this end, President Welhaven has written our mutual friend, Hofrat Dressler, head of the International Police Commission in Vienna, asking him that he join him in urging that you or your representative attend. President Welhaven informs me that he and the other heads of European police systems are intensely interested in you and the magnificent progress which you have been making. It is therefore quite natural that they sincerely hope for the presence of yourself or your representative at Belgrade.

Several months ago the Department of State instructed me in your behalf to obtain all information concerning the police system of Norway. I immediately took the matter up with President Welhaven who appreciated your interest in his system and promised to cooperate to the end of rendering us all possible information. As the system here is undergoing a revision, details of which are contained in a bill which must be acted upon by Parliament, it will be several weeks before President Welhaven will know exactly what the final form of the reorganization scheme will take. He is hopeful that his proposed program will go through without changes. In general, the new scheme calls for the payment of all police salaries by the national government direct instead of by the communes, as in the past. The communes will contribute as usual to the upkeep of the establishment but will contribute to the government which in turn will pay the force.

I cannot tell you how much I enjoyed the data you have sent me from time to time, and I should like to take this occasion to reiterate to you my great admiration of and congratulations for the great success which you are achieving. I was delighted to read in the papers recently that the President has requested that the force of the F.B.I. be augmented.

It was truly a pleasure to receive your excellent letter of January 20, 1936. I most certainly appreciate the interest which you continually display in the work and accomplishments of the Federal Bureau of Investigation. The consideration of its activities which you voice is both heartening and inspirational toward greater effort.

I am pleased to learn that you have had an opportunity to talk with Police President Schaller of Oslo concerning this Bureau, as well as his work, and I am sure that you find many of the same problems facing us both. I am delighted also to learn that he is familiar with our latest developments and would appreciate your conveying my best wishes to him. If this Bureau can be instrumental in allaying the often reported viewpoint that the United States is a rioting nation without any law or order, I think that it will be a broad accomplishment.



By reference from the Director's office Miss McDonald of the State Department telephoned and stated that they had received an invitation from the Austrian Minister for a delegate to be named by the Government to attend the 12th Annual Meeting of the International Crime Commission from Austria and wanted to know if we had the correct title of this organization, stating that the invitation they received for the 11th Meeting last year does not tally with the present title. She further stated that she had talked with the Secretary to Mr. Sanford Bates in the Department, thinking that possibly he was the party who would be interested, and the Secretary advised her that she knew nothing about the matter whatsoever.

I informed Miss McDonald that I did not have the correct title of the organization at hand and further suggested to her that if this was a crime commission, Mr. Bates would not be interested in view of the fact that he has charge of penitentiaries. I suggested to her that probably the proper procedure in handling this matter would be to forward the invitation from the Austrian Minister to the Attorney General, which she said she would do.

I have your letter dated March 28, 1936, file number PC 510.5 E14/21, with which you enclosed a copy of a note dated March 4, from the Minister of Austria, inviting this Government to designate delegates to the twelfth meeting of the International Criminal Police Commission, to be held at Belgrade, Yugoslavia, from May 25 to 31, 1936.

This Department, as well as the Director of the Federal Bureau of Investigation, has received previous correspondence from Dr. Oskar Dressler, General Secretary, International Criminal Police Commission, Federal Police Office, Vienna, Austria, and from Honorable Kristian Holbøven, Commissioner of Police, Oslo, Norway, urging that representatives of the Federal Bureau of Investigation attend the conference. These gentlemen have been advised that the commitments of the officials of the Bureau and the constant pressure of their duties make it impossible for them to indicate an acceptance of the cordial invitations which have been tendered them.

It is my opinion that it would be highly worth while for delegates to attend the meeting of the International Criminal Police Commission, but the conditions I have mentioned and the great cost which would be connected with such attendance make an acceptance of the invitation extended by the Minister of Austria inadvisable.
