The International Criminal Police Commission was founded in 1923 at Vienna, Austria, for the purpose of improving mutual cooperation among police authorities in various countries. As you know, Inspector Lester attended the 13th meeting of the Commission which was held at London, England, in June, 1937, and upon his return recommended by memorandum to the Director that the United States should be permanently connected with this organization.

Inspector Lester in his memorandum points out that while we would not receive much practical benefit from membership in the Commission, the contacts with outstanding law enforcement officials would be helpful and delegates attending the annual conferences could learn of new scientific developments which might prove interesting and helpful to the Bureau and to law enforcement in general in this country.

With reference to the expense of membership in the Commission, Inspector Lester was of the opinion that any contribution suggested by the Director would be acceptable, and recent correspondence with the Secretary General, Dr. Oskar Dressler, confirms this. As you know, the Bureau's Appropriation contains an item of \$1,500.00 to meet the expenses of membership in the Commission.

In addition to Inspector Lester's reasons for joining the Commission, there is also the possibility that if we fail to join, the Secret Service or some other Federal Agency may seek to become a member, and the FBI might thereby suffer in international prestige.

Since Inspector Lester attended the annual conference of the International Criminal Police Commission in London in 1937, a very delicate political situation has developed in Europe. Inspector Lester stated at the time that the greatest drawback to membership in the I.C.P.C. was the fact that the Austrians dominate the entire Commission, probably due to the

fact that an Austrian police official originally conceived the idea of creating the Commission. At the present time, of course, Germany controls Austria, and the Commission assumes a distinctly Austro-German atmosphere. This constitutes the principal objection to joining the Commission at the present time in view of the delicate international situation. On the other hand, if we fail to join the Commission at this time after we have already indicated a willingness to join and after obtaining the necessary funds for membership in our Appropriation, it might be construed as an act of unfriendliness.

It is recommended that the Bureau join the Commission but that no representative be sent to attend the Berlin meeting of the Commission which is to be held in September of this year.





international policy associations or international bodies or any branch affiliates. It would not be possible to supply to the police of foreign countries samples of all American passports in use. There are too many different types of passports and we have abroad in all important places American consular officers who are experts in matters of detecting fraud in passports and who are most desirous of cooperating effectively with local officials. I believe that the present practice of local cooperation is the best for the purposes of this government.

With reference to the proposition that passports be refused, annulled or withdrawn for reasons of public security, these matters in an emergency would be the subject of direct regulations. The proposition, however, which the Permanent Reporter brings to your attention seems to concern the refusal, annulment, or withdrawal in peace times of passports of persons who have criminal records or are supposed to be international criminals. I believe this more directly concerns the countries of Europe than the United States. However, it is the long established policy of this government

not

not to consider the conduct or deportment of an applicant for passport unless it is sufficiently notorious as to be considered a menace to the people of the United States or to reflect seriously upon this government in its international relations.

Under our system of government the punishment for criminals is indicated in the laws and no super-punishment is imposed through the refusal of passport facilities unless there is outstanding reason for it.

I believe this policy is correct. At the same time, as you well know, this Department does not fail to cooperate not only with your Bureau but all other agencies of the American government whose duty it is to assist in the apprehension of criminals. In the circumstances, it does not seem either necessary or desirable to endeavor to become a member of the system set forth in the papers which were submitted by Dr. Schultz and which seems to be over-organized and so complicated as to impede rather than facilitate travel.





MEMORANDUM FOR MR. NICHOLS

Pursuant to instructions I met Dr. Zeno E. Bianu in the Director's office on the afternoon of August 21, 1939, and conducted him on a detailed special tour of the Bureau's facilities.

Dr. Bianu is the brother of the Director of the Rumanian Police and is a medical doctor, having offices at 68 Calea Victoriei, Bucharest, Rumania.

In addition to the general points of interest the Communications Section, Single Fingerprint Section, Photographic Rooms, rear of the Technical Laboratory, Typing Section, Gymnasium and Pistol Range were visited. While on the pistol range Dr. Bianu evidenced great interest in the Bureau's firearms and the Thompson Submachine Gun in particular. Mr. Dawsey explained the workings of the range in detail.

Dr. Bianu also was shown the Director's suite and upon the conclusion of the tour was returned to Mr. Tracy's office. While in the Director's suite Mr. Coffey came around to meet Dr. Bianu who accepted Mr. Coffey's invitation to have dinner with him prior to returning to New York last evening.

Throughout the tour Dr. Bianu advised that his interest in the law enforcement profession was due solely to what he had learned of our work through the activities of his brother and that he had frequently heard splendid comments regarding the Director and the FBI. He advised that at the last meeting of the International Criminal Police Commission in his country extensive preparations had been made to entertain the Director in the event he was able to participate, advising that a plane in Paris had been held in waiting in order to fly the Director to Rumania to facilitate his meeting with that Commission.







Dear Mr. H o o v e r,

I have the honour to refer to my letter, dated February 17th, 1938, concerning the refusal to issue, the annulment and the withdrawal of passports for reasons of public security.

Meanwhile I have received from different members of the ICPC very remarkable suggestions so that I was able to make an ample report-No. 6- based on this material as well as on other propositions forwarded to me, for the XVth ordinary meeting of the ICPC which was to be held at the end of August 1939. Likewise I made a special "supplement" to this report. These reports have been forwarded by mail to all the members of the Commission. So I hope that they are already in your hands.

In the above-mentioned report No. 6, I emphasized the fact in part III ("Final Conclusions") that the details of the present subject had not been sufficiently elicited as the representatives of different countries have not, as yet, given their opinions as to the subject itself or the propositions made by the diverse members in the course of the discussions. For this reason I suggested that the Commission should decide upon the continuation of the studies in question, and should charge me with making a final report for the next meeting which, in consequence of resolution III I had to prepare already for this year.

As this year's meeting did not unfortunately take place, I feel myself in some sort bound to continue my studies i. e. to urge the members of the Commission who have not, as yet, given their opinion, to do this so that I can prepare, if possible, the final report which I had been charged of for the next meeting.

With regard to this and to the fact that I did not receive any answer to my afore-named letter, I have the honour to beg you to inform me at your earliest convenience whether you have taken any step with your government in accordance with resolution IX (passed by the ICPC at the XIIIth ordinary meeting at London in 1937), and, in the affirmative, which results you had obtained.

Finally I am to remark that the proposition of the former representative of the Free State of Dantzig, made in 1938 (vide my report No. 7 of the XIVth meeting/Bucarest 1938/ as well as my report No. 6, prepared for the XVth meeting) must be taken as withdrawn according to a communication received from the Reichskriminalpolizeiamt at Berlin as the former Free State of Dantzig has been united again with the German Reich. However, the legal provisions of the German Reich concerning the refusal to issue, the annulment and the withdrawal of passports correspond completely with the exigencies of the Reich (See also my report No. 6).

I have received your letter of December  
15, 1939, relative to passport matters, and I was  
indeed happy to hear from you again.

As you were advised in my letter of June  
1, 1939, the suggestions contained in your previous  
communications and reports were referred to The  
Honorable, The Secretary of State, for consideration  
and advice. I am in receipt of a letter from the  
State Department in which this Bureau is advised  
that although it has always been the practice of  
this Government to cooperate fully with foreign  
governments with a view to detecting fraud in pas-  
port matters, it has dealt in the past through  
diplomatic representatives of foreign countries and  
diplomatic representatives of this Government abroad,  
rather than with international associations or branch  
offices.

Regarding the international exchange of  
passport forms, I was advised by the State Depart-  
ment that it will not be possible to supply to the  
police of foreign countries samples of all American  
passports in use, for the reason that there are too  
many different types of passports and this Nation

cooperating effectively with local officials.

With reference to the proposition that passports be refused, annulled, or withdrawn for reasons of public security, I am advised by the State Department that these matters in an emergency would be the subject of direct regulation. It is not the policy of the Government of the United States to refuse, annul, or withdraw in passing the passports of persons solely because of the fact that they have criminal records. These measures are adopted only in those cases where the applicant for a passport is sufficiently notorious as to be considered a public menace or to reflect seriously upon the Government in its international relations.

Under our system of government the punishment for criminals is indicated in the laws, and additional punishment is not imposed through the refusal of passport facilities unless there is an outstanding reason for so doing.

I hope that the delay in replying has not caused you too much inconvenience, and I trust this information will be of assistance to you.

cerning the question of an international exchange of passport forms, I have included a special respective paragraph dealing particularly with your point of view in section III of the "Guide for the international exchange of passport forms for the purpose of an international suppression of forgeries of passports" the draft of which I sent you with my letter of April, 17th, 1939. I shall forward to you a new copy of this "Guide" if its newest redaction will be finished.

What concerns your very interesting communications about the refusal to issue, the annulment and the withdrawal of passports for reasons of public security I shall not fail to take of them in my further works connected with that subject.

It seems to me a fact of greatest interest that even in your countries in these cases where the applicant for a passport is sufficiently notorious as to be considered a public menace or to reflect seriously upon your Government in its international relations the measures recommended in Resolution No. IX of the XIIIth Ordinary Meeting (London 1937) of our Commission may be employed.

As far as I am aware the members of the Commission had in

mind, when adopting the above-mentioned resolution, that the said measures should not be inflicted as a kind of punishment of these individuals, but that they should only be employed, as prohibitive ones, necessitated and justified by the fact that the conduct of all those persons makes them considered a public menace.

It seems therefore that the above-mentioned resolution is founded in general on the same ideas as the practice of the United States authorities, you have referred to in your letter; only in as much as the interpretation of the conception of "public menace" is concerned, the I.C.C. has gone further than it is the case in your country.



In conformity with the resolutions adopted in Rome (1932) and London (1937), the Chairmanship of the J.C.P.C. is conferred for a period of five years, i.e. up the end of 1942, on the President of Police in Vienna.

Now, the last President of Police in Vienna has died. His successor will not be appointed within any time, therefore, the J.C.P.C. has no chairman. This state is an intolerable one. For, we have the duty to maintain our fine work of international Police cooperation, the result of our common endeavours done since 17 years,


But, for this purpose we need a Chairman. Considering that no Police President of Vienna has been appointed, and the whole Criminal Police of Germany, i.e. the Viennese Police too, being under the command of the Chief of the German Police in Berlin, it seems to be the best way to confer to the Chief of the German Police also the Chairmanship of the J.C.P.C.

To be noted that Mr. Manuel Perez Garcia, representative of Spain to the J.C.P.C., has already adopted our proposal which was communicated to him some time later.

In conformity with the suggestion made by Dr. B i a n u , representative of Rumania to the J.C.P.C., I have the honour to forward to all the members of the J.C.P.C. the above mentioned proposal asking that they may be kind enough to let me know their advice within three weeks.

Members who have given no answer will be presumed to have adopted the proposal.



Thank you for your communication of January 23, 1959, concerning the membership of the Federal Bureau of Investigation in the International Criminal Police Commission.

You have, undoubtedly, received my communication of January 17, 1959, wherein I advised you that the Bureau now has appropriated legislative authority to accept membership in the Commission. Unfortunately, however, funds for this purpose have not as yet been made available. It is believed that such funds will become available on or about July 1, 1959, at which time I shall be pleased to further consider your suggestion with respect to the subscription for use in assisting in covering the expenses of the Commission from its participating members.

With reference to the contribution of this Bureau to your Commission, I note from your communication of January 23, 1959, that the maximum contribution expected from this country will be \$ 2500 per annum. Our representative while attending the meeting of the Commission in London, England was at that time advised, it would be satisfactory with the Commission for this country to contribute an amount of \$ 1500 for its membership in the International Criminal Police Commission.



MEMORANDUM FOR MR. TOLSON

In connection with the attached correspondence from Legal Attache Lynch at London and the memorandum upon the International Criminal Police Commission, I think it would be well to have some survey or study made, not too long or involved, by two or three of the Bureau key men to prepare suggestions as to the initiation and participation of the Bureau in certain international and hemispheric conferences on law enforcement.

We have from time to time informally discussed the desirability of having such an organization for the Western Hemisphere. We endeavored to have some such resolution introduced at the meeting recently in Mexico City. Whether or not it was introduced and adopted I am not certain, but this should be ascertained, and we ought to try to work out means and ways of developing it and implementing it.

As regards an International Criminal Police Commission, about which Assistant Commissioner Howe has spoken to Mr. Lynch, I think again we should examine that situation and determine whether we desire to participate in it and the extent of participation.

I think we should keep in mind the desirability of the United States actively participating in such activities and that the Bureau should be the agency to initiate it. If this is to be considered desirable, then we ought to have our plans formulated quickly and initiate them before someone else does so.

Re: INTERNATIONAL CRIMINAL POLICE COMMISSION

In a conference with Mr. Ronald Howe, Assistant Commissioner of Metropolitan Police, New Scotland Yard, he stated he was very desirous that you become a member of the International Criminal Police Commission, which is expected to reconvene after the war. He stated that this Commission has been most helpful in the past and that they meet at least once a year to discuss International Police matters and he, himself, has found this Commission to be of great help to Scotland Yard. Mr. Howe stated he was sure that the Bureau would be a welcome addition to this group and was extremely anxious that you become a member of this Commission which he stated would become more important in post war police matters.

Before the war, this Commission met in Paris, France; Brussels, Belgium; Berlin, Germany; London, England; Berne, Switzerland, at which time papers were read on police matters and through this meeting brought the heads of various police departments in close liaison and, according to Howe, Scotland Yard has benefited a great deal from this group as well as from attendance at these meetings.

Mr. Howe requested that I write you and obtain your ideas and comments concerning your desires to become affiliated with this Commission.

In accordance with your request the following is set forth regarding the International Criminal Police Commission:

GENERAL BACKGROUND

Prior to World War I it was felt that some type of cooperation among law enforcement agencies of different countries would tend to curb the activities of international criminals, and with this fact in mind international conferences were held in various places such as Buenos Aires, Argentina, in 1905, Madrid in 1909, and Washington, D. C. in 1913. The progress in forming an organization was slow but in 1923 Dr. Scholer, a former Austrian Chancellor and the Viennese Police President, brought representatives of various European police agencies to Vienna to consider a simplification of extradition processes, the repression of the drug traffic, etc. The International Criminal Police Commission resulted and the headquarters became Vienna.

The Commission consisted of a President, who was always President of the Vienna Police Department, Vice Presidents, Permanent Reporters, Ordinary Reporters, Ordinary Members and Honorary Members. The expenses supposedly were to be taken care of by contributions from the various countries' representatives on the basis of one Swiss franc (about 25¢) for every 10,000 inhabitants of the country represented.

An International Police Congress was sponsored by the Commission in 1926 in Berlin and again in 1930 in Antwerp. Additional meetings have been held from time to time in various countries in Europe.

The Commission has indicated that many of the countries affiliated with it have established offices in close relation with the international central offices in Vienna. The Commission stated at one time that the League of Nations was interested in its work but made no claim that the Commission had any connections with the League. The main forms of international criminology dealt with by the Commission in the past are drug traffic, White Slave traffic, falsification of passports, falsification of checks, bank notes and other documents having monetary value. The Commission formerly issued a magazine containing data on the working of the organization and the activities of international criminals.

1937 MEETING IN LONDON

During April, 1937, the Bureau, through the State Department, received an invitation from the British Ambassador and from the Minister of Austria to send a representative to attend the thirteenth meeting of the International Criminal Police Commission, held in London, England, June 7 through June 10, 1937.

Former Inspector W. H. Drane Lester was designated to attend this meeting and while there he delivered an address entitled "Modern Trends in Criminology in the United States of America."

Upon his return to the United States, Inspector Lester dictated a rather detailed memorandum concerning the occurrences in London and his impressions of the Commission. Inspector Lester expressed the opinion that the United States should seek a permanent connection with this international organization. While he stated that he did not feel the Bureau could derive much practical benefit from membership, he was strongly of the opinion that the contacts with foreign law enforcement would prove stimulating and helpful and that we would invariably learn of new scientific developments, etc. At the time the Director commented that the Bureau should request the necessary sum for membership as a part of our appropriation unless the funds already permitted such membership.

PROPOSED FBI MEMBERSHIP IN THE  
INTERNATIONAL CRIMINAL POLICE COMMISSION

Under date of July 13, 1937, the Director communicated with the Attorney General and mentioned an invitation received by the Bureau to become a permanent member of the Commission. The Director pointed out that he felt the desirability of accepting and said that the assessment for membership would not exceed \$1500. The matter of securing appropriate phraseology in the Bureau appropriation was brought to the Attorney General's attention so that the membership could be accepted.

Under date of November 18, 1937, Judge Holtzoff of the Department advised that the appropriate phraseology had not been included in the Justice appropriation.

On April 2, 1938, Judge Holtzoff advised the Bureau that the Bureau of the Budget had cleared the matter and that bills covering the FBI's membership in the Commission were going forward at once to the House and to the Senate.

March 3, 1945

The bill read as follows: "Be it enacted by the Senate and the House of Representatives of the United States of America in Congress assembled, that the Attorney General is hereby authorized to accept and maintain, on behalf of the United States, membership in the International Criminal Police Commission and to incur the necessary expenses therefor not to exceed fifteen hundred dollars per annum."

#### INVITATION TO ATTEND 1938 MEETING

Under date of May 3, 1938, the Director received an invitation to attend the Congress of the International Criminal Police Commission at Bucharest, Rumania, beginning on June 7th of the same year. The Director expressed his regrets at being unable to attend. A similar invitation was received from Dr. Oskar Dressler, the Secretary General, and a similar response was given.

#### PASSAGE OF THE ACT PROVIDING FOR MEMBERSHIP

The statute authorizing membership in the Commission was approved on June 10, 1938. On the preceding day Judge Holtzoff stated that although the money had been authorized it could not be spent at that time. The Department immediately contacted the Bureau of the Budget regarding putting the item in the Deficiency Bill so that the money could be spent as soon as needed.

Under date of December 24, 1938, Dr. Dressler wrote the Director concerning possible participation in the Commission. The Director advised under date of January 17, 1939, that the Bureau then had appropriate legislative authority but that, unfortunately, funds for this specific purpose never had been made available. The belief was expressed that the funds would be available on or about July 1, 1939.

Under date of January 25, 1939, Dr. Dressler communicated with the Bureau concerning the FBI's contribution toward the financial upkeep of the Commission. He pointed out that since Germany, the largest country in the Commission, has about 80,000,000 people and pays about 7,000 RM, all the other members of the Commission would be glad if the contribution of the United States would be a maximum of \$2500.

The Director wrote Dr. Dressler on February 23, and pointed out that when Inspector Lester was in London in 1937 he was advised that it would be satisfactory if the United States paid \$1500 for its membership. The Director expressed doubt that it would be possible under the enabling appropriation to pay more than \$1500.

April 3, 1945

Dr. Dressler replied on March 23, 1939, and pointed out that the International Criminal Police Commission was not a banking house and that he felt it would be satisfactory for the United States to pay \$1500. He stated that the organization greatly needed money to cover expenses and that the United States' cooperation was urgently needed.

On April 19, 1939, Dr. Dressler wrote the Bureau inquiring whether our contribution could be remitted prior to the meeting in Berlin in the late summer of that year. On June 1, the Director replied that he felt it would be possible to send the contribution after July 1, 1939, when the fiscal year 1940 began.

#### ACTIVITIES OF COMMISSION SINCE SUMMER 1939

On May 12, 1939, Dr. Dressler wrote the Director expressing the hope that he could see him at the meeting of the Commission to be held later in the year. The Director replied on June 19, stating that because of the pressure of official matters in Washington he would be unable to attend. There were several other communications each way during the summer concerning this same matter and on August 16, 1939, the Director advised Dr. Dressler that he had carefully gone over his commitments again and still found he would be unable to attend the annual conference in Berlin from August 29 to September 7, 1939. The Director further pointed out that he had hoped it would be possible to furnish the contribution of the United States after July 1, but that conditions of the Bureau's appropriation would not permit this. The hope was expressed, however, that in another year the appropriation would be in such a condition that we could participate actively in the affairs of the Commission.

It might be noted that during the summer of 1939 the Bureau received, through the State Department, a formal invitation on behalf of the German Government to participate in the fifteenth conference of the Commission at Berlin, August 29 to September 7. The Attorney General communicated with the State Department and expressed the belief that the invitation should be declined and that no American representative should be designated to go to Berlin.

Under date of August 24, 1940, the Bureau received a communication from the Chief of the German Security Police in which the latter indicated that he accepted the office of President of the International Criminal Police Commission in Berlin.

Dr. Dressler, Secretary General of the International Criminal Police Commission, advised on September 6, 1939, that the fifteenth meeting of the organization which was to have been held August 29 to September 7, 1939, had been postponed until a later date.


The last communication in the file of Dr. Dressler was dated September 23, 1940. He stated that in his capacity as Secretary General and Administrator of the Commission he was about to close the Commission's accounts and that he wanted to ascertain whether the contribution of the countries having accepted membership had been fully paid and desired to know when the Bureau would pay its contribution. He was written under date of December 13, 1940, and advised that, unfortunately, matters beyond our control made it impossible for the Bureau to assume full membership in the International Criminal Police Commission at this time.

Late in 1941 the Bureau received a communication advising that the International Criminal Police Commission had been transferred from Vienna, Austria, to Berlin and suggesting that all communications be forwarded to Berlin. On December 1, 1941, the Executive Conference unanimously recommended that no further communication be addressed to this organization. It would appear from the files that the Bureau had stopped communicating with the Commission several months before.

As things now stand, the provision for \$1500 remains in the Bureau appropriation. It would appear that the phraseology on this matter simply provides that no more than this amount can be spent for membership in the International Criminal Police Commission. It would appear that the circumstances which justified our membership in this organization prior to the war will still exist after the cessation of hostilities.

There is quoted below in full a press release published in the New York daily newspaper "PM" August 2, 1945:

**WORLD POLICE FILES FOUND**  
**18,000 Small Criminals in Berlin Lists**

By John M. Locklin

and The Newspaper PM, Inc.)

"BERLIN, Aug. 2.-U. S. Army authorities in Berlin have discovered a house full of files containing the case histories of 18,000 international criminals and they wish somebody would advise them what to do about it.

"The records belong to the International Police Commission, an organization founded in 1923 with 23 members including the U.S.A., Britain and every other major nation except the Soviet Union.

"Its headquarters originally were in Vienna but the Nazis moved them here in 1939, along with Paul Spielhagen, caretaker of the records. Spielhagen has been working for the Commission 15 years and claims to be the only man alive who understands its filing system which is his own invention.

"The Nazis apparently attempted to maintain the commission after the beginning of the war and copies were made as late as last February. It was kept separate from the complex German police hierarchy and authorities here think the files will be useful to both the FBI and U. S. immigration officials.

"The great bulk of the criminals are unknown, listed for such crimes as stealing an automobile in Bulgaria and fleeing across the border into Yugoslavia. It is known that the Gestapo frequently employed criminals as agents and the files with fingerprints and front and side photographs could be useful in ferreting them out.

"Among the few well-known personalities in the files is Ante Pavelich, the Nazi puppet Premier of Croatia, who was recorded for his part in the assassination of King Alexander of Yugoslavia in 1934.

"The office of the organization is in a four-story house in the suburban district of Wannsee. The Nazis also used it as a jail after the attempt on July 20 last year on Hitler's life, and two German generals were imprisoned there. It was also used as quarters for visiting foreign police dignitaries.

"The place is now occupied by Spielhagen who is busy putting the files in shape and a half of dozen American officers who are billeted there and quite baffled by the whole business."

You can appreciate that the location and present status of these files are of considerable interest to the Bureau. You should make inquiries among Army officials to determine what disposition is planned for them. It is assumed that officials of the International Police Commission are seeking them and of course if representatives of that Commission demand possession of the files, no further action need be taken by you. However, if no claimants have appeared for them, you might take whatever steps are possible to protect them. In any event, the Bureau should be advised of their status and the plan for their disposal.
