Permit me to extend to you at this time my most sincere regrets for the unfortunate tragedy which occurred at Kansas City on Saturday morning last. I know that you will not hesitate to call upon me if I can be of any assistance in order that this matter might be brought to its logical conclusion at the earliest possible moment.

In this same regard please be advised that on even date a memorandum has been received from Special Agent R. E. Peterson at Memphis, Tenn., stating that during a conference with Mr. J. E. Holdeman, City Passenger Agent for the L&N Railway, Mr. Holdeman stated that on June 18th last, he conferred with Mr. E. E. Bullitt, a Pullman conductor on train No. 104 of the L&N Louisville-Memphis train, which arrived in Memphis at 7:30 A.M. Sunday, June 18th. Mr. Bullitt advised Mr. Holdeman that he had three men on this train with tickets for Little Rock, Ark., who looked very suspicious; seemed quite nervous and were snoring during the trip; that one of the men weighed approximately two hundred pounds; that after he (Mr. Bullitt) arrived at Memphis, he read of the shooting at Kansas City, and wondered in his own mind whether the passengers mentioned would have any connection with this case.

Mr. Bullitt was on an extra run during this trip, and has returned to Louisville, Ky. His home address is Dixie Highway, Louisville, Ky., telephone Shawnee 7581-M.

I realize that you are possibly being flooded with leads and suggestions concerning this incident, but I deemed it advisable to transmit this information to you in order that every lead, even though remote, might be followed out. It might be that you will desire the Cincinnati Office to interview Mr. Bullitt, in order to obtain a more detailed description of the passengers mentioned by him, and I trust that the culprits perpetrating this crime will be apprehended and severely punished.



Upon receipt of telephone call from the Kansas City office this office immediately contacted Chief of Detectives Kaiser who had the information concerning the automobile together with the available descriptions of the persons involved in the shooting at Kansas City broadcast over K.S.P.C. the St. Louis Police Radio station and likewise a teletype message was sent to each station. The first broadcast was made at 10:57 AM June 17th and will be continued every two or three hours during the rest of the day.

The writer also called the Chicago office of the Bureau and suggested that Winnie Williams who is now residing at 2834 Oakley St. Chicago, Ill. be picked up or at least placed under surveillance for a time as it is believed that she may have been in communication with some of the subjects herein. It will be recalled that Winnie Williams alias Mary Phillips was arrested at Kansas City with Holden, Keating and Bailey.

In connection with these persons your attention is directed to report of Special Agent J.E. Brennan dated St. Louis 8-25-33, wherein is listed a number of calls made by Winnie Williams when residing in St. Louis. It is believed that she may have been contacting Wilhite and Griffin for the subject hereof. Chief of Detectives Kaiser also advised that the above named persons had been passing a number of checks in St. Louis which check were subsequently identified as coming from the recent

bank robbery in Kansas City which was believed to have been "pulled" by Nash and Harvey Bailey, who it is recalled recently escaped from the Kansas State Penitentiary. Chief Kaiser advised that the above named persons have not been seen around St. Louis since passing said checks and he was of the opinion that they and Bailey had contacted Nash and may have been the persons involved in this shooting.

With respect to telephone number Jefferson 9080, this number is found to be listed for HELEN JOHNSON 620 a- N. Garrison St. St. Louis. This is the number called by some person from the joint in Hot Springs Ark. at about 11:41 PM June 16, 1933. Investigation at the above address disclosed that Helen Johnson is colored, the wife of Willie Johnson, a dining car waiter in the employ of the Missouri Pacific. She stated that she and a colored girl who is now married to Timothy Cain, of Hot Springs, have been friends since childhood and have been corresponding since Mandell moved to Hot Springs; that she suffered an injury to her foot which confined her to bed and had neglected to write to Mandell during the past month, and that last night Mandell telephoned her to inquire as to why she had not written; that Mandell did not mention that anyone had been arrested or ask her to give a message to anyone, but that the conversation was confined principally to the health of Helen Johnson. Mrs. Johnson stated that Cain operates a pool-room next to 424 Melvin St., Hot Springs, and that his home telephone number is 1830. Patrolmen Adam Horas and Clyde Peppers, who walk the beat covering 620a N. Garrison, both stated that they know Helen Johnson, that she has never been in any trouble or associated with thieves, and that they consider her respectable.




Reference is made to the case entitled Frank Nash,
with aliases, Fugitive, I. O. 1188, Escaped Federal Prisoner.

Confirming our telephone conversation today, please
be advised that it was ascertained through a confidential inform-
ant here that a Kansas City Italian gang, is at present harboring
Pretty Boy Floyd in the Italian quarters, Kansas City, which district
bears a decidedly tough reputation. The leader of the Italian gang
is Johnnie Lazia, his partners being Charlie Corolla, alias Charlie
Wopp. For identification, Charlie Corolla has a brother, Pete Corolla,
who has been sentenced for a long term in the Missouri State Peniten-
tiary. The gunman for the Kansas City gang is Joe Inace, who uses a
machine gun in his operations.

The informant further advised that Pretty Boy Floyd
and Frank Nash recently formed a friendship; that Vern Miller, fre-
quently mentioned in instant file, is very friendly toward Nash and
that Miller was recently in Hot Springs, Arkansas; that Miller is
driving a new Cadillac Sedan, blue or black color, bearing a blue
and white license, the first numbers being 207. The informant believes
the Cadillac in question is bearing a 1933 Wisconsin License Plate;
that the mother of Vern Miller previously resided in Kansas City,
where her telephone was Westport 8898; that apparently Vern Miller
seldom, if ever, contacts his mother while in Kansas City, in view

CONVICT, 4 POLICE KILLED IN BATTLE AT RAIL STATION

Gunmen Open Fire on Prison
Party at Kansas City Union
Depot Entrance

Kansas City, June 17.—(AP)—

Four officers were slain by machine-gun fire and another was wounded in front of the Union Station here today by gunmen who apparently sought to effect the release of Frank Nash, Oklahoma mail-train robber being returned to Leavenworth Federal Prison.

Nash, one of the few surviving members of the Al Spencer gang of train robbers, also died in the hail of bullets.

The killers fled in automobiles after pouring a murderous fire into a parked car which the officers and their prisoner were boarding at the east door of the station.

Besides Nash, the dead were:

Raymond J. Caffrey, agent of the Bureau of Investigation; W. J. "Red" Grooms, city detective of Kansas City; Frank Hermanson, city detective of Kansas City, and Otto Reed, Chief of Police of McAlester, Okla.

The wounded: F. J. Lackey, agent of the Federal Bureau of Investigation.

Accounts differed as to the number of men in the killers' party. One eyewitness said he saw only two men. Another reported the firing came from two automobiles, and some officers expressed the belief four men were involved.

Captured in Hot Springs

Frank Smith, investigator for the Department of Justice; Lackey and Reed arrived at the station shortly after 7 A. M. with Nash, captured yesterday in Hot Springs, Ark. Nash escaped from the Federal Penitentiary at Leavenworth in 1930.

They were met by R. E. Vetterli, chief of the United States Bureau of Investigation for Kansas and Western Missouri; Raymond J. Caffrey, an investigator for the bureau; Grooms and Hermanson. The seven escorted Nash, handcuffed, through the station to Caffrey's car.

Three of the officers and Nash died on the spot. Caffrey died in a hospital. Lackey was wounded. Smith and Vetterli escaped. All the dead were shot in the head.

Planned Drive to Prison

The officers had planned to drive to Leavenworth with the prisoner rather than wait for a train.

Vetterli, who received a slight wound as bullets tore through his clothing, said the firing "sounded as though it came from four sub-machine guns, but added that he could not be certain of the number of assailants.

"Just as we started to get in Caffrey's car in front of the station, they opened up on us," Vetterli said. "I don't know how many machine guns were opened up on us, but there was more than one.

"All I know is that they were hidden behind cars and opened up on us. They killed Nash first. The bullets were flying so thick about us by then that I don't know who went next."

Reference is made to your letter dated June 10, 1932, in which you mention that when Frank Nash was apprehended he was driving a Plymouth coupe bearing Illinois license plates 624-097. This information had previously reached the Chicago Bureau office through the Oklahoma City office by a letter dated May 22, 1932, which stated that a confidential informant had given the information that subject Nash had been seen driving this car. Special Agent V. W. Peterson submitted a report dated at Chicago, Illinois, 6/6/32, which covered an investigation of the address 1345 East 63rd Street, Chicago, Illinois, and of the name Earl E. Moore, the name and address given at the time that the Illinois license plates No. 624-097 were obtained. This report indicated that Moore had no connection with the address listed, and in all likelihood the name was fictitious.

A letter from the Kansas City office dated 5/18/32 indicated that the tracing to be forwarded to the Kansas City office with the report of Special Agent Peterson mentioned above had not been received and suggested that it be forwarded. In view of the events that have occurred since the mailing of this letter, it is possible that this mail tracing would be of little value. Nevertheless, since a copy of this letter is being sent to the Kansas City office, this mail tracing is being forwarded to the Kansas City office with that copy.

Derlier, a Pullman Conductor on the Missouri Pacific Railway, who resides at 2008 S. Grand Avenue, St. Louis, Missouri, that there was a negro porter employed in the Station at Kansas City, Missouri who observed all of the shooting which took place, and that he believed that this negro would be in a position to identify any photographs which might be exhibited to him.

Mr. Derlier stated he did not know the name of this negro, but that he believed same could be obtained from Mr. Bell, Station Master at Kansas City, inasmuch as Mr. Bell also was familiar with the fact that this porter had observed all of the shooting.

Mr. Derlier stated that he expects to be in Kansas City, Missouri on Monday, June 26, 1933, in the event a representative of the Bureau desires to contact him for the purpose of locating this colored porter.

Re: Death of Special Agent R. J. Caffrey.

Dear Sir:

Permit me to express to you my sincere regrets concerning the recent unfortunate tragedy at Kansas City. I know you feel this unforeseen happening keenly, as do I and every member of the Bureau, and it is because of my desire to be of assistance that I am taking the liberty to address this letter to you in the hope that the perpetrators of this most horrible massacre may be brought to justice. I realize, Mr. Hoover, that everything possible is being done; that no clue, however insignificant it may seem, will be disregarded. I realize also that you are perhaps besieged with offers of assistance, opinions and clues, most of which may have already proved to be valueless. However, I know that you will accept my few suggestions in the spirit with which they are given. They may not, of course, carry much weight, yet I should feel that I had not done my duty were I to remain silent.

You may recall that I was closely associated with Special Agent Caffrey during the Holden-Keating apprehension and thereafter during the further conduct of the investigation. The Frank Nash file was assigned to me for some period of time while I was at Kansas City and I became familiar with his activities as well as those of the various members of his several gangs.

Since the murderous attack of last Saturday I have read every press account available and have noted the various expressions of opinion. However, I am not inclined to believe that any member of the several gangs with which Nash was connected sought to kill him perhaps because of some betrayal on his part. I am convinced that it was a plot to liberate Nash in order that he might return to his old haunts and I feel that Harvey J. Bailey who, you will recall, was apprehended on the Old Mission Golf Course at Kansas City on July 7, 1932, together with Holden and Keating, and who only effected his escape from the Kansas State Penitentiary at

Lansing, Kansas. When Caffrey and I talked with Bailey at police headquarters, immediately after his apprehension last July, he admitted that he was acquainted with Nash, but, of course, would volunteer nothing further. He professed to be a member of a liquor-running crew between Chicago, Illinois and Oklahoma City, Oklahoma, and advanced that as reason for his having been in possession of the bond later identified as having been taken in the Fort Scott, Kansas bank robbery for which Bailey was subsequently convicted. You may also recall that an attorney named Smith who was to have defended Bailey, but for some reason failed to do so, was murdered by unknown persons within two days after Bailey's conviction. Smith, I understand was a Tulsa attorney catering exclusively to criminals of the gang strata.

During the further investigation, after the apprehension of Holden and Keating, a relentless search was made to locate one Bernard Phillips, alias Phil Courtney, a former Leavenworth convict who was on the golf course when Holden and Keating were apprehended, but was not playing with them and at the time we did not have any information concerning him. The woman with whom he was living and who claimed to be his wife, one Mary Crawford, alias Winnie-Winkle alias Mary Courtney, was taken into custody together with the Holden and Keating women and she was questioned at length, but refused to divulge any information whatever concerning herself or Phillips. However, the investigation disclosed, and the Bureau and Kansas City files will show that Phillips is a dangerous criminal. He is wanted by the Minneapolis police for the robbery of a bank there in March, 1932, and at which time he, with six others, procured two hundred thousand dollars in cash, and there is a thousand dollar reward for his apprehension. The investigation further disclosed that Phillips is very close to Holden and Keating and that he is a killer mainly; he being hired to do all the shooting that is necessary to the gang's welfare. He was a former Minneapolis or St. Paul motorcycle patrolman; had service during the World War as a Machine-Gunner and, if I recall correctly, he is said to be somewhat mentally unbalanced; knows little or nothing more than the use of a machine-gun at which he is most adept. In this connection I recall that the woman employed by the Travelers' Aid Society, Union Station, Kansas City, in a press dispatch, was quoted as saying that one of the men in the gang was rather large and that it was he who, she believed, might have been wounded or fell as the gang made its getaway, but managed to pick himself up and get into their car.

There is a possibility that the man she had reference to is Bernard Phillips. I sincerely believe that he has been with Nash continuously since Keating and Holden were apprehended and as soon as he learned that Nash had been apprehended he, together with the other members, and possibly by instruction of Harvey Bailey who, I believe contacted Nash immediately after his escape from Lansing, came to Kansas City determined to retrieve Nash and to kill any and all who opposed their demands.

I believe if Phillips and Bailey can be located that some information of value will be procured. Of course not through them, but I feel that they, or at least Phillips, may possibly be identified by one or more of the witnesses to the tragedy, for I don't believe any one would mistake Phillips.

The foregoing information is submitted, as previously mentioned, for whatever value it may possess and with a clear understanding, on my part, that perhaps I may have overlooked some essential in the various press accounts that would clearly disprove my views. However, Mr. Hoover, if there is anything at all enlightening therein you may be assured that I am happy to have been in a position to offer something towards bringing this matter to a definite conclusion through the prosecution and just punishment of the parties responsible for this terribly unfortunate tragedy.

I am taking the further liberty of mailing this letter to you direct and, I believe, such procedure will meet with your approval and the approval of Special Agent in Charge T. D. Quinn to whom I have furnished a copy for his information.



No other calls were made from the two numbers given for Joplin, Missouri.

With further reference to the shooting at Kansas City, Missouri, it has been noted from newspaper articles that a photograph of Pretty Boy Floyd has been tentatively identified as that of one of the participants in said shooting. In this connection, Chief of Detectives Robert Kaiser of the St. Louis Police Department advised this office that he had received information to the effect that about eight or ten days ago Pretty Boy Floyd was residing across the street from Lake Hill Park in Valley Park, Missouri. Chief Kaiser stated that at the time Floyd was arrested a number of years ago in connection with a charge against him in St. Louis, Missouri, he was known to have connections in and around Valley Park, Missouri.

MEMORANDUM of Telephone Calls re FRANK NASH

Mr. Harvey advised from Kansas City that although a woman who witnessed the shooting has identified the picture of "Pretty Boy" Floyd as that of one of the men with the machine guns, he doubts that this identification should be considered positive; that another witness, Samuel E. Link, has said positively that Harvey Bailey was one of the men with the machine guns; that Mr. Vetterli has recognized from the photographs that a man named Bob Brady, another escaped convict, as one of the gunmen; that he, Mr. Harvey, ascertained yesterday at Lansing that beyond a doubt Harvey Bailey was the ring-leader of the men who escaped from the penitentiary, which information was received from Warden Laws, one of the officers kidnaped in the prison break, who was taken from the prison in a car by six escaping convicts; that four of these convicts, namely Bob Brady, Harvey Bailey, Wilbur Underhill and Ed Davis, have been tentatively identified as being connected with the shooting at the Union Station; that Mr. Link, who is acquainted with Bailey, having known him for some time, says he drove his car up before the station to park the same, just where the gunmen were waiting for the victims to leave the station, and that these individuals swore at him, telling him to "get out of there", and pointed a machine gun in his face, and that he then moved his car a little further down the street from which place he witnessed a part of the shooting.

I requested that the report covering the statements of informant Link be forwarded to the Bureau by air mail. I inquired whether this information had been given to the police and was advised it had not.

Mr. Harvey stated that it is believed Bailey has gone to Oklahoma; that Mr. Nathan suggests that I.O.'s be prepared immediately covering the men wanted in connection with this shooting; that the newspaper articles regarding this matter had been favorable to the Bureau and that he had sent to the Bureau a number of the clippings.

Mr. Harvey stated that they needed more Agents and it was decided that Bruce Nathan, Dwight Brantley and Harold Anderson should go to Kansas City to assist in this investigation.

Special Agent in Charge Gus Jones telephoned from Kansas City, saying he had been unable to get in touch with the informant, as he had left work 5:30 P.M. one to call or see him. I told Jones he should contact this informant and





MEMORANDUM FOR THE DIRECTOR.

With reference to my suggestion relative to the possible desirability of linking on each of the Identification Orders issued in the Kansas City murder case the names of all of the suspects for whom Identification Orders will be issued, I desire to suggest that in re-considering this matter this would appear to be undesirable through reason of the fact that it is entirely possible that later investigation may develop other and additional subjects or it may eliminate some of the subjects for whom we are now looking. For instance, if it would be necessary to cancel the Identification Order on Pretty Boy Floyd his name would still be on the five other Identification Orders outstanding. After going over the matter carefully with Mr. Cowley I believe that it would be undesirable and recommend that the Identification Orders be issued as now prepared.



Esteemed Sir:-

The cold-blooded massacre of officers at the K.C. Union Station this morning proves to my satisfaction that my prophecy, that martial law would yet have to be resorted to to deal with American banditti, is correct as set out in my letter of April 18th. There are enough outlaws hidden in the hills of Oklahoma to wipe out a town of 500 inhabitants.

The press, however, must be censored if the best results are to be obtained. The public is becoming increasingly indignant over the way newspapers broadcast information that aids desperadoes in making their escape. For example:

1. A conversation among bandits was overheard in which their plan to head for the Warsaw Hills was obtained. Immediately the press broadcasted this information. Their confederates can easily inform the fugitives that their destination is known and to change their route.

2. Recently a detective was shot. A local newspaper furnished the information that the death car was heavily nickel-plated with an unusual number of accessories which were nickle-plated. Being advised that the description of their car was known, they naturally removed the conspicuous accessories to avoid detection.

3. The papers this morning carried advance information that Nash was being brought to Kansas City as per clipping enclosed. What business had the press to publish this item? This information was disseminated by the early morning editions for the benefit of desperadoes before the underworld even had retired and in plenty of time to round up local killers.

As long as newspapers are really accomplices of desperadoes in helping them make their get away, no blame should attach to police officers for failure to "bring them in".


Dear Sir:



MEMORANDUM TO -
SPECIAL AGENT IN CHARGE:

This morning about 10 AM., Fred C. Kohut, residence Milby Hotel, Houston, Texas, called at the Federal Building and informed me that Mr. Homer C. Howell, 710 East 10-1/2 Street, Houston, reported to him that Mr. R. J. Harrell, Box 212, Galveston, Texas, who is employed as a Messenger for the United Fruit Dispatch and the Southern S. S. & Transport Company, told him, Howell, that while he was on a street corner in Prescott, Arizona on Friday, June 16, 1933, a man stepped up to him and asked him if he would be there for a while, and when he informed the man that he would, this man asked him to hold a package and he would return in a short time; that he, Harrell, waited about two hours and when the man did not return, he took the package with him on the train and upon examination of same found it contained a full loaded sub-machine gun; that he, Harrell, has this gun in his possession in Galveston and would not turn it over to anyone but a Government Agent.

Mr. Kohut stated that upon learning the above he sent a telegram to the Director of the United States Bureau of Investigation, and that I would likely get a request from the Director to make an investigation of the matter.

In compliance with the Director's telegram, which you relayed to me by telephone, I ascertained thru the United Fruit Company in Galveston by telephone where I might locate R. J. Harrell, and telephoned him, advising him I would call and see him in Galveston. I immediately proceeded to Galveston and located him at 409 - 21st Street, and he was interviewed at the Federal Building and made the attached affidavit, which is self-explanatory. He stated he told Mr. Howell the story about the gun simply to excite Mr. Howell's curiosity and told him to get his furtile brain to working and figure out why the man would give him a machine gun to hold and then run away; that Mr. Howell had at one time informed him he was studying detective work under a former Government detective, whose name he could not remember, but who evidently was Fred Kohut, and he simply gave Howell the story as a problem to figure out, not knowing that it was going to be related to someone else and cause an investigation. Harrell stated he informed Howell about the man giving him the gun when he talked to Howell on June 11th, and not on June 16th, as stated by Fred Kohut.

After returning from Galveston I interviewed H. C. Howell at his residence, 710 East 10-1/2 Street, Houston, where Fred Kohut was present, visiting Howell. Mr. Howell stated that Mr. Harrell gave him the story on June 11th when he was visiting at his house, and that he in turn informed Fred Kohut about what Harrell had related to him. Howell stated that at time Harrell informed him about the matter, he firmly believed that he was telling him the truth, but Harrell then told him he could not show him the gun as he had it in his baggage, which he had checked thru to Galveston. Howell stated that while Harrell is prone to joke with his friends, he firmly believed him to be telling the truth when he related the story about the man giving him the gun.

I informed Mr. Kohut in the presence of Mr. Howell that if he had any more information he desired to furnish to the Bureau, he should report it to the Resident Agent in Houston or to the Special Agent in Charge at San Antonio, and not furnish same direct to the Bureau, as the San Antonio Office would conduct such investigation as the facts merit.

This information is being furnished in memorandum form, as I do not believe you require a report, but desire to furnish the information obtained in letter form to the Bureau.

Before me the undersigned, a Deputy United States Clerk, personally appeared R. J. Harrell, who being duly sworn, deposes and states as follows:

My name is R. J. Harrell, and I reside at 1808 Avenue "M", Galveston, Texas. I am employed as an extra Messenger and Inspector for the United Fruit Company, at Galveston.

On June 11, 1933, I met H. C. Howell in Houston, Texas. He is employed as a Candy Maker at his home, and sells home made candy. He told me he was studying detective work under a man in Houston, whose name I do not recall. I told Howell that I had just come from Prescott, Arizona, and a day or two before, I believe I said Friday, June 9, 1933, while I was standing on the street corner in Prescott, a man came by me and asked me to hold a package for awhile; that I stood at this corner some time and the man did not return, and I came on to Galveston and brought the package with me. I told him I opened the package and found an automatic gun in it. I do not believe that I said it was a sub-machine gun. I do not remember whether or not I said the gun was loaded. At the time I told Howell about the man giving me a package, I told him it was in Prescott, Arizona, for Howell knows that I occasionally make trips for the United Fruit Dispatch thru that section, however, I have not been in Prescott, Arizona, for over a year. I merely told this tale about the man giving me a package which proved to be a gun, just to excite Howell's curiosity, and I wish to state that there is no truth in my statement to Howell, and it was told to him only as a joke.

No one has ever given me a sub-machine gun or any other kind of a gun. I never saw a sub-machine gun, and do not know what one would look like. I wish to state that in telling Howell this story about the sub-machine gun or automatic gun, I had no intention of causing any trouble, and did not expect that he would tell the story to anyone, which would result in the Government making an investigation about the matter.

I have read the above statement and same is true and correct.

Dear Sir:-

I read in Sunday's paper about the murder of the Special Agents and other officers in Kansas City, and was shocked to learn of terrible tragedy. I trust, however, that your Agents may be able to apprehend the killers within a very short time.

I believe some of your very best agents should get in touch with [redacted] as he may have some very valuable information concerning this case.

In our investigation in 1927 into the Cherryvale Kansas Bank robbery, he was our confidential informant and gave us the information that caused the apprehension and conviction of one Robinson, Hamm, and others who participated in the robbery, and also caused us to recover more than one hundred thousand dollars in bonds. Of course, I can't remember all the names of the defendants (subjects) but know that Robinson was convicted, Hamm apprehended in Miami and afterwards convicted and, perhaps, Judge West of Kansas City Kansas was not prosecuted. Other subjects were one Dr. Zeller and a Dr. Safford from whom we recovered several of the bonds.

You will find the reports from the Kansas City Bureau Office were made by Agent John Keating with whom I worked on the case.

[redacted] would not cooperate with the police as he feared that his activities would be disclosed to the underworld but, after a great deal of hesitancy, gave us the desired information.

[REDACTED] realized quite a sum in rewards for the apprehension of the criminals and for the return of the bonds.

This man assisted me in other cases and, in many instances, told me the true state of facts in many cases in which the Government was not interested. I have no doubt that [REDACTED] knows the identity of these murderers and, if given some time and the promise of a reward, will be able to cause their apprehension, if assured that his action will never be divulged to the underworld.

I sincerely request that you treat this information in the strictest of confidence as I don't want [REDACTED] to know that I have violated his trust. He was always square with me and I should like to retain his good will.

I expect you may be able to obtain some information as to the activities of [REDACTED] from the file to which I refer, however, I don't think the name of this informant is found in any report.

I am giving this information to you with the hope that it may be of some assistance in causing the apprehension and conviction of these bloodthirsty murderers.

If at any time I can be of service to you, you have but to command me.

As Henry Carlton, wanted 4-12-31, murder, Hixsonville, Missouri. (\$300.00 reward).

The file at the Chicago Bureau of Identification also shows numerous wanted notices being posted by various Chicago Police Officers and this individual is carried in Detective Bureau File #7774. A wanted notice was also posted at the request of the Sheriff of Muskogee, Oklahoma, on 8-7-30.

Sergeant Joseph Healy, now connected with the States Attorney's Office, Chicago, Illinois, formerly in the Detective Bureau, informed Special Agent W. Carter Bann by telephone that Carlton had been friendly with Barker and Karpis and a little over a year ago, was supposed to have shipped a package through Karpis' sister, Mrs. Neubold, but a watch placed on the home of Mrs. Neubold had failed to reveal that Carlton had ever called in Chicago since his removal in 1929.



Pursuant to a long distance telephone call from Mr. Barney Finn, Superintendent of the Identification Division of the Ft. Worth, Texas Police Department, I proceeded to Ft. Worth yesterday and received from Mr. Finn the following information:

That if the murder in Kansas City on 6/17/33 was by intention on the part of the gangsters to kill Frank Nash for revenge, the following facts might have some bearing on the matter. That he has information, and has had for a long while, that Frank Nash and one other person killed and buried in a shallow grave near Red Fork, 4 miles South of Tulsa, Oklahoma on 2/6/33 one Frank Holloway; that Holloway is a cousin of Earl and Shelby Stiff of Denton, Texas; that Earl was arrested some years ago in Ft. Worth with a stolen car and upon getting out of that case reformed and went to work as a reporter for the Ft. Worth Record, but is now down and out and sick, and some time ago bought a machine gun; that word has come to him that Earl has been practicing with this machine gun and has become very adept in the use thereof. Earl and Shelby Stiff, together with Yancy Storey and W.A. Martin, killed Bob Parsons, Deputy Sheriff, in Denton, Texas some few years ago. Yancy Storey was convicted and took 5 years in the Texas State Penitentiary; he now is reported to be living some place near Wellington, Texas. W.A. Martin served a term in the Texas Penitentiary for bank robbery. Earl lives around Ft. Worth some place; Shelby probably still resides around Denton. Mr. Finn described Earl Stiff as follows:

MEMORANDUM of telephone calls re FRANK NASH

I advised Mr. Vetterli at Kansas City by telephone that it had been determined that the latent fingerprints sent in by the police department at St. Paul in connection with the HAMM kidnaping case, appeared to be those of Frank Nash upon first inspection. I advised that these prints were being enlarged and a positive identification would be made as soon as possible.

Subsequently, I talked with Agent Coulter at St. Paul and also gave him this information, and requested that it be ascertained where and when these prints were taken, in order to place the whereabouts of Nash immediately prior to his capture in Hot Springs. Agent Coulter advised that he understood that these prints were taken from beer bottles found in 204 Vernon Avenue, St. Paul, which place was rented by three strange men and two women under fictitious names, and that these individuals had disappeared from that place at 2:55 a.m. on either June 19th or 20th, and that he had the descriptions of these individuals. I instructed that those descriptions be sent by special delivery to Kansas City.

Later, I advised Special Agent in Charge Jones, now at Kansas City, of the instructions issued to the St. Paul office with regard to the descriptions and fingerprints. I suggested that an Agent from Kansas City proceed immediately to St. Paul, and secure the facts.

Mr. Jones stated that they believed they had found the hang-out of some of the suspected individuals, and that they had Agents surrounding the place, working three eight-hour shifts.

In connection with the long-distance telephone call from the Kansas City Office to the Chicago Office on June 17, 1933, when it was reported that a number of long-distance telephone calls had been made to Central 5990, Chicago, Ill., and to Marrose Park 648, recently from the Southern Club in Hot Springs, Arkansas, the following investigation has been conducted by the Chicago Bureau Office.

It was remembered that the number Marrose Park 648 was that of the O.P. Inn located at Marrose Park, Ill., a suburb of Chicago, Ill. Reports in the file of this case indicate that Nash and his confederates frequented this Inn, and that at one time Nash was supposed to have stayed there when he was wounded. As is indicated in the Report of Special Agent J.J. Keating, Chicago, Ill., 5/19/33, this Inn was raided by State Police, accompanied by Bureau Agents in May, 1933, but no one of importance was found.

The Inn consists of about eight rooms on two floors, and sets back off the main road, a single driveway apparently serving as an entrance and exit. Because of its secluded position, it is extremely difficult to watch this place without creating suspicion. Information previously developed disclosed that while customers were readily admitted to the dining room which had a bar and where beer was sold, that the gangsters who frequented this place were in the habit of congregating in the rear room or upstairs.

Special Agents E.F. Mallico and E.C. Ryan were assigned to investigate the possibility that the persons who conducted the business in Kansas City might attempt to reach this Inn, and hide away. Agents Mallico and Ryan visited the vicinity of this Inn on June 18th, 1933, but did not deem it wise to venture in since business seemed inactive. The garage, visible from the road through its open door, seemed empty. These Agents then interviewed Frank Gallagher, District Three Headquarters of the Illinois State Police Department, at River and Rand Roads. Officer Gallagher is in charge of this station during the day. He is familiar with the occupants of the roadhouse known as the O.P. Inn. Officer Gallagher said that the Inn is reputed to be owned by Doc Stacey, his brother, "Coat" Stacey, of name unknown, Tony DeGrassi, and the latter's brother, Rocco DeGrassi. Officer Gallagher told the Agents that he and other officers raided the

O.P. Inn some time before agents from this office had advised the State Police that Nash was wanted as an escaped federal prisoner, and at that time that he had observed Nash in that Inn and wearing a wig. Officer Gallagher later accompanied agents on the visit to this point as has been referred to above.

Nash, Gallagher said, had been very friendly with Stacey and had called on various beer customers with Stacey. "Doc" Stacey was arrested recently by the Narcotic Bureau, so Gallagher had heard. He said that Tony DeGrassi is wanted by the Illinois State Highway Police on a charge of Murder, which crime was committed in Melrose Park, Ill., about six months ago. After this crime, DeGrassi disappeared. This man is known as a killer, and is reported to have connections throughout the entire United States with gangsters and hoodlums. Gallagher suggested the possibility that DeGrassi might have been one of the Kansas City murderers. Gallagher said that DeGrassi had served a sentence in Leavenworth, so he had heard, on some unknown federal charge. He described DeGrassi as about 40 years of age, height, 5'6", weight, between 155 and 160, build slender, and nationality, Italian. No record of this individual under the names of DeGrassi or DeGrasia appears in the Chicago Bureau Office.

An inquiry at the Bureau of Identification, Chicago Police Department by Special Agent W. Carter Baum showed that one Tony DeGrasia, fingerprint classification $\frac{V}{IV} \frac{R}{R} \frac{10}{10} \frac{I}{I}$ Ampt.

Chicago Police No. 8814, was arrested on December 12, 1930, on general principles. His home was listed as 425 22d Street, Melrose, Illinois, and his place of activity was given as Melrose Park, Ill. He was described as 35 years of age, weight 150, height 5'5 1/2", hair, dark chestnut, complexion, fair, teeth, full, eyes, hazel, marks and scars, middle finger operated at second joint, irregular scar over right brow. A picture of this individual is being obtained from the Chicago Police Department for transmittal to the Kansas City Office. This DeGrasia is undoubtedly the same man referred to as DeGrassi by Officer Gallagher. A previous record from Hartford, Conn., shows the name as Thomas De Marco. A notice on the file shows that De Marco is wanted by the Department of Labor. Lt. Arthur Katt, Chicago Police Department, in charge of the Hoodlum Squad, informed Agent Baum that Tony DeGrasia was reputed to be interested in a beer flat in the vicinity of North and Hanna Avenues in Chicago, Ill.

Officer Gallagher also mentioned a number of other places in the vicinity which are reported to be gangster hangouts. Gallagher said that he had a number of undercover informants in Melrose Park whom he would contact for all possible information concerning the O.P. Inn and the murders at Kansas City.

Officer Callagher was contacted by Agent Muller on June 10, 1933, and reported that all possible efforts were being made to obtain information. All information showed that the O.P. Inn was very quiet, having few customers since the advent of legal beer. Stacey spends most of his time playing golf. The Inn still bears the reputation as a hangout for wanted criminals, but no names or descriptions of any such character could be obtained, or the fact verified that any criminal is now using this place in which to hide.

Agents Muller and Ryan will continue to contact Officer Callagher and to conduct such other investigation as may be required.

Special Agent Jay C. Newman requested the Illinois Bell Telephone Company, confidentially, for a list of the toll calls made from the telephone number Melrose Park 648. It will be noted that a record is kept of all toll calls charged to that telephone number, but no record is kept of local calls, or toll calls paid for by the other party. The telephone company supplied a list of toll calls made to Chicago, Ill., and some suburban points near Chicago. This list is appended. The identity of the subscribers of the telephone numbers called will be ascertained, and the telephone company will be interviewed in order to learn if calls subsequent to 5/24/33 are available. Any such calls will be obtained and similarly checked.

Special Agent W.C. Ryan discovered from the Illinois Bell Telephone Company on June 17, 1933, that Central 8990 was an unlisted telephone which is subscribed to by one Joe Haves, 84 West Randolph Street, Room 830. The door of Room 830 bears the inscription, "National Glass and Mirror Company". Mail Carriers William E. Rosengart and Leo A. Turner were interviewed, and stated that Haves received a considerable amount of local mail, but that he received little mail from distant points. The room door is always locked and Haves receives few if any callers. He is known as a bookmaker of the syndicate type. He writes bets that other bookmakers do not care to handle because of the size of the bet, the risk, or other similar reasons. Haves has had an office at this address for about the last five years and has never been molested. There are a number of bookmaking establishments in the building at 84 W. Randolph, and the mail carriers were of the opinion that the agents for the premises were not adverse to this type of tenant.

Traffic Officer W. Hoffman, located at Dearborn and Randolph Streets, was interviewed by Agent Ryan and promised to watch for a car described in the message sent to the Chicago Office which might bear a Missouri license number, and for individuals resembling known acquaintances of Rank, whose pictures were displayed to this officer. Haves was described as being about 30 years of age, 5'9", 170#, ruddy complexion, hair, gray and partly bald in front.

Additional inquiry will be made at the Detective Bureau by Agent Baum in order to learn more particulars about Harves, and such additional investigation as may be necessary will be made.

After the receipt of advice from the Kansas City Office and from the local press, the Chicago Bureau Office immediately instituted investigations at a number of the places formerly frequented by Nash or his associates and places where friends of Nash might contact. Acting Special Agent in Charge D.O. Smith assigned Special Agents T.V. Miller, W.C. Ryan, J.L. Madala, J.R. McDonald, and J.B. Swanson to cover various angles of this case which was assigned to Special Agent Baum who arranged for the services of two details from the Detective Bureau on June 17th and 18th to assist in covering these places. The results of this investigation together with the data mentioned herein will be summarized in a report at an early date.

All contacts with informants are being actively maintained, and the various angles of the case are receiving active attention as they arise. The results of all inquiries will be reported to your office.



Mr. Hanni telephoned from St. Paul to state that an automobile bearing Missouri license #157309 had been used by the persons in the house where the beer bottles had been found containing Frank Nash's fingerprints, and that this car had been there from May 27th, when the people came into the house, until June 20th, when they vacated the premises, and that this information has been sent to the Kansas City office. Mr. Nathan telephoned and advised that it had been ascertained that this license had been issued to A. Carter, 3824 Main Street, Kansas City, Missouri, which is the address of a moving and storage company.

Mr. Hanni further advised that an automobile bearing Pennsylvania license #77V46 had been around that vicinity for about a week, but that he had been unable as yet to get a complete description of the car.

In a subsequent telephone conversation, Mr. Hanni suggested that the Bureau send a telegram to the police department at St. Paul advising that we have been unable to identify the fingerprints sent in taken from the beer bottles in connection with the Hamm kidnaping case, so that this telegram might be shown to newspaper representatives making inquiry in that regard. I advised Mr. Hanni that this was not desirable, but that I would send the letter for the St. Paul Police Department advising them of this identification, to Mr. Hanni for delivery. I also advised Mr. Hanni that in the future in such cases photographs requested by police departments will be sent to the Agent in Charge to be shown to the Chief of Police requesting the same, which pictures should then be returned to the Bureau by the Special Agent in Charge.

MEMORANDUM FOR THE DIRECTOR.

Agent Sackett at Philadelphia called and stated that further investigation of Nathan M. Green there, who appeared to be the owner of the car noted in St. Paul a week ago, developed that this car had been financed by the Huber Investment Company at Philadelphia; that Nathan M. Green had defaulted on his payments in April or May and that the Huber Investment Company at Philadelphia turned the matter over to the Burns Detective Agency and the Minneapolis branch of that agency seized and re-possessed the car under the name of the Huber Investment Company on May 4, 1933. He stated that at that time Green was located by the Burns Agency investigator J8 at 908 Ashland Avenue, St. Paul, where he was living with his sister. The Burns man drove the car to the Standard Garage at 215 South 3rd. Street, Minneapolis, and a storage check, #578, was received by the Burns Agency for the car. Subsequently the car was sold by the Burns Agency in Minneapolis. The date is not definitely shown, but the records of title and tag were changed in Pennsylvania on May 17, 1933, placing the same in the name of the Huber Investment Company. Said company said that they do not now have title to the car and the title has not been changed because of the fact that they have not received the check for the sale from the Burns Agency. However, they know that the car was sold about May 17.

I called the St. Paul office and gave them this information, together with a file number in the Burns Agency at St. Paul, #6196, and suggested that the man that they would be interested in is probably the man who purchased the car last and not Nathan Green. St. Paul will conduct immediate inquiries at the Burns Agency.


MEMORANDUM FOR THE DIRECTOR.

Agent Sackett of the Philadelphia office called late on the afternoon of the 23rd instant and advised that cautious inquiry concerning Nathan B. Green, the owner of the automobile seen in St. Paul about a week ago, developed only that Green seemed to be a very elusive person known to practically no one in the vicinity of the address which is shown in the State records on automobile registrations. However, from the mail carrier on that route, it was ascertained that the owners and residents of the house at 5375 Hazelhurst Avenue, Philadelphia, Green's address, are Mr. and Mrs. Benjamin Aschinski, and that the carrier in seeking to deliver mail from time to time addressed to Nathan B. Green had learned from Mrs. Aschinski that she is a sister of Nathan B. Green. It was stated that Green was away from this residence for long periods of time and no one in the vicinity of the address knew anything concerning him. A registered letter received for him in December, 1932, was directed by Mrs. Aschinski to some downtown house address, which Sackett hoped to obtain later.

It was suggested also to Agent Sackett that a check be made of the automobile permit bureau in order to obtain whatever information might be available there concerning Nathan B. Green, applicant for driving permit.

Because of other urgent matters which were immediately before me at the time Agent Sackett called, I suggested that he promptly communicate with the St. Paul office and furnish the information that he had so far ascertained and also to continue with a discreet inquiry concerning Green.

Dear Sir:

At Hot Springs yesterday I contacted confidential informant A, who told me that Nash's woman and little girl had gone from Hot Springs about 3:30 on the afternoon of the 16th by aeroplane to Joplin, Missouri, accompanied by H. E. Gladdis, whose true name is Dick Galatas and who is boss of a slot machine racket in Hot Springs, and in partnership with one Jig Clark, a broken down gambler, and McLaughlin, the mayor of the city.

Informant A states that Galatas is the official representative of the gangster world in Hot Springs and gets orders from the head of a big criminal organization in Chicago, said to be dominated now by a man named White, and that it is Galatas' duty in Hot Springs to arrange for and afford protection to the gangsters who come there to cool off or for other purposes.

Informant A told me that the aviator who was interviewed by Agent Chipman on June 18 had lied to Chipman but would tell me the truth, so I went to see this aviator - at the Municipal Airport - whose name is John Stever and who runs a flying service. Stever readily talked to me and stated that he had lied to Chipman because he was afraid of getting mixed up in it and because he did not know exactly who Chipman was. He said that the truth of the matter was as follows:

About 3:30 P.M. on the 16th, Gladdis drove out to his place and said that he had a woman and a little girl who wanted to get to Joplin very quickly and wanted to know if he, Stever, could take them, giving the information that the woman was in Hot Springs to get a divorce and wanted to slip out of town for a while. Shortly thereafter Gladdis returned with his wife, another woman and a little girl in a car. In the meantime Stever had gotten his Ryan Monoplane ready for travel. He stated that it appeared that Mrs. Nash, not having traveled by plane before, was somewhat apprehensive and there was discussion of Stever's wife going along. However, the party was in an awful hurry and they could not wait for Mrs. Stever to get ready, therefore, the last moment Gladdis stated to Stever that he would go along if he would bring him back that same night, which Stever agreed to do. They took off

about 4:00 P.M., proceeding direct to Joplin, where they arrived at ten minutes to six and Stover, not having made that trip recently, landed by mistake at the old airport, about a mile and a half west of Joplin, where there is a small filling station and lunch stand. No one was there to meet them and Gladdis went into this place and called a taxicab by telephone. Shortly thereafter the cab appeared and took Gladdis, the woman and girl away. The aviator then told Gladdis that he would fly over to the new airport to fill up with gas and oil and they would start back. Upon arrival at the new airport he saw a large man, weighing about 200 pounds, who is very stout, there in a large black sedan. This man had stated to the airport attendant that he was looking for a plane from Little Rock or Hot Springs, Arkansas. Stover's plane was pointed out to him as having just arrived from Hot Springs and he then asked "Where are your passengers?" On being informed that they had been taken to town the man left in a very great hurry. This man is no doubt Herbert Farmer, telephone 1241 W., Joplin. Shortly thereafter Stover received a telephone call from Gladdis asking him when he would be ready to start back and Stover, having found that he could get no gas until morning, told Gladdis and the latter directed him to come into Joplin to the Coombe Hotel, which he did, and they stayed that night at that hotel and started back to Hot Springs about 6 o'clock the next morning. Stover claims that he has not seen Gladdis since he brought him back to Hot Springs. Mrs. Nash paid the aviator \$100, consisting of one fifty dollar bill and five ten dollar bills. She handed the aviator her purse for a moment while she was getting into the plane and it was so unexpectedly heavy that the aviator almost dropped it and said that it must have contained a large pistol or a lot of coin. The aviator at the time he handed these people had not heard of the arrest of Nash down town a few hours earlier but stated that he would not have thought anything particular about the matter as he frequently hauls gangsters on hurry-up calls from Hot Springs to St. Louis, Indianapolis, Peoria, and other places and they always pay him liberally and he never asks questions.

I examined the Plymouth Coupe left by Nash and it bears motor number MC 45468, serial PG 65018C, Illinois license 624-497, Chicago City license 62-846, and has a speedometer reading of 8078 miles. Informant A told me that he thought this car would be found registered in the name of George L. Miller and that he had bought it in Chicago, having turned in a Buick on the trade. Chicago office has been asked to trace.

I found that Nash, as George L. Miller and wife, registered at the Oak Lawn Tourist Camp, Hot Springs, late in the night of June 14 - party of three - which was said to consist of himself, a woman and girl. They paid for the nights of 14th and 15th. The operatives of the tourist camp could give no further information, having paid but little attention to the party.

Informant A states that immediately after Dick Celeste returned to Hot Springs he ordered every gangster in town to leave and that

they have all disappeared and that Galatas himself has disappeared. He has a ranch in California and I will know the location of that tomorrow.

Informant A also stated that he thought that Nash and this woman, who is said to be from Peoria, Illinois, were married about a month ago at Hot Springs under the name of Miller. I got this information too late to verify there yesterday but am having it checked.

Informant A says that Herbert Farmer is a contact man and member of the gang in Joplin and that it was most certain that the information regarding in the massacre of Kansas City was sent from Farmer. The informant, however, apparently attempted to divert suspicion from Bailey, Watershill, et al and said that the execution was so easily ordered by one White, alleged present king of the gangsters in Chicago, particularly in the beer running line and that if White ordered the execution it was probably done by Bugs Moran Men. He stated that Bugs Moran spent two months in Hot Springs this winter. My personal opinion is that the informant is trying to divert our attention away from Harvey Bailey and his bunch, as I could not even interest him in looking at their photos. I found out, however, that Harvey Bailey was in Hot Springs two weeks ago and living very noticeably. It will be recalled that Nash was last in Hot Springs, prior to the date of his capture, about two weeks ago.

The informant states that Herbert Farmer is a very dangerous man, a killer, and his best known line is the gun game, and that he recalls that about six months ago Farmer took an old man and his wife from Hot Springs to Reno, where he cleaned them for \$50,000.00 on the race con. He says that Farmer is living with one Kether, a handsome black haired woman, who is the divorced wife of Walter Muhliss of Baroka Springs, Arkansas. The Nash file will show that we have investigated Walter Muhliss as being an alleged harbinger of Nash about a year ago. Muhliss is king of the gambling racket at Baroka Springs, Arkansas and is very powerful politically. Informant says that the gangsters now use Muhliss's place as a hideaway very frequently and may be there at the present time.

Informant does not think any telephone calls other than the one to Joplin and possibly those to 645 Malcolm, Chicago, had anything to do with the arrangements for the assassination at the Union Station. He states that Mrs. E. E. Cumber, when the records show to have placed the calls to 1841 W. Joplin, and 645 Malcolm, Chicago, did not in reality place those calls but same were placed by Mrs. Nash, who used the Cumber name for privacy. He thinks the call to Chicago was to "headquarters" there.

Informant A says that Herbert Farmer and his bunch have a big fight regularly once a month and that if we can get him in jail somewhere just after they have had a falling-out, that this year will "blow the cover

He says Farmer will also squeak if we arrest him on some charge and put the screws on him by making him believe that we have the goods on him for arranging the massacre. He says that in such an event if we play it strong enough that Farmer will squeak on anybody, but stated that if an attempt is made to arrest him every precaution should be made as he is a cold-blooded killer, his favorite weapon being the knife.

This Mrs. E. B. Decker, according to Informant A, is a member of the mob, whose husband Billie Decker was killed in New York by another woman some time or six months ago. She also reportedly left Hot Springs and Informant A advised me that someone had visited her apartment and Informant thought it was probably done by some agents.

The plane in which Galatas, the Nash woman and child, were taken to Joplin is a Ryan, carrying number NO 7072, and will be registered as landing at the Joplin airport on the 10th. No doubt the record of the registration of John Stever, the pilot, and possibly Dick Galatas, will be found at the Casino Hotel, Joplin.

Agent Harold Anderson contacted a valuable informant yesterday and secured a lot of information which will be valuable and he has a line on further information which he will procure today. He has moved over to the Lee Hotel, which is run by a Greek, who also has important information. Anderson is staying there under the name of Harry Anderson. I told him to keep under cover insofar as possible and to keep me advised of his whereabouts.

Informant A told me that he thought Dick Galatas would also squeak if pushed hard enough and I think that if we locate him in California it might be well to have him arrested there on a charge of complicity in the murder and I believe he will talk his head off.

A lot of telephone calls were put in on that date - in fact some seven or eight - at Hot Springs by W. S. Jacobs, calling Central 5090, Chicago. These calls were placed, some of them from Long Distance 1, some of them from Long Distance 17, Hot Springs, and some from 2701 Hot Springs. Jacobs is the owner of the gambling concessions at Hot Springs and owns the Salvatore Gardens, the Ohio Club and the Southern Club, and I expect that the calls placed by him at 12:34 P.M., 1:27 P.M., 2:21 P.M., 2:57 P.M., 3:02 P.M. and 3:28 P.M. on June 16 were merely calls to get returns on races. W. S. Jacobs from LD 17 at Hot Springs called Louisville, Ky., Jackson 2211, calling for the holder of the Louisville Trust Company. I think the last call was perhaps to verify some check that they had received in the gambling house.

I have found that the red Chrysler "protection car" which was stationed across the street from the White Front in Hot Springs when Smith

and Lasky arrested Nash is the car of Dick Galatas and is still in Hot Springs.

If we could locate the Casner woman we might get some information but I tried to find out from Informant A how she could be found but he professed ignorance. I also think that if we could locate the Mrs. Nash and little girl we might get something but it looks like the strongest key to the situation is Herbert Farmer of Joplin.
