NYA currently is controlled by individuals who militantly promote white racialism and anti-Zionism and who suggest violent revolution ultimately as the means for implementing their racial and political ideas in America.

The February, 1974 (Number 25), issue of "Attack!", the tabloid newspaper published by NYA, announced the formation of a new organization called the National Alliance (NA). The new organization was described in "Attack!" as a "superstructure for an anticipated array of specialized, coordinate groups", of which NYA will continue as the youth group for individuals 30 years of age and under. Persons over 30 years of age wishing to join the "movement" must become members of the new organization. According to "Attack!", "* * * the National Alliance will remain generalized in its appeal and its membership and will guide and direct all the special interest groups* * *."



WALLACE supporters following the 1968 Presidential election for the purpose of countering radical leftist and anarchist influences on the campuses of American colleges and universities. NYA currently is controlled by individuals who militantly promote white racism and anti-Zionism and who suggest violent revolution ultimately as the means for implementing their racial and political ideas in America.

When General Brown recently made a public statement revealing the extent of Jewish control over the lives of Americans, there was consternation in the news media. General Brown had done a "no, no." He had told the American people the simple truth.

How have the facts of Jewish control of America's foreign policy and her economy been kept secret for so long? Why is such a fuss made when one brave man speaks the truth?

The answer is that the Jews have managed to gain a monopoly control over America's news media, and they use their monopoly to determine what the people shall know and what they shall not know.

Television News

Consider, for example, the TV-news broadcasting industry. This is probably the single most influential mass medium.

Virtually all national and international TV news in the U. S. is filmed, edited and broadcast by just three corporations: American Broadcasting Companies, Inc. (ABC), Columbia Broadcasting System, Inc. (CBS), and National Broadcasting Company (NBC). The last is not an independent corporation, but is a subsidiary of Radio Corporation of America (RCA).

ABC

The president and chief executive officer of ABC is Leonard Goldenson. The general manager of ABC News is Martin Rubenstein, and under Mr. Rubenstein, as executive producer of ABC's TV-news programs, is Avram Westin.

CBS

The top man at CBS is Chairman of the Board William S. Paley. The CBS News subsidiary is run by President Richard S. Salant.

NBC

Robert Sarnoff is president, chief executive officer, and chairman of the board of RCA.

President and chief executive officer of NBC itself is Herbert Schlosser.

Alien News Monopoly

The major broadcasting corporations employ thousands of persons in executive positions, but the seven men named above are at the key control points. They are the ones who have the ultimate decision-making authority. They dictate what 210 million Americans shall learn of what has happened in the nation and in the world each day. All seven of them — Goldenson, Rubenstein, Westin, Paley, Salant, Sarnoff, and Schlosser — are Jews.

Newspapers Too

After television, daily newspapers are the most influential mass medium in America. Sixty-two million of them are sold (and, presumably, read) each day.

Those 62,000,000 copies are divided between some 1,700 different publications. One might guess that the sheer number of different newspapers would in itself provide a guarantee against minority control of this important medium. Unfortunately, such is not the case.

Today, more than half the daily newspaper circulation in America is controlled directly, and the remainder indirectly, by Jews, a minority group which makes up only 2.9 per cent of the total population. This extraordinary and dangerous situation has resulted in the press in America becoming, for all practical purposes, an instrument of Jewish policy.

The use of the press by the Jewish minority to set the policies which affect the lives of all Americans could hardly be better illustrated than by the examples of the nation's two most prestigious and influential newspapers: the New York Times and the Washington Post.

New York Times

The New York Times is the unofficial social, fashion, en-

tertainment, political, and cultural guide of the nation. Its influence and ideas reach into every stratum of American life. It is sold in virtually every community in the United States.

The New York Times (originally New York Daily Times) was founded in 1851 by Henry J. Raymond (1820-1869) and George Jones (1811-1891).

Shortly after Jones' death in 1891, the newspaper experienced a drop in advertising revenue that forced it near bankruptcy. As a consequence Adolph Ochs, a wealthy Jewish publisher, was able to purchase the paper from Jones' estate in 1896 for a modest price. After Ochs' acquisition of the New York Times, advertising revenues rose dramatically.

The present Jewish owners of the newspaper, the Sulzberger family, are related to Ochs through the marriage of Ochs' daughter, Iphigene, to Arthur Hays Sulzberger in 1917. Their son, Arthur Ochs Sulzberger, is the paper's current president and publisher.

Washington Post

A close second to the New York Times in national influence is the Washington Post, which, by establishing its "leaks" in most governmental agencies in Washington, has an inside track on news involving the Federal government.

The Washington Post was founded in 1877 by Stillson Hutchins and purchased from him in 1905 by John R. Maclean.

In 1933, at the height of the Great Depression, Maclean was forced into bankruptcy, and the Washington Post was sold at auction to Eugene Meyer, a Jewish financier, for a trifling \$825,000.

The Washington Post is presently run by Katharine Meyer Graham, Eugene Meyer's daughter, who is the principal stockholder and board chairman of the Washington Post Co., and Larry H. Israel,

who is the president and operating officer.

The Washington Post Co. owns Newsweek magazine, a number of radio and television broadcasting stations.

Instinct for Power

And the situation is worse — if that is possible — the motion-picture industry, other media. Jews, with an uncanny instinct for power, insinuated themselves into every nook and cranny of the communications industry decades before the profound influence of the media on public opinion and the democratic political process was generally recognized.

During the early part of the century they established bridgeheads in the motion-pictures, and broadcasting. By World War I they were already in a commanding position. In the years since 1945 they have tightened their grip on the media that they exercise virtual monopoly control.

Leading America by the

Coordinating their business interests with their political interests, they have not only profited financially from their control of the media but have used that control to bring in America's nose to the power base for themselves, which few dare oppose. They can make Congressmen, Presidents and — as Watergate has so clearly shown — even the people themselves do as they please.

This Jewish control of the American mass media is the single most important factor in our life, not just in America, but in the whole world today. There is nothing: famine, inflation, fuel crisis, war — anything dangerous to the future of the people.

Until this Jewish control of American public opinion is broken, continued misfortune, confusion, and decadence will be our lot, and there can be no national liberation or regeneration.

NO MORE WAR!

The Zionist minority in America, in collaboration with the Secretary of Defense and other high government officials, is trying to railroad America into another war. If Washington continues to support Israel's war aims against her Arab neighbors, then America will certainly become involved in the next outbreak of Middle East fighting. We

are still suffering from the effects of U.S. support of Israel before and during the October 1973 fighting. That caused an enormous increase in the price the Arab oil-producing nations charge America for oil, and it caused the temporary oil boycott which wreaked such havoc in the American economy.

Another oil boycott against America will be the certain consequence of renewed Middle East fighting, and it will disrupt America's economy far more than the last one did.

As Senator Fulbright, chairman of the Senate Foreign Relations Committee, warned recently, a new oil boycott will probably cause another Great Depression in America. Millions will lose their jobs, their homes, and their savings. When that happens there will be overwhelming pressure for America to take direct military action against the Arabs and attempt to seize the Arab oil fields. And

that will bring us into direct conflict with the Soviet Union, which also has vital interests in the Middle East. Since the Israelis have already threatened to use nuclear weapons against the Arabs, a direct U.S.-Soviet confrontation in the Middle East may result in Armageddon, as Senator Fulbright has warned.

But the Zionists don't care what happens to America. They are willing to fight to the last American GI and the last American dollar to hold onto their ill-gotten Arab land.

America's arsenals are already being stripped bare by Israel's insatiable demand for military weapons and munitions. Hundreds of our latest tanks and aircraft, thousands of heavy guns and missiles, and millions of tons of bombs, ammunition and napalm have been robbed from active-duty units of our armed forces and sent to Israel, crippling our ability to defend America's vital interests. During the October 1973 fighting

more than 600 new M60 tanks were "borrowed" from U.S. armored units, mostly those stationed in Europe, and they haven't been replaced yet. Instead, even more M60 tanks are being sent to Israel as the Zionists prepare to launch a new pre-emptive war. More recently, half the entire U.S. inventory of our new, wire-guided, anti-tank missile launchers were spirited out of the country and sent to Israel.

America's defenses have been dangerously weakened by the "Israel first-America last" policy of Secretary of Defense Schlesinger and other Zionist or pro-Zionist officials.

The damage that has already been done to America's economy and armed forces by this subordination of American interests to those of a foreign power is enormous. Infinitely worse damage will occur if this policy is continued. And it will be continued as long as

the Zionists have the Congress and the White House in their pockets. Only when the American people rise up, as General George S. Brown, chairman of the Joint Chiefs of Staff, said recently, and break this Jewish lobby will the policy be changed.

The time has come for a rising up!

The time has come for military personnel to seriously consider disobeying orders which put Israel's interests ahead of American interests. The time has come for civilians to engage in acts of civil disobedience — even

sabotage — in order to halt the further involvement of America in Israel's military schemes. The time has come to punish traitors. The time has come to put America first. Help the National Alliance do it!

The February, 1974 (Number 25), issue of "Attack!", the tabloid newspaper published by NYA, announced the formation of a new organization called the National Alliance (NA). The new organization was described in "Attack!" as a "superstructure for an anticipated array of specialized, coordinate groups," of which NYA will continue as the youth group for individuals 30 years of age and under. Persons over 30 years of age wishing to join the "movement" must become members of the new organization. According to "Attack!", * * * * the National Alliance will remain generalized in its appeal and its membership and will guide and direct all the special interest groups * * *."





PREFACE

This investigation is based on information which indicates that the National Youth Alliance (NYA) is engaged in activities which could involve a violation of Title 18, United States Code, 2383 (Rebellion or Insurrection); 2384 (Seditious Conspiracy); 2385 (Advocating the Overthrow of the Government); 231-233 (Civil Disorders); 2101-2102 (Anti-riot Laws); 241 (Conspiracy Against Rights of Citizens); and 245 (Federally Protected Activities).

The NYA was originally formed from a nucleus of Youth for (GEORGE C.) WALLACE supporters following the 1968 Presidential election for the stated purpose of countering radical leftist and anarchist influences on the campuses of American colleges and universities. Its efforts to establish in this country a German-type national socialism of the HITLER era emphasize white racist and anti-Semitic policies. The NYA tabloid newspaper, "Attack!" in its Summer, 1971, (Number 6) issue, advocated revolutionary action to destroy the existing system, since "It is no longer possible to cure the System.... by Constitutional methods." A series of articles entitled "Revolutionary Notes" published in "Attack!" beginning in the Summer, 1971, (Number 6) issue, and concluding in the October, 1972, (Number 15) issue, provided readers with instructions and diagrams for the construction of simple incendiary and explosive devices and techniques of guerrilla warfare "for use in counter-revolutionary situations." The Fall, 1971, (Number 7) issue of "Attack!" carried an editorial entitled "What We Must Do Now." which discusses "revolutionary action" and states in part: "We must think...in terms of assassinating federal judges, of burning the stores of businessmen who act as if they are more interested in what's good for business than what's good for White America, of dynamiting the TV transmitters and newspaper presses of the alien news manipulators, of harshly punishing Whites--male or female--who fraternize sexually with non-Whites, of putting the fear of terrible retribution into every treacherous politician and System-serving editor, advertiser, bureaucrat, or other public person."

III. NA/NYA OBJECTIVES

The January, 1976 issue of "Attack!" contained the following statement of NA/NYA objectives:

"What We Want"

"Our members are working to build a revolutionary new order of things in American life--a new order based on natural laws.

"We want to develop in America a healthy cultural and racial approach to politics reflecting an understanding of authority, discipline, duty and honor.

"We want to achieve an organic society which will not only protect and perpetuate the great traditional values of Western civilization but will purify the Western world of the degeneracy of communism and liberalism.

"We want to secure for our people control over our own destiny by eliminating from the nerve centers of our society every anti-American and anti-Western influence.

"We want to safeguard our racial identity by putting an end to the present insanity of enforced racial integration, which is threatening all involved with social chaos, cultural dissolution, and racial death.

The February, 1974 (Number 25), issue of "Attack!" the tabloid newspaper published by NYA, announced the formation of a new organization called the National Alliance (NA). The new organization was described in "Attack!" as a "superstructure for an anticipated array of specialized, coordinate groups," of which NYA will continue as the youth group for individuals thirty years of age and under. Persons over thirty years of age wishing to join the "movement" must become members of the new organization. According to "Attack!," "***the National Alliance will remain generalized in its appeal and its membership and will guide and direct all the special interest groups***."

"The National Alliance is a growing, dynamic organization of patriotic men and women concerned about America's future and determined to take a hand in shaping that future.

"Our members come from a wide variety of backgrounds, but we all share four things in common:

"First, a deep and vital concern for our Western racial-cultural heritage. We esteem that heritage, created for us by the blood and toil of our ancestors over many thousands of years, as our most precious possession. We accept as the sacred obligation of our generation the defense and the furtherance of that heritage, so that we may pass it on, enhanced, to our descendants.

"Second, a recognition of the natural inequality of men. We recognize that any truly progressive society cannot be based on an artificially imposed 'equality', just as it cannot be based on a system of privilege according to wealth or social class, but must instead be organized so as to offer to each member of society an opportunity, commensurate with his demonstrated character and ability, for the contribution of the fruits of his talent to the whole community.

"Third, an absolute rejection of neo-liberalism in all its sickly and destructive manifestations. We understand that this disease of the spirit, whether it raises its head in the guise of revolutionary Marxism or as the media-peddled philosophy-religion of the present System, is alien to our people and must be utterly rooted out and eliminated, along with its bearers.







THE RHODESIAN CRISIS is shaping up as the worst disaster to befall our people since World War II. The Jews and their neo-liberal camp followers are so confident of a White defeat they can almost taste the Rhodesians' blood. And it is particularly frustrating for us to be in a position where we cannot play a really decisive role in changing the outcome of this situation.

We may be tempted, as individuals, to buy a ticket for Rhodesia, so that we can volunteer to help kill Black terrorists there. But the people who really need to be killed, the people who are really responsible for Rhodesia's present crisis, are right here in America. And it is here that we must do what we can.

The new issue of ATTACK!, which will be mailed in the next few days, will have a long feature article on Rhodesia, with many photographs. The article will be directed at the man in the street and will attempt to make him understand what is at stake in Rhodesia—and who the villains are. All members and supporters are urged to begin planning now to distribute as many copies of this issue as possible.

AN ALLIANCE ACTIVIST in the Danbury, Connecticut, area, William Bingel, Jr., has written the National Office about his organizing efforts. "The recent warm weather here," he reports, "has brought the Blacks out," and this has led to an early upswing in clashes between Blacks and Whites this year. The result has been that a number of young men of Mr. Bingel's acquaintance who showed no inclination to participate in Alliance activities during the winter have begun dropping by again, with suggestions that the Alliance "do something about the niggers."

Mr. Bingel has had little patience with these fair-weather friends and has told them that, unless they are willing to work with the Alliance over the long haul, giving up their beer-and-football time for things a little less exciting than thumping some of the local wildlife, they can go solve their own "nigger problems."

"With that," he reports, "most left, mumbling and grumbling. However, a few other guys, not a part of that crowd, are now kicking in \$1.50 per week for the cause—\$1 for the Alliance and 50¢ for our own needs, such as extra ATTACK!s and other things to spread the word and help recruit a revolutionary band of patriots who are on the up and up, and not just loudmouthed punks. Right now I'm trying to collect enough items for a tag sale, the proceeds to go to the Alliance."

Mr. Bingel also writes that, on top of everything else now putting demands on his time, he has just become the father of a baby girl—his second.

FOREIGN CORRESPONDENCE AND PUBLICATIONS have been arriving at the National Office in increasing volume. At least six new racially oriented groups have sprung up in Germany in the last few months. England is also increasingly active. Most of the new organizations are quite small and suffer

from more-or-less severe shortcomings of one sort or another, but it is encouraging to note the increasing restlessness everywhere.

MONTHLY MESSAGE V

Last month we received the first part of the answer we have been seeking. It did not seem to tell us much, but in reality it contained the essence of everything else we will learn. Let us think about it for a moment before we go on.

What we are seeking to discover is man's purpose, both individually and collectively. Throughout a billion years of evolution the answer to our question has slowly taken shape and has been written by God on our souls, just as a different answer to an analogous question has been formed in the deepest part of the being of every living creature—and the non-living as well. (That is, the answers are different in detail, but they are all the same in a more general sense.)

In the words of one of our sisters in spirit, the sum of all these answers is the total expression of "that mysterious and unfailing wisdom according to which Nature lives and creates: the impersonal wisdom of the primeval forest and of the ocean depth and of the spheres in the dark fields of space."

To each creature and to each race of creatures the answer assigns a role and determines its relationship to the Whole. We can have only imperfect knowledge of the answers which apply to other creatures, to other races, for, although our science can tell us much, we cannot see into their souls.

What is the role of the Negro? It is evident that for the last few hundred thousand years, at least, the Negro's message has, unlike ours, told him to stop and rest. Does it also tell him that, like so many other creatures in the past, his role is finished? Perhaps we will know later.

And what of the Jew? Who can see into those dark and murky depths? Judging only from what we can observe, we might easily guess that his role is analogous, on the human level, to that of the bacterium on the subhuman level: to serve as a ferment of decay and decomposition, infecting and bringing about the disintegration of civilizations and races not proof against him. His role is to stand in the path, cleverly persuading some to turn around and go back, slyly tripping others and causing them to stumble into the depths to one side or the other.

But the message for us is that we must neither turn back nor rest, but must continue upward, overcoming every obstacle in our way.

Upward, where?

Upward, why?

When we ask these new questions, the fiery characters before us shift and change, and now we can read:

"Upward, toward the Creator."

"Upward, because you yourself are not only an instrument of the Creator but a living part of his Being, which is the Whole. While you were unconscious of this truth, you were a very imperfect instrument of his Will. But now the truth has been revealed to you, and as your understanding of that truth grows, so will your degree of utility as an instrument in the service of that truth.

"And so will grow within you the portion of the Whole; so will burn more brightly within you the Divine Spark. And that Spark will serve to guide you further along the path you must follow."

Then, for a moment, the mists clear, and we are able to catch a breath-taking glimpse of what lies ahead of us. It is as if we are standing on a narrow, rocky ridge. Behind us it falls off steeply into the dark jungle from which we have been slowly and laboriously climbing for so many eons—a jungle whose tendrils still curl across the ridge for some distance ahead of us, forming snares which will trip us if we are insufficiently vigilant.

But the ridge eventually rises above the last of the jungle and into the crystalline air above. And as our eyes continue to follow the ridge before us, ever upward, mounting to dizzying heights, we can only guess at the dangers which lie there. We already know that there were safer stretches of the ridge behind us, where the climbing was easier than it is now.

But, despite the dangers, the ridge ahead of us remains unbroken—and unending. Finally, it passes beyond the limit of our vision in the starry sky above. Who knows what new worlds it reaches—and then leaves behind it?

All we know now is that, unlike others who must remain in the jungle below, we must continue along this never-ending, always upward path toward Godhood. But, even as the mists swirl about us once again, we can faintly see other signs ahead, and we shall soon be able to decipher them. They will tell us more that we need to know in order that we can continue climbing with a sure sense of direction that will keep us from stumbling off the path.







The National Youth Alliance (NYA) is an organization originally formed from a nucleus of Youth For (George C.) Wallace supporters following the 1968 presidential election for the purpose of countering radical leftist and anarchist influences on the campuses of American colleges and universities. NYA currently is controlled by individuals who militantly promote white racialism and anti-Zionism and who suggest violent revolution ultimately as the means for implementing their racial and political ideas in America.

The February, 1974 (Number 25), issue of "Attack!", the tabloid newspaper published by NYA, announced the formation of a new organization called the National Alliance (NA). The new organization was described in "Attack!" as a "superstructure for an anticipated array of specialized, coordinate groups," of which NYA will continue as the youth group for individuals 30 years of age and under. Persons over 30 years of age wishing to join the "movement" must become members of the new organization. According to "Attack!", "the National Alliance will remain generalized in its appeal and its membership and will guide and direct all the special interest groups".

ORIGIN, OBJECTIVES AND LEADERSHIP

The National Youth Alliance (NYA) was organized following the 1968 Presidential Election Campaign from the membership of the Youth for Wallace, an organization, which actively supported the candidacy of Governor GEORGE C. WALLACE for President of the United States during the 1968 Election Campaign.

During early 1969, it became apparent that elements within the NYA were oriented towards fascism or Nazism.

"We want to develop in America a healthy cultural and racial approach to politics reflecting an understanding of authority, discipline, duty and honor.

"We want to achieve an organic society which will not only protect and perpetuate the great traditional values of Western civilization but will purify the Western world of the degeneracy of communism and liberalism.

"We want to secure for our people control over our own destiny by eliminating from the nerve centers of our society every anti-American and anti-Western influence.

"We want to safeguard our racial identity by putting an end to the present insanity of enforced racial integration, which is threatening all involved with social chaos, cultural dissolution, and racial death.

"We want to foster among our people, through the restructure of our information media and our educational system, a new spiritual outlook; the outlook of free men living and working in harmony with Nature.

"We want to make possible for our people a new way of life, a meaningful and satisfying way of life as opposed to the present rat race in which every man and every woman exists simply as an exploitable economic unit.

"We want our country, one day, to have a sane policy toward the other nations of the world, in place of the self-destructive idiocy which presently passes for American foreign policy. We need a policy based on a recognition that our interests are bound up with those of the other peoples sharing our common racial-cultural heritage, whether in Canada, Europe, southern Africa, Australia, or elsewhere, and that other races must develop in accord with their own, distinct racial-cultural imperatives--without help or hindrance from us except where such development poses a distinct threat to our own security."

The NA/NYA publishes a tabloid newspaper entitled, "Attack" and an internal bulletin entitled, "Action". Newspaper articles are mainly anti-Jewish and anti-Black in nature and [REDACTED] does not hesitate to criticize national leaders who do not support the NA/NYA view of racial segregation. The "Action" bulletin describes local NA/NYA events and [REDACTED] uses it as a forum for his spiritual views of man.

During the past two years, the NA/NYA has held several public meetings in the Northern Virginia area where PIERCE has spoken on a number of major national issues such as the Arab oil embargo and forced school busing. These public meetings only attracted approximately 20 to 30 participants. Due to the lack of activists within the organization, PIERCE has abandoned the use of public demonstrations.

At the present time, the main thrust of the organization is the publishing and distribution of the newspaper "Attack" in the greater Washington Metropolitan Area. There is no known organized NA/NYA activity outside of the Northern Virginia Area.

The NA/NYA has no formal organizational structure since [REDACTED] handles all organizational matters. Two part-time staff workers assist [REDACTED] by servicing the organization's newspaper racks which are located mainly in Washington, D. C.

BASIS FOR INVESTIGATION

During the early 1970's, the NA/NYA organization was

revolutionary in nature. A letter circulated with the summer, 1971, issue of "Attack" indicated the organization had begun a dramatic new phase of its development which included using the most radical and aggressive methods which could be devised in a program of intensive organization. It also stated the organization intended to adopt a bold revolutionary tone for its publication "Attack", and hoped to attract young marxist militants to the cause.

A series of articles entitled, "Revolutionary Notes" was inaugurated in the summer, 1971, issue of "Attack". These articles provided readers with instructions and diagrams for the construction of simple incendiary and explosive devices. Subsequent articles discussed "medium-sized bombs", "improvised detonators", and "construction of FGAN bombs."

The "Revolutionary Notes" articles were discontinued in October, 1972, and the revolutionary character of the NA/NYA was de-emphasized for the apparent purpose of winning support of a sizeable segment of "conservative" Americans who opposed continued American support of Israel in its conflict with Arab nations.

CONSIDERATION OF THE FACTS

The NA/NYA was originally formed as a revolutionary organization which advocated armed revolt and emphasized the use of bombs and incendiary devices. Apparently due to the lack of acceptance by the general public, the NA/NYA de-emphasized their revolutionary philosophy and began to emphasize racism and the downgrading of the Jewish religion. [REDACTED] the NA/NYA, has carried on his organization's program by verbally attacking Jewish leaders, blacks in general, and prominent United States leaders who oppose racial segregation. The NA/NYA is completely dominated by [REDACTED] and there is no organized activity outside of the Northern Virginia and Metropolitan Washington area. [REDACTED] main objective is the publication of his tabloid newspaper and he has shown little enthusiasm for expanding his organization, due in part to the lack of acceptance by the general public.

[REDACTED] has not engaged in any known illegal acts or overt actions which could deprive persons of their civil rights under the constitution, laws, or treaties of the United States.

On January 1, 1967, the official name of this organization was changed to National Socialist White People's Party. The NSWPP supports and follows the line of hatred against blacks, Jews and communists through various propoganda media, demonstrations, and other publicity-seeking devices for the purpose of seeking a legitimate dominant political party within the United States and in foreign countries. Headquartered in Arlington, Virginia, the NSWPP is currently led by Matthias Koehl, Jr.

b7c On 7-12-86, SSA [redacted] OCPA, telephonically advised he had been contacted by a representative of the National Alliance Newspaper, a self described "progressive newspaper", seeking the FBI's reaction to a proposed news conference to be held on 7-15-86 (time undisclosed) by the editor of the newspaper. The topic of the proposed news conference is the Arab Anti-Defamation Committees's evaluation of the FBI's investigation into the death of Alex Odehe. Odehe was killed last year in the state of California and the killing has been the source of some news media attention.

b7c SSA [redacted] advised the proposed site of the news conference was the public sidewalk outside the JEH building. The editor of the National Alliance Newspaper, who would be giving the news conference was not identified further. [redacted] noted that an unspecified Congressional subcommittee was scheduled to commence hearings on 7-16-86, on the subject of attacks against various Arab-American groups in the recent past.

b7c The representative of the newspaper was advised by SSA [redacted] that the FBI had no objections to such a news conference, but suggested to the representative that notification should be given to the Metropolitan Police Department, and any permits which may be necessary should be obtained.
