The Criminal Investigative Division (CID) proposes disclosure to the [REDACTED] of information concerning [REDACTED]. The Privacy Act of 1974,^{1/} as applied to this matter, directs that, in the absence of [REDACTED] consent, data concerning him be disclosed by the Federal Bureau of Investigation (FBI) only if one or more alternate conditions are satisfied.^{2/} [REDACTED] has not authorized FBI disclosures concerning himself.

One of the Privacy Act's alternate conditions permits the FBI to make "routine use" disseminations; i.e., releases which are compatible with the purposes for which information was first collected.^{3/} Pursuant to statutory direction,^{4/} the FBI publishes notices identifying, among other things, routine uses for information in FBI records systems. 

Station knocked off in 'act of terrorism'

HUNTINGTON, W.Va. (UPI) — The FBI is investigating a cable-cutting incident that knocked a television station off the air shortly before it was to begin a series on the activities of the Ku Klux Klan and neo-Nazis.

WOWK went off the air at 10:46 p.m. Monday, minutes before it was to broadcast a five-part series on the Klan, neo-Nazis and other extremist groups called "West Virginia: A Haven for Hate?" Programming did not resume until 1:10 a.m. yesterday.

The station's vice president and general manager, Leo MacCourtney, called the vandalism "an act of terrorism." Two FBI agents spent about 2½ hours at the station interviewing MacCourtney and viewing footage and promotional spots of the series, said Bob Willis, WOWK promotions manager.

MacCourtney linked the vandalism with the series primarily because the station had received calls threatening lawsuits if the series was aired, Willis said.

"We got two or three calls [Monday] between 7:30 and 8 p.m. threatening suits if we ran the series, but there were no threats of violence," Willis said. "A couple of people even identified themselves as people who had been interviewed" for the series, he said.

"Somebody climbed a fence behind the station where satellite dishes are and sawed or hacked a large cable leading to the network satellite dish, killing the network," he said.

"At the same time, somebody got on top of the building and cut another cable to our microwave system that goes into the transmitter. That knocked us off the air locally. Somebody knew what they were doing."

The station planned to run series unless the FBI asks that it hold off, Willis said.

He said the series will show there is considerable activity by neo-Nazi groups in West Virginia.

"It's surprising to me that these groups are running around here," he said. "They're here. That's for sure."

One neo-Nazi who has set up shop in West Virginia is William Pierce, who wrote a new philosophy for white supremacists. His novel, "The Turner Diaries," is said to be a training manual for the Klan.

Pierce, 51, has bought two pieces of land totaling about 345 acres in the mountains of eastern West Virginia. Under the name of the Cosmotheist Community Church, Pierce and a band of followers have obtained tax-exempt status for the land.
