Above referenced Bureau teletype denied authorization for a 180 day extention in captioned domestic security/terrorism investigation, citing that LHM did not contain any allegations of criminal activity in the furtherance of social or political goals, which is a primary criteria in justifying a DS/T investigation or authorizing the continuation of an ongoing investigation.

Pittsburgh Division is currently holding in abeyance investigation of the captioned subject pending Bureau approval for reinstitution of full domestic security/terrorism investigation. Analysis of results of pen register and additional investigative leads developed through review of materials obtained through search conducted November 8, 1986, at Pocahontas County, WV, landfill/garbage dump will be handled upon Bureau approval regarding Pittsburgh Division request set forth herein.

b7c [REDACTED] Additional investigation determined that during October, 1984, PIERCE had purchased 346 acres for \$95,000 cash in Pocahontas County, West Virginia (WV). Subsequently, PIERCE relocated the headquarters of the National Alliance from Arlington, Virginia (VA), to Pocahontas County, WV.

The National Alliance was formed from the reorganization of the National Youth Alliance (NYA) in approximately February, 1974. The N/A was described as a superstructure for an anticipated array of specialized coordinate groups. The NYA continued as the youth group for persons under thirty years of age, and the N/A for persons over thirty years of age. The NYA is a coalition of conservative youth groups whose purpose was to control certain campus oriented groups which were causing chaotic conditions in the United States college campuses. The NYA promotes white racism and antizionism, suggesting violent revolution as the ultimate means for implementing their ideals in the United States. The NYA is opposed to the use of dangerous drugs, anarchism, marxism, other radical groups, foreign wars and black organizations. The organization publication was known as Attack.

b7d [REDACTED] There were approximately twelve cities considered to be activist, which included Alexandria, VA; Springfield, Massachusetts (MA); and Wilmington, North Carolina (NC).

In 1972, the NYA published a series of articles entitled "Revolutionary Notes", instructing readers in the construction and deployment of simple explosives, incendiary devices and the techniques of urban guerilla warfare. Articles in Attack advocated political assassination and destruction of the system by total revolution. The organization advocated violence if other means failed to control radical campus groups.

A review of material recovered from the above search indicated several coded lists of members of the "Order". Included in this list was a code name [REDACTED] and the telephone number (703) 979-1886. This was the telephone number for the National Alliance, 542 23rd Street, South Arlington, VA.

Investigation conducted by the Alexandria Division, FBI, established that the N/A had vacated its quarters in Arlington, VA, and that new headquarters for this organization were relocated to Pocahontas County, WV.

During the weekend of September 6-7, 1986, a dedication was held at the Cosmotheist Community compound wherein the headquarters building was officially completed and opened. PIERCE had established a print shop, computer center and other offices at that compound for engaging in fundraising and establishing a computer network for the right-wing extremist groups.

b7c [REDACTED] have made several unsuccessful efforts to purchase a storefront building in Hillsboro, WV, for purposes of establishing a bookstore from which to establish public contact and raise funds for the sale of published materials available through the Vanguard Press, an affiliate of National Alliance.

Extensive financial records, personal correspondence, computerized National Alliance mailing lists and other significant intelligence information were recovered from a landfill in Pocahontas County, WV. A review of these materials has determined an established mailing list of National Alliance associates not only throughout each region of the United States but also in South Africa, West Germany, England, Canada, Mexico, Norway, France, Switzerland, Spain, South America, Sweden, Italy, Australia, Belgium, Portugal and the Middle East.

A review of a National Alliance Bulletin dated November-December, 1986, contained an article concerning recruiting guidelines for the National Alliance. Contained in this section of the bulletin in part was the following quote:

"There is a greater need for recruiting members inside the system; persuading men and women who now occupy positions in the government, the armed forces, educational establishments and a wide range of industries to remain where they are and begin using their positions to serve the alliance. This need is the consequence of both a deceased reservoir of potential cadres and the lengthened revolutionary time scale with which we must contend. When we cannot have as much internal strength as we would like, then we are more dependent on allies inside the enemies camp ..."






