KLUX KLAN, INCORPORATED, ALSO KNOWN AS THE
INVISIBLE EMPIRE, THE ANCIENT ORDER OF THE
KNIGHTS OF THE KU KLUX KLAN**

William Lloyd Jacobs, Durham, North Carolina, advised on May 3, 1967, that The Invisible Empire, The Original Knights of the Ku Klux Klan (IKKKK) had the original charter of General Nathan Bedford Forrest. He said this klan had become totally inactive but on September 4, 1966, at Stone Mountain, Georgia, it was reactivated.

On May 10, 1967, and June 6, 1967, a source advised that the national headquarters of IKKKK was Post Office Box 1652, St. Petersburg, Florida, and regional headquarters was Post Office Box 932, Shelby, North Carolina. W. W. Lynch was shown as Klajutant of the Realm of North Carolina, South Carolina, and Virginia.

The same source advised on September 27, 1967, that on the preceding day, Lloyd Jacobs stated he had incorporated IKKKK in North Carolina under the name The Ancient Order of the Knights of the Ku Klux Klan (AOKKKK). He explained that the organizations were one and the same and that he had incorporated under a different name so he could retain control of AOKKKK in the event he had a falling out with the leadership of IKKKK.

A second source advised on May 11, 1970, that W. W. Lynch calls his organization by two names, either The Ancient Order of the Knights of the Ku Klux Klan, or The Invisible Empire, The Ancient Order of the Knights of the Ku Klux Klan. There is no known affiliation with any other Klan group. Lynch has been referred to as Imperial Wizard, National Director, and Klajutant. He is the only known state or national officer of this organization. The address of the headquarters of AOKKKK is Post Office Box 932, Shelby, North Carolina.

The second source advised that the general objectives of AOKKKK are to prevent integration and to fight communism by any means.
