Reference is made to my letter dated September 17, 1946 in the above-captioned case in which you were advised that SIEGEL contemplated making a trip to New York City in connection with securing a loan.

This is to advise that it has been ascertained through [redacted] that reservations have been made on American Airlines, Los Angeles, for SIEGEL to leave Los Angeles on October 3, 1946 at 10:10 p.m. on Flight 170. This office is making appropriate arrangements to cover the departure of SIEGEL from Los Angeles and you will be immediately advised as to his leaving Los Angeles. b2

In connection with the proposed trip of SIEGEL to New York City, it is desired that your office make the appropriate arrangements to cover SIEGEL's activities completely at such time as he arrives in New York City and during the tenure of his stay there. As previously pointed out in the referenced letter, SIEGEL has been in contact with MEYER LANSKY, who is well known to your office. In addition, it has been noted that SIEGEL has been in contact with [redacted] who is also well known by your office. It is considered very possible that SIEGEL will spend considerable time with LANSKY and possibly [redacted]. In this connection, I desire to stress the importance of covering SIEGEL's activities in New York relative to his contacts with these individuals and other outstanding hoodlums in the New York Field Office territory. b7c

For your assistance in covering SIEGEL's activities there are attached two photographs of SIEGEL, which are considered to be extremely good likenesses of him. For a complete description of SIEGEL, reference is made to the report of Special Agent [redacted] dated August 28, 1946 at Los Angeles, in the instant case, wherein on Page 63 SIEGEL's description is set forth. b7c

Further, it has been ascertained that Mrs. ESTHER SIEGEL, the subject's former wife, whom he divorced recently at Reno reportedly resides at 88 Central Park West, Apartment 9, New York City.

Las Vegas Club Building Halted

WASHINGTON, Sept. 30. — The compliance division of the War Relocation Administration has temporarily halted construction of the Flamingo Club at Las Vegas, Nev., pending an investigation to determine whether construction was under way before C.P.A. issued a stop order on nonessential buildings March 25.

The club, when completed, is expected to cost between \$2,500,000 and \$4,000,000. Already over \$200,000 worth of construction has been put into the club.

Reference is made to teletype from the Los Angeles Field office dated September 18, 1946, wherein it was stated that according to information received from confidential sources, SIEGEL receives [REDACTED]

It was also suggested in reference teletype that in view of the close associations between MEYER LANSKY and "BUGS" SIEGEL, the relationship between MEYER LANSKY and [REDACTED] should be ascertained.

Reference is also made to the report of Special Agent [REDACTED] dated September 26, 1946 in the above entitled case, wherein information was set forth that [REDACTED]

During the course of a surveillance conducted on the activities of the chauffeur of MEYER LANSKY on October 1, 1946, it was ascertained that at about 11:00 a.m. on this date he went to the Paramount Jewelry Exchange, 66 Bowery, New York City. He was not observed taking any packages nor delivering any [REDACTED] at this address. It is suggested, however, that the Los Angeles Field office, in view of the information heretofore obtained, be alert for shipments of cash received by SIEGEL through his possible intermediaries.

The New York office will also check registered mail shipments from [REDACTED] to SIEGEL or his known associates for the pertinent period.







The following information was made available through [redacted] with reference to the purchase of the Chi-Chi Bar Restaurant at Catalina Island.

On October 10, 1946 [redacted] was in contact with one [redacted] (Phonetic) at the Beverly Wilshire Hotel, after which [redacted] spoke to [redacted]. [redacted] informed [redacted] that he had heard of a spot that [redacted] might be interested in; that it was the best bar and cocktail room or restaurant in Catalina. He informed [redacted] that it was the Chi-Chi and [redacted] inquired as to whether this was the one [redacted] had an interest in. [redacted] stated that [redacted] was supposed to have had an interest in it, but that a friend [redacted] owns it and he has no one to take care of the business. Further, [redacted] was supposed to take care of it; however, he only went over there once or twice. The owner, according to [redacted] has a great deal of outside interest, and tried to place a brother in the business who did not fit into it. Regardless of this the proposition made money for his friend. The friend desires to sell the Chi-Chi for \$60,000 and [redacted] related that his friend had paid \$52,000 for the place and had spent \$18,500 fixing it up. [redacted] described the place as being "a h[redacted] of a buy". He related that the business was good for \$30,000 or \$40,000 for the summer season. [redacted] stated he wanted to get a report on the business and [redacted] said he would get a report by the next night. [redacted] was to leave town on the 11th; however, he stated he would cancel his reservations. [redacted] informed him that he would have called [redacted] in Chicago and had him come out and look at it as it was a natural proposition and Catalina was a "ball of fire". Assistant Director ROSEN called from the Bureau at 1:15 p.m. today and stated that the Bureau had instructed the spot surveillances on SIEGEL at New York City and [REDACTED] be discontinued. This is being done in an effort to conserve manpower. He asked what spot surveillances were in effect at Los Angeles and I told him that we had no spot surveillances in effect here; that VIRGINIA HILL had left for Chicago yesterday, but we did not have any surveillance on her nor did we request Chicago to surveil her. Mr. ROSEN then inquired concerning technical surveillances and I told him that at Los Angeles we were on [REDACTED]. Mr. ROSEN suggested that these technical surveillances be discontinued and I advised him that they were being operated [REDACTED] at the Los Angeles Office and, therefore, required no additional manpower. I also pointed out to Mr. ROSEN that at the conferences at the Bureau it was decided that we would keep on the technical surveillances at Los Angeles and Las Vegas until we had inquired into the Flamingo Hotel matter. I advised Mr. ROSEN that we were covering the Las Vegas Club and also Room 401 at the Last Frontier Hotel at Las Vegas and this required two men on the plant. Mr. ROSEN said that we would continue this technical coverage.

I asked Mr. ROSEN if any information had been secured at Washington concerning an additional C.P.A. stop order and Mr. ROSEN said that there had not. He requested that I call him on Monday, October 14th, to ascertain the Bureau's attitude toward the further investigation of the Flamingo Hotel matter.
