Dear Sir:

Reference is made to letter from this office to the Bureau of November 23, 1944, reflecting an attempt being made at that time to reduce the amount paid to this organization from \$2,000 to \$1,500 per month, and to the Bureau's reply in cable No. 256 of December 12, 1944. The latter cable suggested that this office pay the informant organization the original agreed amount, \$2,000. (X)

Following the Bureau's suggestion, the second installment paid this informant in December, 1944, was according to the original agreed amount, that payment consisting of \$1,000. The relationship with this informant has apparently not been impaired by this attempt to reduce their payments. However, the question whether this office should make up the amounts paid during that period when the sum to be paid them was being decided has not been settled; that is, it is undecided whether this office should pay the informant \$750, representing the difference between \$1,500 and \$2,000 during November, 1944, and \$1,750 and \$2,000 during December, 1944. The informant understands that this matter is being decided and advice of the Bureau is requested as to whether this back payment should be made. (X)

Reference is made to your letter of February 20, 1945, requesting advice as to whether a back payment should be made to the Basque organization in connection with a temporary reduction in the sums paid to them during November and December, 1944.

It is suggested that you determine this on the basis of your local relations with the Basques. It would be desirable not to pay additional sums at this time, inasmuch as the services rendered by them in November and December were rendered on the basis of payments made to them at that time. If necessary, however, to maintain future good relations with them, you are authorized to reimburse them as set forth by you.



payments referred to in the sum of \$686.25 pesos, \$250.00 US (\$436.25 pesos) for the BASQUE ORGANIZATION and \$250.00 pesos (\$143.27 US) for the full-time services of a member of the BASQUE ORGANIZATION, have been made. X

During a conference held with [redacted] on February 9, 1945, which was attended by SA [redacted] and the writer, it was pointed out to [redacted] that this office is desirous of obtaining more complete coverage throughout Colombia in connection with investigation of Communist activities and desires that the BASQUE ORGANIZATION assist in procuring this coverage by utilizing [redacted] who are considered loyal members of the BASQUE ORGANIZATION and who are located in various sections of Colombia. He was also advised that this office believes that by using [redacted] of the BASQUE ORGANIZATION who are in a position to attend Communist meetings and conventions in various towns and cities in Colombia and report regularly on their activities, considerable additional service could be rendered. [redacted] was likewise advised that no information has been obtained to date from BASQUE informants residing on the coast of Colombia and on the Guajira Peninsula. X

In addition to the foregoing, [redacted] was advised that full use of the BASQUE ORGANIZATION and complete coverage throughout Colombia on all types of investigations in which this office is interested are necessary in order to justify the present payments being made. X

[redacted] advised that when his organization received instructions from President AGUIRRE to cooperate exclusively with this office when furnishing information, he had written to various members of the BASQUE ORGANIZATION in Colombia requesting them to furnish intelligence information but stated that to date no reports have been received except in those instances where specific requests for investigation have been made by this office. He stated that while coverage is being maintained on Guajira Peninsula by BASQUE [redacted] no information has been received from them. He advised that he would contact various loyal BASQUE [redacted]

[redacted] for the purpose of requesting them to furnish regular monthly reports concerning Communist activities although he stated he could not give this office definite assurance that they would cooperate fully in this project. He also indicated he would attempt to obtain better cooperation from other loyal BASQUES throughout Colombia. X

He also stated that the BASQUE ORGANIZATION does not need money for their services and would be glad to continue working with this office without the \$250.00 US (\$436.25 pesos) monthly payment which is being allotted to them by the office of the President in New York City. He further stated that he hopes to be able to increase the coverage of the BASQUE ORGANIZATION and that if he is able to do so, it would not necessitate additional monthly payments by this office. [REDACTED] concluded by stating he would prepare a letter advising President AGUIRRE of his willingness to work with this office on the above basis. [REDACTED] was advised that in the event he desires to communicate with President AGUIRRE through facilities available to us this office will gladly assist him. X

In view of the foregoing it is contemplated that in the future payments will be made to the BASQUE ORGANIZATION on the basis of \$250.00 pesos (\$143.27 US) per month together with expenses which may from time to time be incurred by them in carrying out specific investigations requested by this office. In the opinion of the writer the payments which are currently being made to the BASQUE ORGANIZATION are excessive and unless instructions are received to the contrary, the \$250.00 US (\$436.25 pesos) monthly payment is being discontinued as of February 1, 1945. X

Reference is made to my letter to the Bureau dated February 14, 1945, in the above captioned matter, and special attention is drawn to the last paragraph on page two, which set forth contemplated changes in the remuneration presently being paid to the Basque Organization and [Redacted]

As noted in my referenced letter, I am of the opinion that the present services rendered by [Redacted] and the Basque Organization in Colombia do not justify the payment of \$250.00 U.S. (436.25 Colombian Pesos) to the Basque Organization and an additional payment of 250 Colombian pesos (approximately \$145.00 U.S.) to [Redacted] for his services in procuring information. I feel that no value is received for the \$250.00 U.S. (436.25 Colombian pesos) payment which, according to [Redacted] is deposited by him to the account of the Basque Organization in a local Bogotá bank, inasmuch as it is used for the maintenance of the Basque Organization in Colombia and not for the direct purpose of furnishing information to this office.

On March 4, 1945, [Redacted] advised this office that he has been confused concerning the agreement reached between himself and this office at the conference of February 9, 1945, mentioned in my referenced letter, and he now states that it was his understanding that this office would continue to make the payment of \$250.00 U.S. (436.25 Colombian pesos) to the Basque Organization, which he believes is a payment being allotted to the Basque Organization by President AGUIRRE in New York City, but would discontinue the 250 Colombian pesos (approximately \$145.00 U.S.) to him personally. He stated that in view of the fact that the \$250.00 U.S. (436.25 Colombian pesos) payment is being made under an arrangement with President AGUIRRE, it cannot be altered by him.

To date this office has not advised [redacted] anything to the contrary concerning the previous arrangement for the payment of \$250.00 U.S. (436.25 Colombian pesos) to the Basque Organization because of the request of Secretary IRALA of the Basque Organization in New York City, contained in memorandum dated April 24, 1944, entitled "THE BASQUE ORGANIZATION IN THE WESTERN HEMISPHERE", which was forwarded to this office under cover of Bureau letter dated May 3, 1944, and entitled "BASQUE ORGANIZATION", to the effect that "The Basques will be satisfied if the relationship between the Legal Attachés and the Basques is maintained as though the funds paid the various Basques emanated from President AGUIRRE in the United States."

The writer is of the definite opinion that the services of [redacted] and the Basque Organization in Colombia are not worth \$250.00 U.S. (436.25 Colombian pesos) paid to the organization and the 250 Colombian pesos (approximately \$145.00 U.S.) paid to [redacted]. This was the reason for the conference which was held with [redacted] on February 9, 1945, mentioned in my referenced letter. However, as long as [redacted] is of the opinion that the sum paid to the Basque Organization comes from President AGUIRRE in New York City and not this office, any efforts to reduce this amount or convince [redacted] that the present services of the Basque Organization are not worth this amount fail. It is the writer's opinion that the services of the Basque Organization and [redacted] would be worth \$250.00 U.S. in total, if the suggestions for increased coverage outlined in my letter of February 14, 1945, materialize. It is believed imperative, however, to consider that the services of [redacted] himself and not the Basque Organization have been the real value to this office. It also appears that [redacted] is quite content to continue working for this office without the remuneration of 250 Colombian pesos (approximately \$145.00 U.S.) presently being paid directly to him. However, if [redacted] should go to the United States as is anticipated, it is not believed that the services of his replacement would be worth 250 pesos (approximately \$145.00 U.S.), in addition to the payment of \$250.00 U.S. (436.25 Colombian pesos) to be paid to the Basque Organization separately.

Therefore, it is requested that this office be permitted to advise [redacted] that the \$250.00 U.S. (436.25 Colombian pesos) does not in fact originate with President

AGUIRRE in New York City, and that this office believes the present amounts being paid are not commensurate with the information received. X

As a matter of additional information, [redacted] has advised that he has received affirmative responses to letters sent to various Basques throughout Colombia for assistance in the coverage of Communist activities, and it is believed that better results can and will be obtained in the future from the Basque Organization throughout Colombia. Therefore, this office is of the opinion that the payment of \$250.00 U.S. (436.25 Colombian pesos), to [redacted] in lieu of the payment of 250. pesos (approximately \$145.00 U.S.) set forth in my referenced letter, will be justified if the coverage throughout Colombia improves as anticipated, and provided that the payment is made with the definite understanding that it originates not from the Basque organization in New York City, but from the United States Government and is in return for services rendered to this office, rather than for the maintenance of the Basque Organization in Colombia. X

Reference is made to your letter of March 5, 1945, concerning the contemplated changes in the payments presently being made to the Basque organization and [Redacted] by your office.

For your guidance in this matter, the original instructions regarding handling of the Basque organization stated that arrangements had been perfected through President Aguirre of the Basque Government in exile whereby the services of their organization in the Western Hemisphere would be utilized exclusively by Bureau representatives. However, compensation for the services of the various Basque local groups was to be handled through the Bureau, not the Basque Government in exile. As you know, it was previously stated that the Basques would be satisfied if the relationship between the Legal Attaches and the Basques be maintained as though the funds paid the various Basques emanated from President Aguirre. If it will assist you in arriving at appropriate remuneration for the Basque group in Colombia, it will be entirely satisfactory to inform [Redacted] that the funds being received by him through you do not emanate from the Basque Government in exile but are made available through the Government of this country.

It is entirely satisfactory to consider the amount of the payment to the local Basque group in light of any information submitted by that organization or in consideration of service performed and their potential value as informants. In considering this matter you should realize that the Basques' present worth should be taken into account and also the potential value of having available the services of an organization which can be called upon if the occasion should arise. Your responsibility in obtaining benefits from this organization does not end with the development of the head of the local group as an informant and the receiving of what information he may be able to supply, but extends to the formation of a well-organized informant organization in line with current problems as reflected by the work of your office and the Bureau's work as a whole. It is believed that the possibility of developing this organization is in many instances overlooked. The payments now being made to the Basque organization and [Redacted] by your office are not large when you consider the possibilities which can be developed if this group is properly handled, nor is such a sum excessive in view of their potential work.

On March 17, 1945, ANTONIO IRALA, Secretary of the Basque Republic, advised Jerome Doyle of the New York SIS office that on or about March 25, 1945, Irala and JOSE ANTONIO AGUIRRE, President of the Basque Republic, are travelling by plane from New York City to Paris, France. The Bureau has been advised previously of this intended trip of these extremely confidential sources of information and consequently, upon receipt of this information, Doyle advised Supervisor George Hall at the Bureau to notify Special Agent [redacted] at Paris, France of the coming trip of Irala and Aguirre.

Arrangements were made with Irala so that he would ~~directly~~ contact Special Agent [redacted] at [redacted] home address in Paris.

It is believed that through Aguirre and Irala, Bureau representatives in Paris will be able to meet key members of the Basque Government in exile in that city and representatives of the Basque Intelligence Service.

It was further stated that in view of the fact that Mr. Irala and President Aguirre were returning to the United States, the most appropriate time for the Bureau representatives to meet the Basque intelligence leader in France was while Irala and Aguirre were there to bring about the introduction of [redacted]

Doyle advised Irala that all the Bureau desired at this time was that the Basque President introduce his intelligence leaders to a Bureau representative and explain to these leaders [redacted]

Doyle continued that thereafter, if the Bureau's jurisdiction in foreign intelligence matters was broadened to include France, that at that time President Aguirre could instruct his representatives to cooperate and work with the Bureau representatives in France.

Dear Sir,

Reference is made to your letter dated January 25, 1945 in the above-entitled matter which advised me that Jose Antonio de Aguirre and Antonio de Irala would shortly be coming to France.

This is to advise that on April 7 de Irala called upon me and advised that both of them had arrived in France a few days before and that they had been furnished with my address and telephone number by Special Agent Jerome Doyle in New York City. Irala told me that Aguirre was handling mainly political matters here and in London concerning the Basque people and that at the conclusion of his mission, which he did not expect to last for very long, he would return to the United States. Irala, on the other hand, will be staying here in Paris and after about two weeks will go to the South of France where he will stay about two months and then return to the Western Hemisphere. Intelligence and related matters will be wholly within his jurisdiction.

We had a long talk concerning the Basque people and about the problems of Fascism and Communism which confronted them. As is already known to you he is strongly opposed to Communism and feels that if the Allies do not back the truly democratic elements both in Spain and in France that the majority of the people may, out of dissatisfaction and discouragement turn to the Communist Party. At the time of this interview he was also very enthusiastic concerning the Bureau and the way of life in the United States.

At this time he also furnished to me information concerning one [REDACTED] which data I have already made the subject of a separate communication to the Bureau.

When Irala leaves for the South he is going to put me in touch with the man who is head of the Basque Services here in Paris who, he assures me, will work with me in the same way that Aguirre and Irala have previously worked with the Bureau. Upon his return from the South, and prior to his departure for the United States, we will have another series of conferences wherein he will give me the result of his findings on the Communist situation here and in Spain. The comments which he has made on this situation up to the present will be made the subject of separate communications.

On April 10, 1945 another conference was held with [redacted] and he advised that he is making progress in his efforts to obtain more active cooperation of other responsible Basques in the matter of covering Communist activities and other matters of interest throughout the country. He agreed to furnish the names of Basque leaders in Medellín, Barranquilla, and Cali, major cities of Colombia, who can be contacted in the future directly by our representatives in those cities.

On April 14, 1945 he brought to this office letters of introduction for [redacted] of Barranquilla, and [redacted] of Medellín. These are being forwarded to our representatives in those cities in order that they may make direct contact with the Basque informants.

In accordance with established procedure, it will be satisfactory for you to accept such communications for transmittal to President Aguirre who may then relay the information through the Bureau's facilities to the Basque representative in Caracas. It is not desired that your office forward such communications directly to the Caracas Office, however, the procedure suggested above may be used inasmuch as such procedure is now in existence and by this method the correspondence of the Basque will pass through the control of the Bureau.

It is suggested you so advise the informant in order that he may forward the communication to President Aguirre for transmittal to Venezuela if he so desires.

COUNCIL OF GALICIA IN URUGUAY PUBLISHES MANIFESTO DEMANDING IMMEDIATE UNION OF ALL SPANISH REPUBLICANS IN EXILE.

Writer encloses copy of a declaration drawn up by the CONSEJO DE GALICIA, signed by ALFONSO R. BASTELAO, President, and A. ALONSO RIOS, Secretary, dated April 1st, 1945; this reads as follows:-

"The CONSEJO DE GALICIA, having met in the city of Montevideo on April 1st, and after having reviewed the present situation in Spain, and especially that prevailing in Galicia.....agreed to publish the following communication:-

"In this decisive hour, the CONSEJO DE GALICIA proclaims its close ties with the Basque Government and the organized forces of Catalunya, in accordance with the growing solidarity of the three peoples, in an internal and external alliance which has already been consecrated under the well-known title of 'GALEJZCA'.

"The CONSEJO DE GALICIA, as an integral part of this triangular union, has declared itself to be aloof from all party and personal strife, and therefore is in no way responsible for any Republican disagreement; but its members do not yet feel reassured, even though they have always observed a friendly attitude towards the discordant elements, fervently desiring that they should cease their useless and pernicious disputes; and therefore they offer to work for a concerted union of all Spanish democrats in order to find without delay a single line of policy.



"In consequence, the CONSEJO DE GALICIA cordially invites all Spanish democratic groups and personalities in exile to put aside their ill-will and settle their differences amicably. The historic moment in which we are living demands the immediate union of everyone for the recovery of the Republican order in Spain. Let us say more: if before a month is over the individualistic groups have not come to a frank and clear understanding we shall believe that there are no ex-leaders in exile capable of taking up their leadership again.

"The democratic forces organized in the Peninsula are insistently calling for our union, which should be as close as that which has been formed over there, and they consider the discord prevailing among the exiles to be both suicidal and unpatriotic. The bases for union, fixed by the forces of the interior, are the following: 1. Recovery of the Republican order, and simultaneously, the establishment of the autonomias of Euzkadi, Catalunya, and Galicia; 2. A formal undertaking to establish a Federal Republic.



There are enclosed herewith several items of information which the local Basque intelligence organization has requested the Bureau to send to its superiors in the United States. These items have been retained in the office of Legal Attaché until it was possible to sift them and to use them in appropriate reports. Many of the attached items are of no interest either to this office or to the Bureau.

For the Bureau's information, the Basques are assigned leads by this office in the same manner as are other confidential informants, and the results obtained by them are included in investigative reports in like manner.

The Bureau's letter dated September 6, 1944 and captioned as above requested this office to send translations of the Basque material to the Bureau when such translations were made by this office. I am advised that, since the receipt of that letter from the Bureau, representatives of this office have made an attempt to translate large portions of the material word for word, whether such material appeared to be of interest or not.

Unless advised to the contrary, this office will in the future send to the Bureau for forwarding to the Basque representatives in the United States only the untranslated material given us by the Basques in Santiago, except in such cases where the material would appear to be of unusual and timely interest to the Bureau. Other material of interest will be translated into English by this office and will thereafter be handled like reports from any other informants; i.e., it will be incorporated into investigative reports where such is indicated by the nature of the case and the nature of the information. The material which is of no interest to this office or to the Bureau will not be translated into English.

At the suggestion of Jerome Doyle in charge of the New York SIS office and the request of *[redacted]* the writer contacted Antonio Irala, Secretary to Jose Antonio Aguirre, President of the Basque Republic at the New York SIS office. Irala has recently returned from France where he contacted various members of the Basque organization including their intelligence operatives. Irala stated that the Basque organization has a group of capable representatives throughout France who remained there during the entire period of occupation by the Germans. He added that these members of the organization have a large number of additional persons working for them of French and other nationalities. *[redacted]*

Irala advised that he had met Agent *[redacted]* in Paris and had arranged for liaison between *[redacted]* and the Basque organization in the event the Bureau should desire to use that organization in the future. He expressed the wish that all contacts be made through their one selected liaison man for security reasons. The writer will contact *[redacted]* upon arrival in Paris and make arrangements for liaison with the representative of the Basque organization there in the event the Office of the Legal Attache should desire to make use of the organization in the future. *[redacted]*
