CIRCULAR NO. 3959

TO ALL EMPLOYEES:

Subject: Affidavit regarding membership in organizations which assert the right to strike against the Government.

Appropriation bills for the fiscal year 1947 provide that no part of the appropriation shall be used to pay the salary or wages of any person who engages in a strike against the Government of the United States or who is a member of an organization of Government employees that asserts the right to strike against the Government of the United States. It is provided that for the purpose of this legislation an affidavit shall be considered prima facie evidence that the person making the affidavit has not contrary to the provisions of this law engaged in a strike against the Government of the United States and is not a member of an organization of Government employees that asserts the right to strike against the Government of the United States.

All employees must execute the affidavit on the other side of this circular. When you have signed the affidavit it should be returned promptly to your immediate supervisor who will forward it through regular channels (for noting against payroll records) to the Administrative Assistant to the Attorney General.

Certifying Officers shall not release salary checks until this affidavit has been prepared and forwarded.

NOTE: Any officer or employee of a department or establishment who is designated in writing by the head thereof to administer oaths in connection with employment as required by law is authorized to administer the affidavit required incidental to the foregoing and such affidavit must be administered without charge or fee and has the same force and effect as affidavits administered by officers having seals.

STATUTORY PENALTY CLAUSE: *Any person who engages in a strike against the Government of the United States, or who is a member of an organization of Government employees that asserts the right to strike against the Government of the United States ***and accepts employment the salary or wages for which are paid from any appropriation contained in this Act shall be guilty of a felony and, upon conviction, shall be fined not more than \$1,000 or imprisoned for not more than one year, or both: Provided further, that the above penalty clause shall be in addition to, and not in substitution for, any other provision of existing law.*





Notice of right to appeal

Appeal from classification by local board must be made within 10 days after the mailing of this notice. You may file a written notice of appeal with the local board, or you may go to the office of the local board and sign appeal form on back of Selective Service Classification Certificate (Form 30).

Within the same 10-day period you may file a written request for personal appearance before the local board. If this is done, the time in which you may appeal is extended to 10 days from the date of mailing of a new Notice of Classification (Form 37) after such personal appearance.

If you are the first person to take an appeal and such appeal is based on occupational grounds, you may, in accordance with Selective Service regulations, request transfer of the case to the board of appeal having jurisdiction over the area where you work.

If an appeal has been taken and you are classified by the board of appeal in either Class 1-A, 1-A-O, or 1-B, and one or more members of the board of appeal dissent from such classification, you may file appeal to the President with your local board within 10 days after the mailing of notice of such classification.

For advice, see your Government appeal agent.
The law requires you: (1) To keep in touch with your local board; (2) to notify it of any change of address; (3) to notify it of any fact which might change your classification; (4) to comply with the instructions on the notice of classification part of this form.



I am very much concerned about the fact that mail of an important character is not personally read by Mr. Tolson and Mr. E. A. Tamm. In discovering that much of the mail that comes to my desk dealing very definitely with matters of policy and critical situations is only initialed and not read, this practice must be changed. Categories that are to be read are: the Attorney General; Departmental officials; members of Congress; and high Government officials in other departments, together with memoranda dealing especially with political and critical situations must be read by the two assistants in the Director before being forwarded. I will appreciate the great volume of work that is passing through, but I must insist that not only should the head of a division read and initial mail, but that the assistants to the Director likewise read and initial the mail if it seems wise their approval, particularly that mail which is in the categories I have mentioned above.

As you know, we have found numerous instances in the past several weeks when mail and file material was held in Supervisors' offices for an undue period of time without justification for keeping such matter from the Files Section. This has occasioned a tremendous amount of work in files in connection with locating material needed to bring the files up to date.

I would like to suggest that Inspector Hendon be designated, with such supervisory assistance as he may need, to make a check of the desks of all Supervisors at the Seat of Government in order to determine whether any material is being held for an undue period of time without justification. If you approve, I will ask Mr. Hendon to make this survey by Divisions in numerical order. 22.21 Class II-A (When necessary in the War Production Program) (a) In Class II-A shall be placed any registrant found to be a necessary man in any industry, business, employment, agricultural pursuit, governmental service, or any other service or service, or a training or preparation therefor, the maintenance of which is essential to the national health, safety, or interest.

(b) Class II-A deferments shall be for a period of 6 months or less, but there is a change in the registrant's status during the period of his deferment in Class II-A, his classification shall be reopened and considered anew. At the expiration of the period of the registrant's deferment in Class II-A, his classification shall be reopened and he shall be classified anew. When the registrant is classified anew he shall not be again placed in Class II-A unless such classification is warranted, and in addition, the registrant or the registrant's employer, as the board of appeal (or an appeal is taken) or the registrant or an appeal is permitted and taken) that is available, shall make a reasonable effort to secure or train a replacement for the registrant during the period of deferment. If these conditions are met and the registrant is again placed in Class II-A, such further deferment shall be for a period of 6 months or less, but may be deemed necessary to secure or train a replacement. The same rule shall be applied when again classifying such a registrant at the end of each successive period for which he has been classified in Class II-A.

22.22 Class II-B (When necessary in the War Production Program) (a) In Class II-B shall be placed any registrant found to be a necessary man in any industry, business, employment, agricultural pursuit, governmental service, or in any other service or service, or a training or preparation therefor, the maintenance of which is necessary to the war production program.

(b) Class II-B deferments shall be for a period of 6 months or less. If there is a change in the registrant's status during the period of deferment in Class II-B, his classification shall be reopened and considered anew. At the expiration of the period of the registrant's deferment in Class II-B, his classification shall be reopened and he shall be classified anew. When again classifying the registrant care should be taken not to impede the war production program. The registrant should be again classified in Class II-B for a period of 6 months or less if such classification is warranted and if the registrant's employer has made a reasonable effort to secure or train a replacement for the registrant during the period of deferment. The same rule shall be applied when again classifying such a registrant at the end of each successive period for which he has been classified in Class II-B.

22.23 General rules for classification in Class II-A and Class II-B. (a) In the local board is placed the primary responsibility of deciding which men should be deferred because of their civilian activities. It is in the national interest and of paramount importance to the national defense that civilian activities which are directly contributing to the war effort or which are otherwise essential to the national health, safety, or interest, should be maintained where possible, consistent with the fundamental purposes of the Selective Training and Service Act of 1940, as amended.

(b) No deferment from training and service shall be made in the case of any individual except upon the basis of the status of such individual and no deferment shall be made of individuals by occupational groups or groups of individuals in any plant or institution.

(c) The local board may avail itself of the assistance of all Federal, State, or local agencies (such as the Office of Production Management, Labor Supply Commission, State and Federal employment services, State occupational advisor, county Agricultural Agents, etc.) to obtain information in cases of occupational deferments.

22.24 (When necessary in the War Production Program) (a) In Class II-C shall be considered a necessary man in any industry, business, employment, agricultural pursuit, governmental service, or in any other service or service, including training or preparation therefor, when all of these conditions exist: (1) He is not for a period of temporary interruption world in such activity; (2) he cannot be replaced because of a shortage of persons with his qualifications or skill in such activity; and (3) his removal would cause a serious loss of effectiveness in such activity.

The Federal Bureau of Investigation has been designated as the sole civilian Government investigative agency, having jurisdiction over the investigation of matters pertaining to the national defense, that is, espionage, sabotage, registration of agents of foreign principals and the like. Further, the Federal Bureau of Investigation has sole investigative jurisdiction in a great number of other Federal statutes which embrace bank robbery, kidnaping, extortion, white slave traffic, the National Motor Vehicle Theft Act, and numerous others. The Federal Bureau of Investigation has also been designated by Congress as the agency officially responsible for the tabulation and dissemination of police statistics for the entire country. Under an Act of Congress these statistics are gathered and are distributed to thousands of interested police and affiliated agencies each quarter so that trends of crime, crime records, and crime control can be known to those to whom it is of most interest. Further than this, the Federal Bureau of Investigation has been designated as the agency having jurisdiction over the classification and maintenance of fingerprint records, not only on a national basis, but on an international basis. We have some forty-six million sets of fingerprints on hand today. We are receiving the fingerprint records of all persons enlisted or being inducted into the Army and enlisted in other military services. Thousands of persons in public utility positions are fingerprinted and the prints are retained in our files. Those working in national defense industries on many occasions are fingerprinted, their prints being included in our files. Our Government employees' prints are included. We are receiving thousands of criminal fingerprints from all police agencies in the country daily and it is essential that we immediately be able to notify the arresting agency of the criminal record of the individual because he may be wanted for more serious crimes in other sections of the country and if he is to be released on a mere vagrancy or other charge, he may be set free to continue his depredations on society. This Bureau, together with many other foreign countries, participates in the international exchange of fingerprints. Hundreds of international crooks are brought to task yearly through the media of this service we have rendered.

Our Criminology Laboratory handles the scientific examination of evidence in cases investigated by the Federal and local law enforcement agencies. A great deal of their work is done in the examination of suspected sabotage cases at the present time. The scientists in that Laboratory have lectured throughout the country on bombs and explosives so that local police agencies may be adequately prepared to handle any such matters which might arise under their jurisdiction.

There are contained in our Files Section the files of hundreds of thousands of individuals whose activities are of the greatest importance to the country today. The work of the Files Section and the records of that section which have to do not only with the investigation of kidnaping, extortion, bank robbery, and like cases but also the investigation of our espionage, sabotage, foreign agent cases, and others, are of course accessible to employees working in that unit. It is most essential that only the most trusted employees be so assigned.

B. 5.

The work of the Federal Bureau of Investigation is of the utmost importance in the national defense. It is essential that thoroughly qualified personnel of the highest integrity and background be secured for every position in the Bureau. Our work is the guarding of the internal security of the country, not only in national defense matters, but in the control of those criminals who previously had terrorized the country in waves of bank robbery, kidnaping, extortion, white slavery, automobile theft, and numerous other crimes. There is no doubt whatsoever in the minds of law enforcement officials that should any group be permitted to have the assurance that their activities were being minimized during the present national emergency, we would have a tremendous country-wide wave of crime in that particular category in a very short period of time. It is, therefore, essential that from a national defense standpoint and from a public security standpoint the Bureau maintain its qualified staff at an absolute maximum in order to continue to have control of the criminal element under its jurisdiction.

B. 7. a. b. c.

The Federal Bureau of Investigation is primarily a service agency. We serve our Government and the public. We cannot determine the amount of work which is going to be referred to us. If there is a crime wave of local or national significance at any time the work of the Bureau is increased in comparison. Our identification, laboratory, and crime statistics facilities reflect very definitely the trends in the country. We must have available personnel to properly handle the thousands of fingerprint records being received by us daily. We are at the present time receiving approximately one hundred and twenty thousand sets of prints daily. We must have a scientific staff in the laboratory to examine scientific evidence. We must have an investigative force of sufficient size to handle the work being referred to us. We must have a technical and supervisory staff of sufficient size to render the service to our investigative, identification, laboratory, and statistical staffs so that we may have the benefit of the wealth of information in our various files. The work of the Federal Bureau of Investigation has increased so tremendously that every employee in the Bureau, regardless of his position, is performing a tremendous amount of overtime service. Our Special Agent investigators are performing no less than four hours a day overtime service. In the present emergency we have found it necessary to curtail leave because of inadequate personnel and many of our men have worked over long periods of time without having any time off for vacation.

D. 1.

The additional duties imposed upon the Bureau since the declaration of the national emergency have made it necessary that our staff be more than doubled. From the information furnished under sub-heading B, it will be seen that it is essential to carefully investigate every employee in the Bureau. All of our employees in the performance of their work at one time or the other have opportunity to observe and note the content of confidential investigative reports, the publication of which would be most detrimental to the national safety. We have had considerable difficulty in securing sufficient employees. We find that out of applicants who file application, we are successful in appointing about one out of every one hundred. It, therefore, means that if we lose an employee after he is fully investigated and is being given training or has been experienced, we must again consider on an average, one hundred persons before he can be replaced. In the accelerated program of the Government it is essential that the Federal Bureau of Investigation work at top speed to keep abreast of its duties and investigation of matters pertaining to national defense, its regular activities, and its most important and essential identification activities at this time.

D. 5.

At the present time the Federal Bureau of Investigation is employing additional qualified persons as rapidly as they can be found. The assembled Congress has in the past several months passed several bills which will increase even to a greater extent our present volume of work. The needs of the service as to employees fluctuate with the periods of stress in the country.

D. 6. a.

Special Agents of the Federal Bureau of Investigation are given twelve weeks of training which embraces five hundred and thirty-five hours of study. During that period of time they are trained not only in investigative techniques and procedures but are qualified in the handling of firearms, mechanical devices, and technical devices in use by the Bureau. After entering the field service after training, their skill, of course, increases with their length of service in the field.

An Open Letter to the President of the United States of America

July 11th, 1942

DEAR MR. PRESIDENT:

It is in the interests of the American people, and victory over the Axis, rather than in the interests of the individual Harry Bridges alone, that we address this open letter to you, to urge reconsideration of the order of Attorney General Biddle for Mr. Bridges' deportation.

In the last few days we have given careful consideration to the far-reaching effects of the Attorney General's order. To the best of our ability, we have analyzed the public response, and have found organized labor shocked and concerned, government production chiefs and patriotic industrial leaders deeply disturbed, many newspaper editors and columnists critical—and the appeasement, anti-war forces of the country, along with the official Axis propaganda bureaus, delighted by the decision.

Within a few days after Mr. Biddle announced his decision, Senator Reynolds, opponent of many measures necessary to win the war and critic of your administration of our wartime government, called for deportation not only of Bridges but of "thousands of others," and urged that the Communist Party be outlawed. An appeasement columnist, giving only lipservice to the cause of the United States, utilized the decision to launch a flagrantly scurrilous attack on Mrs. Roosevelt. And Radio Berlin, in its broadcasts beamed to the United States, used the Biddle decision to attack American collaboration with Russia in the fight against the Axis.

Certainly these incidents by themselves prove that the decision of the Attorney General jeopardizes our war effort, not in terms of production—it is clear that labor will continue to surpass its own high records—but in terms of national morale. Mr. Biddle's decision was described by one commentator as "the blunder for which pro-Axis propagandists have been waiting." It is exactly that, through its negation of the cause for which we are fighting and its contradiction of your pledge that all loyal residents of our country would find a place in this fight, judged by one criterion only — wholehearted, unequivocal, sacrificial support of the war.

Our fight for freedom and against the tyranny of the Axis, has brought home to the American people the meaning of fascism. For nine years, we have watched the rise of fascism in Germany and its encroachment upon other lands and peoples. We have seen the pattern repeat itself: destruction of powerful trade unions, persecution of the Jewish people, suppression of the Catholic church, loss of the right of free worship, and outlawing of the Communist Party, the inevitable first step towards the banishment of democracy and the enslavement of free peoples.

We have seen Hitler and the Axis use the slogan "anti-communism" to thrust upon the world brutality and violence unprecedented in human history. We have seen the

Lavals and the Petains of both hemispheres using the same slogans to carry out their work, seeking everywhere to divide and conquer the people and prevent them from achieving victory over fascism.

Your statement on May 16th, 1942, that you were commuting the sentence of Earl Browder because it would have "a tendency to promote national unity" was acclaimed by all Americans with a real understanding of the needs of unity and national morale.

The Government's evidence on the character of the Communist Party was put in through the testimony of thoroughly discredited witnesses most of whose testimony on other phases of the case was disbelieved both by Inspector Sears and the Board of Immigration Appeals. In view of the Attorney General's comment that he hopes the Bridges case will become a "test case of communism" it must be pointed out that the Communist Party was not a party to the deportation proceedings and that at no time were any of its officials subpoenaed or invited to present accurate evidence on its position.

The constitution of the Communist Party, adopted in 1938 and a matter of public record since that time, declares its unequivocal opposition to any "clique, group, circle, faction or party which conspires or acts to subvert, undermine, weaken or overthrow any or all institutions of American democracy." Whatever one conceives the political principles of the Communist Party to be, there can be no question of its unreserved support of the war program.

Because the decision rendered by Mr. Biddle in the case of Harry Bridges can only serve to undermine our national morale, and because it has already been used to create distrust of aliens and of labor leaders, we urge upon you the necessity of directing reconsideration. We make this plea not alone in justice to Harry Bridges, alien and labor leader, but in justice to Harry Bridges, fighting leader of the men behind the fighting lines, forceful asset to our war effort, vigorous spokesman for unity behind the war.

We recognize that your executive powers in this war emergency are extraordinary. It is our belief that executive action is required to prevent the execution of Mr. Biddle's order or the necessity of entering, at this time, upon what will inevitably be protracted and disruptive litigation. It is equally essential that the Attorney General's ill-advised, arbitrary, and unwarranted findings relative to the Communist Party be rescinded.

We believe, therefore, that you must offset the dangerous aspects of the Attorney General's order by a positive and immediate reaffirmation of the rights of labor, and of all loyal racial, religious and political groups, to full participation in the war.

In the interests of national unity and victory over the Axis, we urge you to use your executive authority to rescind the Attorney General's decision.

I hereby join in signing the Open Letter to the President of the United States, requesting him to use his executive authority to rescind Attorney General Biddle's order for the deportation of Harry Bridges.

THE CASE OF HARRY BRIDGES

On May 28, 1942, Attorney General Francis Biddle ordered the deportation of Harry Bridges. His decision reversed the unanimous finding of the Board of Immigration Appeals of the Department of Justice, which on January 3, 1942, overruled the decision of Presiding Inspector Sears. Mr. Biddle's decision also discounted the outstanding opinion, in 1939, of James M. Landis, then Dean of Harvard Law School and now Director of the Office of Civilian Defense.

Here are the outstanding recent statements on the case for your information.

THE RECORD

Dean James M. Landis, "In the Matter of Harry R. Bridges," December, 1939

"Bridges' own statement of his political beliefs and disbeliefs is important. It was given not only without reserve, but vigorously as dogma and faiths of which the man was proud and which presented in his mind the aims of his existence. . . . That Bridges' aims are energetically radical may be admitted, but the proof fails to establish the methods he seeks to employ to realize them are other than those that the framework of democratic and constitutional government permits."

Board of Immigration Appeals, J. A. Fanelli, Chairman, January 3, 1942

"That the aims of Bridges, personally, were legitimate union

aims is clearly shown by the evidence. . . . Bridges believes in arbitration and direct negotiation to settle labor differences, with the strike used only as a last resort."

Official Statement of Harry Bridges, May 29, 1942

"I am urging all union men and women to redouble their fight against Hitler and the Axis to make up for the damage caused by the Attorney General. . . . Our first job is winning the war and this decision will not deter us in any way from that goal. My deportation has never been, and is not now, the issue. It was the fight for union conditions and against Fascist aggression conducted by my union which led to the origination of the charge of Communism against me."

THE REACTION

New York Herald Tribune, Editorial, May 30, 1942

"It may be that Harry Bridges, West Coast labor leader, is doing his best to promote this country's battle of production against the Axis not from love of America but from loyalty to the Comintern. . . . But, whatever his motivation, the fact remains, from all accounts, that in helping to organize management-labor committees and in his pep talks to long-shoremen and shipyard workers he has been making no mean contribution to the cause."

A. Beasley, Minister of Supply and Acting Attorney General of Australia, May 30, 1942

"Determination of the desirability of any person is a matter for his own country to decide. Bridges might conceivably be the greatest social reformer ever seen here. Another country's court decisions regarding the desirability of any Australian cannot be regarded as acceptable to the Australian viewpoint. . . . Australia's code of industrial conditions and the rights of unions and workers to organize is on a different level from those of other countries. The men who fight to obtain these conditions in Australia might reasonably be regarded as undesirables elsewhere."

The New Republic, Editorial, June 8, 1942

"Viewed as a whole, it (the Attorney General's decision) seems one of the most stupid, ill-advised, undemocratic actions in recent years. . . . (Mr. Biddle) goes back into the Communist Manifesto of 1848. It is like saying that the Democrats are now in favor of state's rights and the Republicans in favor of federalism, just because this was true in 1860."

PM, Editorial, May 30, 1942

"Bridges is absolutely all-out not only for winning the war, but for winning it quickly and decisively. Far from advocating the overthrow of the Government—today—he advocates putting nothing ahead of its welfare. . . . he has continued to advise his men to waive all kinds of advantages—won from their employers over a long period of years—so that they might get on with the job of leading ships for the battle of the Southwest Pacific. Our men who are fighting over the Southwest Pacific already are in Bridges' debt. . . . He is the hard working and aggressive head of an organization on whose efficiency the lives of Americans fighting abroad depend."

Freda Kirchwey, June 6, 1942

"One is driven to the unhappy conclusion that Francis Biddle is not as sharply aware as a war-time Attorney General should be of the social and political effects of administrative acts. . . . Division and turmoil have been created at a time when unity and order are essential. The pretense that Bridges can go on with his work while his case moves slowly from court to court is ridiculous. No labor leader can serve as an effective aid to a government which has ordered his deportation as a dangerous alien."

New York Daily News, "War Chiefs Protest 'Outsiders' Order," by Guy Richards, May 30, 1942

"Officials of the War and Navy Departments, the War Shipping Administration and the War Production Board today complained bitterly that Biddle's out-of-the-blue-sky decree had handed them the war's No. 1 political headache. . . . Said one harassed big shot, '. . . as you probably know, Bridges has helped more to keep our labor and shipping troubles down than any civilian I can think of'. . . . 





MEMORANDUM FOR THE DIRECTOR

For record purposes I desire to advise that on Wednesday, February 1st, Commander Nixon of Naval Intelligence, left at my office the attached list of Bureau personnel at the Coast of Government holding Reserve Officers commissions. Commander Nixon stated that predicated upon inquiries which I had made of him from time to time, he had discussed with Admiral Holt a which Bureau employees would be mobilized for active duty and which Bureau would be allowed to remain in the Bureau service or return to the Bureau after mobilization.

Commander Nixon stated that Naval Intelligence had decided that from the attached list of names it would be desired that Assistant Director C. A. Tolson and myself be mobilized and assigned to active duty at the office of Naval Intelligence. The Navy Department would waive the services of any other persons holding Reserve Commissions as indicated by the attached list and would defer to Mr. Hoover's judgment as to the personnel which he might desire to maintain or retain in the Bureau.

After discussing this matter with you I indicated to Commander Nixon that you considered the services of Mr. Tolson and myself as so essential to the Bureau in time of war that you could not release either Mr. Tolson or myself to the Navy Department but that you would be willing to release any others of the Reserve Officer personnel to the Navy Department in case of a national emergency. Commander Nixon stated that he would talk to Admiral Holmes, and subsequently contacted me and advised that the Navy Department would be willing to informally agree that Mr. Tolson or myself would not be mobilized in time of war but would be released from our Reserve commissions for service in the FBI. On the question of whether any written record of this arrangement would be made, Commander Nixon indicated that no written record would be made, and when I inquired as to the efficacy of such an agreement in view of the fact that the present officers of Naval Intelligence would undoubtedly be returned to other duties within a maximum period of three years, Commander Nixon stated that neither Mr. Tolson nor myself would be sent to any mobilization station. I pointed out to Commander Nixon that the Navy Department might leave our names out of the mobilization now, but the next group of officers of Naval Intelligence would include them.

No. This is not satisfactory. I cannot give clearance to Jamm for commissions & will not clear any other applications for Naval Reserve Commissions of Respectfully,
