For information of Indianapolis, the enclosed letter was forwarded to Assistant Attorney General Robert A. McConnell, Department of Justice (DOJ) on 6/6/84. This letter was, in turn, forwarded to the Legal Counsel Division, FBIHQ.

DOJ opined that the enclosed letter contained no "overt threats," but is sufficiently violent (bottom of second page) to be called to the attention of the FBI.

Indianapolis is requested to contact U. S. Secret Service (USSS) and apprise it of subject and enclosed letter. Indianapolis should conduct an indices search and any other investigation deemed appropriate. DE-128
